#### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 4 CY 2024** of the **Municipality of Babatngon**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 482** with a total appropriation in the amount of **P5,855,383.45** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 4 CY 2024.

- 3. That the grant of increase in Representation and Transportation allowance shall be subject to the guidelines under LBC No. 157 dated May 3, 2024.
- 4. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.

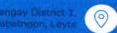

(PHP 5,855,383,45).

Introduced by: HON. FEDERICO P. ELIZAGA. JR. Sangguniang Bayan Member

Be it enacted by the Sangguniang Bayan of the Municipality of Babatngon, Levie in session assembled:

**SECTION 1.** – The Supplemental Budget No. 4 of the Municipality of Babatngon, Leyte for Fiscal Year 2024 in the amount FIVE MILLION EIGHT HUNDRED FIFTY-FIVE THOUSAND THREE HUNDRED EIGHTY-THREE PESOS AND 45/100 (PHP 5,855,383.45) is hereby approved.

The following budget documents are incorporated herein and made integral part of this Ordinance:

- Certification of Availability of Funds signed by the Municipal Treasurer and Municipal Accountant;
- Statement of Funding Sources signed by the Municipal Treasurer and Municipal Accountant;
- Statement of Funds Available for Reversion signed by the Municipal Budget Officer and the Municipal Mayor; and
- Statement of Supplemental Appropriation signed by the Municipal Budget Officer and the Municipal Mayor

**SECTION 2.** Sources of Funds. The source of funds for Supplemental Budget No. 4 of the Municipality of Babatngon, Leyte in the amount of PHP 5,855,383.45 is derived from Vacant Positions Salaries & Wages -July to December FY-2024 and other amount derived from Personal Services (Vacant Position-January-December FY-2024); and Maintenance and Other Operating Expenses (Transportation Terminal-Vacant Office- Jan. to Dec. FY-2024).

**SECTION 3.** Use of Funds. — The amount of PHP 5,855,383.45 is hereby appropriated for Supplemental Budget No. 4, FY-2024 of the Municipality of Babatngon, Leyte.

SECTION 4. Separability Clause. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

**SECTION 5.** Effectivity. This ordinance shall take effect upon approval.

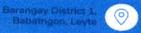

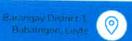

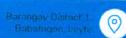
