



Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 06 FY 2024** of the **Municipality of Tunga**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 07**, **Series of 2024** with a total appropriation in the amount of **P450,000.00** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the allocation and utilization of the 5% Local Disaster Risk Reduction and Management Fund (LDRRMIF) shall conform with the provisions of NDRRMC-DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
- 2. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 6 OF THE MUNICIPALITY OF TUNGA, LEYTE, FOR CALENDAR YEAR 2024 IN THE AMOUNT OF FOUR HUNDRED FIFTY THOUSAND PESOS (PHP 450,000.00).

Be it enacted by the Sangguniang Bayan, Tunga, Leyte that:

SECTION 1. The Supplemental Budget No. 6 of the Municipality of Tunga, Leyte for Calendar Year 2024 in the amount of Four Hundred Fifty Thousand Pesos (Php 450,000.00) is hereby approved.

The Supplemental Budget documents consisting of the following are incorporated herein and made integral part of this Ordinance:

- 1. Certification of Availability of funds signed by the Acting Municipal Treasurer & Municipal Accountant
- 2. Statement of Funding Sources signed by the Acting Municipal Treasurer & Municipal Accountant.
- 3. Statement of Supplemental Appropriation prepared by the Municipal Budget Officer & approved by the Municipal Mayor.

SECTION 2. SOURCES OF FUNDS. The source of funds for Supplemental Budget No. 6 in the amount of Four Hundred Fifty Thousand Pesos (Php 450,000.00) shall be from the

New Revenue Source.

SECTION 3. USE OF FUNDS. The amount of P 450,000.00 is hereby appropriated for Supplemental Budget No. 6, C.Y. 2024 of the Municipality of Tunga, Leyte.

SECTION 5. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. EFFECTIVITY. This ordinance shall take effect upon approval.
