Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 1 CY 2024** of the **Municipality of San Isidro, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 2024-02 Series of 2024** with a total appropriation in the amount of **P1,800,000.00** reveals compliance with the same law and its implementing Rules and Regulations.



AN ORDINANCE AUTHORIZING THE FIRST SUPPLEMENTAL BUDGET OF THE MUNICIPALITY OF SAN ISIDRO, LEYTE FOR THE CALENDAR YEAR 2024 IN THE TOTAL AMOUNT OF ONE MILLION EIGHT HUNDRED THOUSAND PESOS 1,800,000.00) COVERING THE GRANT FOR THE COLLECTIVE NEGOTIATION AGREEMENT (CNA) INCENTIVE TO ALL QUALIFIED PERSONNEL OF THE MUNICIPALITY.

WHEREAS, the DBM Budget Circular No. 2024-4 dated November 11, 2024 provides for the guidelines on the grant of the CNA incentive for FY 2024;

WHEREAS, one of the motivating factors for the employee's effort toward a higher productivity is the grant of incentive as provided on item no. 4, (h) (ii) of the Congress Joint Resolution No. 4 s. 2024;

WHEREAS, under the MOOE of the office of the municipal mayor there are savings as of September 30, 2024 which shall be the subject for reversion to be made available for the CNA incentive, which is authorized under Section 322 of the Local Government Code, which says, "balances of appropriations authorized in the annual appropriations ordinance shall revert to the surplus of the general fund at the end of the fiscal year and shall not thereafter be available for expenditure except by subsequent enactment."

WHEREFORE, on motion of the Honorable Hospicio B. Apacible duly seconded en masse;

BE IT ENACTED, by the Sangguniang Bayan of the Municipality of San Isidro, Leyte in its 121st Regular Session assembled:

SECTION 1. That the First Supplemental Budget of the Municipality of San Isidro, Leyte for Calendar Year 2024 in the total amount of ONE MILLION EIGHT HUNDRED THOUSAND PESOS (* 1,800,000.00) are supported by the following documents:





EXECUTIVE ORDER NO. 50 Series of 2023

OFFICE OF THE MUNICIPAL MAYOR

CREATION OF THE EMPLOYEES' ORGANIZATION OF THE MUNICIPALITY OF SAN ISIDRO, LEYTE

WHEREAS, Executive Order No. 180 dated June 1, 1987, providing guidelines for the exercise of the right to organize the government employees, creating a public sector labor-management council, and for other purposes;

WHEREAS, Sec. 1. This Executive Order applies to all employees of all branches, subdivisions, instrumentalities, and agencies, of the Government, including government-owned or controlled corporations with original charters. For this purpose, employees, covered by this Executive Order shall be referred to as "government employees";

WHEREAS, Sec. 2. All government employees can form, join or assist employees' organizations of their own choosing for the furtherance and protection of their interests. They can also form, in conjunction with appropriate government authorities, labormanagement committees, works councils and other forms of workers' participation schemes to achieve the same objectives;

WHEREAS, Sec. 3. High-level employees whose functions are normally considered as policy-making or managerial or whose duties are of a highly confidential nature shall not be eligible to join the organization of rank-and-file government employees.

WHEREAS, Sec. 10. The duly registered employees' organization having the support of the majority of the employees in the appropriate organizational unit shall be designated as the sole and exclusive representative of the employees;

NOW, THEREFORE, I, REMEDIO B. VELOSO, Municipal Mayor of the Municipality of San Isidro, Leyte, by virtue of the powers and authority vested in me by law do hereby order:

SECTION 1. CREATION. There shall be created an EMPLOYEES' ORGANIZATION OF THE MUNICIPALITY OF SAN ISIDRO, LEYTE.
