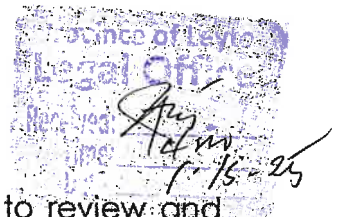

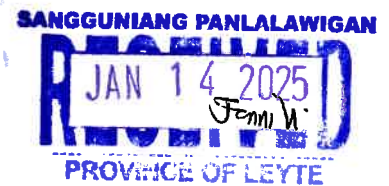

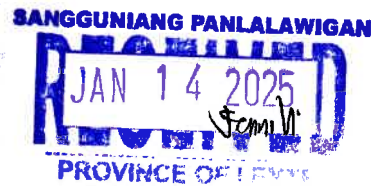

AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 2024-11, ENTITLED “AN ORDINANCE ESTABLISHING A VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (VAWC) DESK IN EVERY BARANGAY OF Calubian, Leyte” INTRODUCED BY: COMMITTEE ON TOURISM DEVELOPMENT, SOCIAL AND CULTURAL DEVELOPMENT

NOW THEREFORE, on motion of SB Member Julia E. Halichic, duly seconded by SB Member Benjamin A. Calbitaza, and the Majority of the SB Members present;

BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Bayan of Calubian, Leyte in session assembled, that:

Section 1. Title. – This Ordinance shall be known as the “AN ORDINANCE AMENDING SECTION 3 OF MUN. ORDINANCE NO. 2024-11, ENTITLED “AN ORDINANCE ESTABLISHING A VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (VAWC) DESK IN EVERY BARANGAY OF THE MUNICIPALITY OF CALUBIAN, LEYTE”

Section 2. Amendment – Section 3 of Municipal Ordinance N. 2024-11 is hereby amended as follows:

ESTABLISHMENT OF VIOLENCE AGAINST WOMEN (VAW) DESK in every Barangay xxx

(3) Provision for granting honorarium/ incentive in the amount of **FIVE HUNDRED PESOS QUARTERLY FOR NONE KAGAWAD VAW DESK OFFICERS** to compensate their transportation allowance and other expenses while on official business or transaction in relation to VAWC program and service implementation, to be taken from the MOOE GAD budget from the Office of the MSWDO.

Section 3. Repealing Clause. — All ordinances, resolutions, executive issuances, or rules and regulations, or parts thereof, which are inconsistent with or contrary to the provisions of this Ordinance, are hereby deemed repealed, amended, or modified accordingly.

Section 4. Applicability Clause. — The provisions of existing ordinances, resolutions, or executive orders dealing with related subject matter such as protection against child labor and exploitation, anti-violence against women and children, and the like which are not contradictory with this Ordinance, are hereby adopted as an integral part of this Ordinance.

Section 5. Separability Clause. — If for any reason, any section, or provisions of this Ordinance is held unconstitutional or invalid, the other sections or provisions hereof shall not be affected thereby.

Section 6. Effectivity Clause. — This Ordinance shall take effect immediately upon approval of the Municipal Mayor, unless otherwise provided by the Honorable Sangguniang Panlalawigan of Leyte.
