

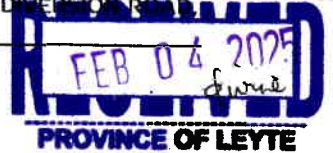

A RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT AND THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF LEYTE, THROUGH GOVERNOR CARLOS JERICO L. PETILLA AND VICE GOVERNOR SANDY JAVIER, FOR FINANCIAL ASSISTANCE FOR THE COMPLETION OF THE SPORTS FACILITIES OF THE CITY OF BAYBAY IN PREPARATION FOR EVRAA HOSTING.

WHEREAS, the Eastern Visayas Regional Athletic Association (EVRAA) is an annual sports competition for student-athletes in the Eastern Visayas region organized by the Department of Education;

WHEREAS, the EVRAA primarily aims to improve student-athletes' competitive sports skills and prepare them for the Palarong Pambansa as well as promote and inculcate the necessary values and discipline to mold them into better and productive members of the community;

WHEREAS, the City of Baybay, with its earnest desire to host the EVRAA, is significantly challenged with budgetary constraints to finish and complete its sports facilities;

WHEREAS, to realize the desire and intention of the city to host the EVRAA, the august body deemed it necessary to request the Provincial Government of Leyte, through Governor Carlos Jericho L. Petilla and Vice Governor Sandy Javier, for Financial Assistance for the completion of the sports facilities of the City of Baybay.
