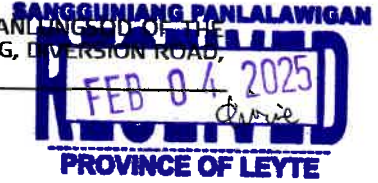

**A RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT AND THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF LEYTE, THROUGH GOVERNOR CARLOS JERICHO L. PETILLA AND VICE GOVERNOR SANDY JAVIER, FINANCIAL ASSISTANCE FOR ADDITIONAL PERMANENT HOUSING FOR TYPHOON AGATON VICTIMS**

WHEREAS, on April 14, 2022, Typhoon Agaton hit the entire City of Baybay resulting to the loss of lives and massive damage to properties and infrastructures;

WHEREAS, the provision of adequate permanent housing facilities for the affected families is crucial for their well-being safety, stable environment, health and overall quality of life;

WHEREAS, the City of Baybay, with the support coming from the various channels was able to provide a considerable number of housing units for the said victims, but still needs more to cater the needs of all affected.

WHEREAS, the August body deemed imperative to seek assistance from the Provincial Government and the Sangguniang Panlalawigan of the Province of Leyte, through Gov. Carlos Jericho L. Petilla and Vice Gov. Sandy Javier, in furtherance of the city's goal to provide housing units for all families affected by typhoon Agaton,
