AN ORDINANCE IMPOSING RENTAL AND FIXING THE RATES ON THE USE OF BUSAY EQUIPMENTS AND AMENITIES OWNED BY THE MUNICIPALITY OF BABATNGON, LEYTE.

WHEREAS, the Local Government Unit of Babatngon, Leyte owns various Busay Equipments and amenities;

WHEREAS, Article 129 of Republic Act 7160 otherwise known as the Local Government Code of 1991 in relation to Article 10, Section 5 of the 1987 Philippine Constitution provides, "Each local government unit shall exercise its power to create its own sources of revenue and levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy autonomy. Such taxes, fees and charges shall accrue exclusively to the local governments".

WHEREAS, Article Five, Section 153 and Section 154 of Republic Act 7160 further provides that the local government units may impose and collect reasonable fees and charges for services rendered and may fix the rates for the operation of public utilities owned, operated and maintained by them;

WHEREAS, the Municipality of Babatngon intends to maximize the use of its sources and create additional source of income by renting out the equipment and amenities in order to keep and support the required budget for the maintenance of these said properties;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Babatngon in its Regular Session assembled that:

<u>SECTION 1.</u> Title of the Ordinance – This ordinance shall be known as "AN ORDINANCE IMPOSING RENTAL AND FIXING THE RATES ON THE USE OF BUSAY EQUIPMENTS AND AMENITIES OWNED BY THE MUNICIPALITY OF BABATNGON, LEYTE."

<u>SECTION 2.</u> Fees and Charges – There is hereby imposed the following rental rates for the use of equipments and amenities being rented out by the Municipal Government to private parties:

<u>SECTION 3.</u> General provisions Governing the Rental and Use of Equipment and Amenities – The rental and use of equipment and amenities indicated under Section 2 shall be in accordance with the following conditions:

a. The rental rates shall be exclusive for the use of the equipment and amenities.

 A rental agreement shall be executed between the Municipal Government and the renting party indicating therein, among others, all attendant terms and conditions governing said agreement.

<u>SECTION 4.</u> Separability Clause – If any provision of this ordinance or the application of such provision to any person circumstances is declared invalid, the remainder of this Ordinance shall not be affected.

SECTION 5. Repealing Clause – All ordinances, rules and regulations, or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed of modified accordingly

<u>SECTION 6.</u> Effectivity – This Ordinance shall take effect upon approval and the requisite posting and publication as provided under the Local Government Code.


