

### AN ORDINANCE AMENDING VACANT PLANTILLA POSITIONS TO CHANGE POSITION TITLE INTO ITS GENERIC POSITION TITLE SPECIFICALLY THE ADMINISTRATIVE AID III (CLERK III)

Sponsor/Author: Atty. Jesus B. Cabanacan, SB Member

WHEREAS, Section 325(f) of the Local Government Code provides that the use of the provincial, city, and municipal funds shall be subject to the limitation that no changes in designation or nomenclature positions resulting in a promotion or demotion in rank or increase or decrease in compensation shall be allowed, except when the position is actually vacant, and the filling of such positions shall be strictly made in accordance with the Civil Service Law, Rules and Regulations;

WHEREAS, Section 3.1.2 of DBM Budget Circular No. 2005-5 dated August 16, 2005 provides that if the salary grade of the position is maintained, the staffing modification and/or position classification action is deemed as retitling, provided that such is within the same occupational group; and

WHEREAS, DBM Local Budget Circular, Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2022 Edition, contains the updated list of classes or position titles existing in the local government units (LGU5) that are grouped by occupation, and provides that all positions in the LGUs shall be allocated to their proper position titles and salary grades in accordance with said Index.

NOW THEREFORE, on motion of Atty. Jesus B. Cabanacan, duly seconded by Hon. Nikkos Rhet V. Astorga.
