

MUNICIPAL ORDINANCE NO. 24-21 SERIES OF 2024

AN ORDINANCE GRANTING CASH INCENTIVES TO THE SEVENTY-SEVEN (77) APPOINTED VIOLENCE AGAINST WOMEN (VAW) DESK OFFICERS FOR THE PURPOSE OF SUPPORTING THEIR FUNCTIONS IN PROMOTING AND PROTECTING THE RIGHTS OF WOMEN AND CHILDREN IN THE MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, the Violence Against Women (VAW) Desk is a barangay-level facility established under Republic Act No. 9710 or the Magna Carta for Women, which aims to address the issues of violence against women and children and provide support services such as legal assistance, counseling, referrals, and rehabilitation programs to abused women and children;

WHEREAS, the municipality of Burauen has appointed 77 VAW Desk Officers in different barangays to perform essential functions in line with the provisions of Republic Act No. 9262, the Anti-Violence Against Women and Children Act of 2004, and other related laws aimed at protecting the rights of women and children;

WHEREAS, the Barangay VAW Desk Officers are tasked with the critical responsibilities of attending meetings, submitting quarterly reports to the Municipal Social Welfare and Development Office (MSWDO), coordinating and referring cases to government and non-government agencies, addressing various forms of abuse against women, including senior citizens, women with disabilities, and other marginalized groups, leading advocacy initiatives for the elimination of violence against women and children, and performing other functions as assigned by the barangay;

WHEREAS, the position of VAW Desk Officer is a voluntary one, with no wages or salaries in return for the services they provide, thus their roles are carried out without any direct compensation from the government;

WHEREAS, in recognition of the efforts of the VAW Desk Officers in promoting the welfare of women and children, and to support them in performing their duties, it is deemed appropriate to grant a cash incentive to assist with the basic necessities incurred in carrying out their functions, particularly for transportation and meals;

NOW, THEREFORE, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled, that:

SECTION 1. Grant of Cash Incentives. The seventy-seven (77) appointed VAW Desk Officers of the Municipality of Burauen shall be entitled to a cash incentive of One Thousand Pesos (\$\P\$1,000.00) annually.

SECTION 2. Source of Funds. The amount required for the cash incentives shall be sourced from the local government's annual budget, particularly from the funds allocated for social welfare programs, subject to the availability of funds and compliance with the budgeting laws and regulations.

SECTION 3. Implementing Guidelines. The Municipal Social Welfare and Development Office (MSWDO) shall be tasked with the formulation of the necessary guidelines.

and procedures for the proper implementation and distribution of the cash incentives, ensuring that it is given to the duly appointed VAW Desk Officers in accordance with the provisions of this ordinance.

SECTION 4 - Repealing Clause. All ordinances, resolutions, executive orders and all other issuances inconsistent herewith are deemed to be repealed or modified accordingly.

SECTION 5 - Separability Clause. If any of the provisions of this ordinance is declared invalid and unconstitutional, other parts or provisions hereof shall continue to be in full force and effect.

SECTION 6 - Effectivity. This ordinance shall take effect upon its approval.

CARRIED UNANIMOUSLY, this 27th day of August 2024, in regular session assembled.
