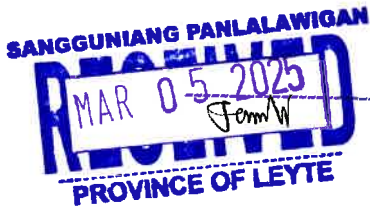
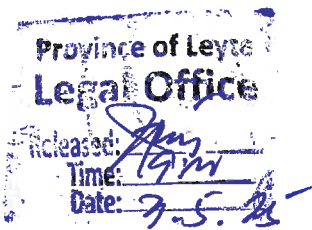

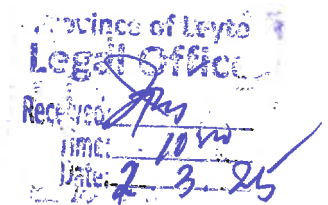

¹ (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

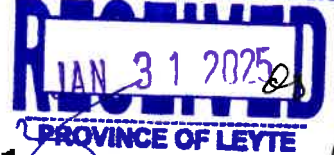

MUNICIPAL ORDINANCE NO. 24-31

Series of 2024

AN ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF A PORTION OF SAN RAMON STREET, LOCATED IN POBLACION DISTRICT 5, BURAUEN, LEYTE, ADJACENT TO ABC HALL ELEMENTARY SCHOOL, ON WEEKDAYS DURING CLASS HOURS FROM 6:00 A.M. TO 6:00 P.M., TO ENSURE THE SAFETY OF STUDENTS CROSSING FOR SCHOOL ACTIVITIES CONDUCTED AT THE GYMNASIUM

Section 1. Title. – This Ordinance shall be known and cited as the “Temporary Street Closure Ordinance for Student Safety at ABC Hall Elementary School, Burauen.”

Section 2. Declaration of Purpose. – The purpose of this Ordinance is to protect the safety and well-being of students at ABC Hall Elementary School who must cross San Ramon Street to access the gymnasium for school activities, as the school grounds have limited space for such functions. To minimize the risk of accidents and ensure student safety from vehicular traffic, a temporary closure of the designated portion of San Ramon Street during class hours is hereby deemed necessary.

Section 3. Scope and Period of Closure. – A designated portion of San Ramon Street, directly fronting ABC Hall Elementary School in Población District 5, Burauen, Leyte, shall be temporarily closed to vehicular traffic from Monday to Friday, during official class hours from 6:00 a.m. to 6:00 p.m., except on holidays and non-school days. This temporary closure shall be enforced as long as student safety requires their crossing to access the gymnasium located across from the school.

Section 4. Repealing Clause. – All ordinances and resolutions inconsistent with this ordinance are hereby repealed or modified accordingly.

Section 5. Separability Clause. – If any provision of this ordinance is declared unconstitutional or invalid, the remaining provisions shall remain in full force and effect.

Section 6. Effectivity. This Ordinance shall take effect immediately following its approval and posting in at least three (3) prominent locations within the municipality.






