## **MUNICIPAL ORDINANCE NO. 2, S. 2025**

AN ORDINANCE PROHIBITING GENDER-BASED SEXUAL HARASSMENT IN THE STREETS AND PUBLIC PLACES IN THE MUNICIPALITY OF VILLABA, LEYTE, EXACTING PENALTIES FOR VIOLATIONS OF ANY PROVISIONS THEREOF

#### PREFATORY STATEMENTS

This Ordinance is a sequel or logical consequence of Ordinance No. 34, S. 2023-2025, a legislative measure CRAFTED TO ELIMINATE GENDER-BASED SEXUAL HARASSMENT IN THE MUNICIPALITY OF VILLABA, LEYTE, AND IMPOSE PENALTIES FOR VIOLATIONS THEREOF, While the original Ordinance No. 34, S. 2023-2025 deals on sexual harassment in the employment, education and training environment, this offshoot Ordinance No. 2, S. 2025 pertains to sexual harassment in the streets and public places.

It is for this reason that the author is no longer incorporating herein all the provisions in the original ordinance save for those which are necessarily applicable to its concerns.

Sexual harassment is an act of creating unpleasant or hostile situation that involves sexual desire through one's verbal or physical conduct. To prevent and totally eliminate this brand of immoral actuations, a legislative enactment shall be done, HENCE,

**BE IT ORDAINED,** as the Sangguniang Bayan in regular session assembled hereby ORDAINED, that:

Section 1. SHORT TITLE. – This legislative measure shall be known as "The Anti-Gender Based Sexual Harassment in the Streets and Public Places in the Municipality of Villaba, Leyte."

Section 2. **SCOPE**. – This ordinance shall cover all residents of this municipality, including, especially, drivers of vehicles, private, public utility or government owned, riding public, visitors or transient guests.

Section 3. **DEFINITION OF TERMS**. – The terms as used in this Ordinance shall mean as follows:

- a) Act of Lasciviousness An act depicting sex in a harsh and insulting way
- b. Humiliating Disgracing or lowering the status of a person
- c. Innuendo Insinuation or reference to someone so light as to be difficult to detect
- d. Lewd Picture A picture that shows an indecent sexual desire
- e. Leer Maliciously look at someone with ill will
- f. Obscene offensive to accepted standards of modesty
- g. Proliferation multiplying at a fast rate
- h. Sexual Advances efforts made to win the sexual favor of someone

Section 4. **SEXUAL HARASSMENT**. – As defined under R.A. 7877, is a form of misconduct involving an act or series of unwelcome sexual advances, request for sexual favors, or other verbal or physical behavior of a sexual nature made directly, indirectly or impliedly.

Section 5. **FORMS OF SEXUAL HARASSMENT.** – The following acts constitute sexual harassment some of which are covered by the Revised Penal Code under acts of lasciviousness:

- 1) Persistent telling of jokes, such as green jokes or other analogous statements to someone who finds them offensive or humiliating;
- 2) Taunting a person with talk about sex and sexual innuendoes;
- 3) Displaying offensive or lewd pictures and publications in public places;
- 4) Making offensive hand or body gestures at someone;
- 5) Repeatedly asking for date despite verbal rejection:
- 6) Staring or leering maliciously;
- 7) Touching, pinching or brushing up against someone's body unnecessarily or deliberately;
- 8) Kissing or embracing someone against her will;
- 9) Requesting sexual favors in exchange for fare or service;
- 10) Cursing, whistling or calling a woman in public with words having dirty connotations, implications which tend to ridicule, humiliate or embarrass the woman, such as "Puta", "Boring", "Peste", etc.;

Section 6. **DENUNCIATION**. – The situations stated in section 5 of this Ordinance are manifestly obscene and spiteful on the part of the woman-victim. Predicated upon this reason, it is but just and proper for the Local Government of Villaba to strongly denounce and put to an end the existence and proliferation of these evil doings.

Section 7. **PENAL PROVISIONS**. – Any person committing any Sexual Harassment Act stipulated under Section 5 of this Ordinance shall undergo these punishments, to wit:

First Offense: A fine of two thousand pesos (\$\mathbb{P}2,000.00) with an imprisonment of four (4) months;

**Second Offense**: A fine of two thousand, three hundred pesos (\$\mathbb{P}2,300.00) with an imprisonment of five (5) months;

**Third and Subsequent Offenses**: A fine of two thousand, five hundred pesos (\$\mathbb{P}2,500.00\$) with an imprisonment of six (6) months.

Section 8. **SEPARABILITY CLAUSE**. – If for any reason, any part or provision of this Ordinance be declared unconstitutional or invalid, the other parts or provisions not affected shall continue to be in full force or effect.

Section 9. **REPEALING CLAUSE**. – All ordinances, rules and regulations, executive orders and other issuances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 10. **EFFECTIVITY CLAUSE**. – This Ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code.

Being moved for approval by the Hon. Rogelio J. Baay, this Ordinance was approved on February 3, 2025.
