#### PREFATORY STATEMENT

It is provided in Section 12, Article II of the 1987 Constitution of the Philippines that the State recognizes the sanctity of the family life and shall protect and strengthen the family as a basic autonomous social institution. The natural and primary right and duty of parents in the rearing of the youth for civic efficiency and the development of moral character shall receive the support of the government:

The Constitution further provides in Article XV that the State recognizes the Filipino Family as the foundation of the nation. Accordingly, it shall make firm its solidarity and foster its total well-being:

The Department of Social Welfare and Development (DSWD) is mandated to identify the basic needs of the needy, the disadvantaged and the impoverished, develop and implement appropriate measures to alleviate their problems and improve their living conditions pursuant to Section 483 of the Local Government Code of 1991:

Thus, Republic Act 11310, the Pantawid Pamilyang Pilipino Program (4Ps) Act was passed and approved in 2019, which provides conditional cash grants to the poorest of the poor, to improve the health, nutrition and the education of the children;

On account of the foregoing grounds, the Municipality of Villaba, Leyte, upholds the program of National Government relative to the 4Ps expanded benefits and THEREFORE, Be it

**Section 1. TITLE.** – This enactment shall be known as "An Ordinance Crafted to Institutionalize the Expanded Benefits of Pantawid Pamilyang Pilipino Program (4Ps) Beneficiaries in the Municipality of Villaba, Leyte"

Section 2. SCOPE. – This Ordinance shall cover all residents of Villaba who are qualified 4Ps beneficiaries pursuant to Republic Act No. 11310.

**Section 3. DEFINITION OFTERMS.** – The terms hereunder, used in this Ordinance, shall mean as follows:

- a. **Beneficiaries** are those who are entitled to receive the benefits, the households in the municipality identified by the MSWDO for entitlement to the monthly cash grants
- b. Benefits material aids or services provided due the beneficiaries
- **c.** Case Management Assessment a process used by the MSWD to enable the household beneficiaries to improve their functioning by dealing with their difficulties in complying with the terms of the program
- **d. Family Development Session (FDS)** the parents group actively attended by the main grantees of households, usually mothers, to enhance their parenting capabilities and encourage them to be more active citizens of society
- e. Institutionalizing establishment or formalizing a program, as the expanded benefits
- f. Kilos Unlad Case Management Framework- a social case management strategy which aims to guide the households in achieving improved well – being, stepping out of poverty and employing individual/ family cooperation

**SECTION 4. EXPANDED BENEFITS OF 4Ps** – The expanded benefits of the Pantawid Pamilyang Pilipino Program shall include, but not limited, to the following which may be appropriate for the situation of the Municipality of Villaba, to wit:

- a. Guaranteed and Continued Preferential access to Social Services and Programs;
- b. Grant of Scholarship to 4Ps Beneficiaries Qualified Dependents under Existing Municipal Scholarship Program of the Municipality
- c. Employment Assistance through the Public Employment Services Office (PESO) of the Municipality, if applicable
- d. Medical Assistance through the Municipal Rural Health Unit;
- e. Conduct of Pantawid Pamilya Graduation Ceremonies of all Municipal Candidates for Exit from the Program. These 4Ps candidates are afforded livelihood project and assistance after graduation by the MSWD Office.

The foregoing enhancement interventions, not-withstanding the application of the original monetary assistance under R.A. 11310, shall cater to the expansion of said benefits in this program.

**Section 5. CREATION OF COMMITTEES/TEAMS.** – The Local Government through the MSWDO, shall organize committees/teams which are deemed necessary for the support in the setting up of the expanded benefits of the 4Ps beneficiaries in the Municipality of Villaba, as:

a. Case Management Team (Kilos Unlad Case Management Framework) — an aggrupation whose function is to develop a standardized procedure, mechanisms and tools to ensure that household-beneficiaries are assessed on

    - b. Villaba North District
  - DA Head/Officer
  - 4. Gender and Development Officer
  - 5. Disaster and Risk Reduction Management Officer
  - 6. PNP WCPD Officer
  - 7. Youth Development Officer
  - 8. Municipal Environment and Natural Resources Officer
  - 9. Public Employment Service Officer
  - 10. Two (2) CSO/NGO Officers
- b. Family Development Session (FDS)/Youth Development Session Team -The FDS Team shall be composed of the heads of the following:
  - 1. Chairperson – Commission on Population and Development Officer
  - 11. Vice Chairperson - Youth Development Officer
  - III. Members (the same as in the Case Management Team)

The FDS Team constituted herein shall serve as subject matter experts or resource persons on areas of concerns. This team shall likewise aim to provide a venue for 4Ps beneficiaries to enhance and acquire new skills and knowledge in responding to their parental roles and responsibilities, promoting the concept of shared parenting.

Section 6. BARANGAY FAMILY DEVELOPMENT SESSION(BFDS) TEAM. - The BFDS Team shall replicate the function of the FDS Team of the municipality. The manner of its creation and funding of its operation in the barangay shall be coordinated by the Municipal Social Welfare and Development Office (MSWDO)

Section 7. PAWNING THE ATM CARD. - R.A. 11310, the 4Ps Act, provides conditional cash grants to the poorest of the poor for the purpose of improving the health, nutrition and education of the children. This statement shows to prove that the granting of this privilege is containing, implying or depending on a condition that after the going out of the 4Ps beneficiary from this program, the children shall gain the state of well-being.

Corollary to the foregoing principle, this cash grant can never be spent for any other objective, except as stated therein. Therefore, the Act of pawning the ATM by the 4Ps beneficiary in order to obtain an early cash for fiesta or birthday celebration, for a cockfighting bet or any other gambling habit or luxurious spree, shall be malicious offense and mean automatic expulsion of said 4Ps member from the program.

Section 9. REPEALING CLAUSE - All ordinance, rules and other issuances inconsistent , with the provisions of this Ordinance shall hereby be repealed or modified accordingly.

Secion 10. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code
