# AN ORDINANCE PROVIDING RULES AND REGULATIONS GOVERNING VEHICULAR TRAFFIC IN THE MUNICIPALITY OF PASTRANA AND CORRESPONDING PENALTIES FOR VIOLATIONS THEREOF

**WHEREAS,** there are areas in the Municipality of Pastrana that experienced severe strain in its transport capacity;

**WHEREAS,** the Local Government Code of 1991 mandates the local government unit to ensure the safety, the maintenance of peace and order and the preservation of the comfort and convenience of its inhabitants

**WHEREAS,** the Sangguniang Bayan recognized that the private sector can contribute significantly in the planning and implementation of traffic, transportation and communication management plans and programs in the Municipality of Pastrana.

**NOW THEREFORE**, the Sangguniang Bayan of Pastrana, Leyte in session duly assembled

**DO HEREBY ORDAIN that** 

### ARTICLE I - TRAFFIC VIOLATIONS

**SECTION 1.** The following acts omissions in the operation of any motor vehicle and the use of thoroughfares and declared traffic violations:

### SECTION 2. TRAFFIC CITATION TICKETS-

- (a) Any person apprehended for violating any provision (s) of this Ordinance shall be issued a Traffic Citation Ticket in the form prescribed for the purpose and to be issued by the apprehending officer of the Philippine National Police and/or any duly authorized personnel.
- (b) The provisions of the Traffic Citation Ticket shall be complied by the offender within the number of days prescribed therein.

#### SECTION 3. PENALTIES-

All penalties for the first and second offenses as herein prescribed shall be paid to the Municipal Treasurers Office not later than seven (7) days upon receipt of the citation ticket after apprehension. For the third offense, payment shall be within Thirty (30) days after apprehension. Non-compliance of the violation he/she will be subject to court trial.

The impounded motor vehicle shall be released and restored to the owner/operator immediately after payment of the fines.

**SECTION 4.** Traffic Citation Tickets shall be issued to the motor vehicle driver violators, thus for minors, the guardian/whoever authorized the minor apprehended will be issued of the citation ticket.

### **ARTICLE II - ADMINISTRATIVE PROVISIONS**

**SECTION 1.** Traffic law enforcers, pollution control officers, transportation officers from the National Government who have certain duties relating to traffic, emission control of motor vehicles and licensing of motor vehicles and drivers shall to consult the Municipal Government on their plans programs and operations and secure approval before implementation thereof from the Sangguniang Bayan pursuant to section 26, 27 and 458 (a) (5) (v) and (vi) of the Local Government Code of 1991.

**SECTION 2.** All traffic signs, signals and road markings intended to inform drivers and regulate the use of streets, alleys, bridges and sidewalks before

they are installed or removed shall be approved by the Sangguniang Bayan through the recommendation of the Municipal Mayor.

### ARTICLE IV - MISCELLANEOUS PROVISIONS

SECTION 1. APPROPRIATION. The sum of Twenty Thousand (P20, 000.00) Pesos shall initially be allocated for the initial printing of traffic citation tickets. Thereafter the costs of the subsequent printings shall be charged to the accumulated penalties for traffic violations.

SECTION 2. SEPARABILITY CLAUSE- If any provisions or part of this Ordinance shall be declared unconstitutional or invalid, the same shall not affect the constitutionality or validity of the other provisions or parts hereof.

SECTION 3. REPEALING CLAUSE- If any provisions or part of any existing ordinance is not consistent with this Ordinance, the same is hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE- This Ordinance shall take effect after three (3) consecutive weeks of publication in a newspaper of general circulation in the province of Leyte.

MINUTES OF THE PUBLIC HEARING ON THE MUNICIPAL ORDINANCE "AN ORDINANCE PROVIDING RULES AND REGULATIONS GOVERNING TRAFFIC IN THE MUNICIPALITY OF PASTRANA AND CORRESPONDING PENALTIES FOR VIOLATION THEREOF" HELD LAST JULY 25, 2024 AT THE MUNICIPAL AUDITORIUM, THIS MUNICIPALITY.

### I. Preliminaries

- a. The Public Hearing was conducted by the Office of the Sangguniang Bayan of Pastrana, Province of Leyte, spearheaded by the SB Committee Vice Chairman on Peace and Order and Public Safety and was joined by the members of the committee mentioned above.
- b. It was well participated by the different Drivers Association, Barangay Chairpersons, Sangguniang Kabataan Chairpersons and all others interested to listen to this particular public hearing. (Attached is the Attendance sheet)
- c. The said public Hearing was Presided over by Honorable Gerardo S. Carian, SB Committee Vice Chairman on Peace and Order and Public Safety.
- d. The said Public Hearing started at exactly 1:30 in the afternoon, and Prayer and the singing of the Philippine National Anthem was conducted through an overture.

### II. Parliamentary Proceedings

- a. The Draft Ordinance, "AN ORDINANCE PROVIDING RULES AND REGULATIONS GOVERNING TRAFFIC IN THE MUNICIPALITY OF PASTRANA AND CORRESPONDING PENALTIES FOR VIOLATION THEREOF", was presented by Hon Gerardo S. Carian and was read by the SB Staff Mr. Emelito Salvador Silva, with a power point presentation. After which Carian proceeded to the different Sections of the proposed ordinance and asked the participants if they have corrections and suggestions. Then, Hon. Nathan G. Letrodo solicited for suggestions and ideas from the participants and according to him everyone is encouraged to share their opinions as all of those will be discussed and so they should not hesitate to do so.
- b. The Presiding Officer expressed that they can go over with each Sections to check and verify if they have clarifications.
- c. One of the drivers named Mr. Marianito clarified if after the third offense they will no longer be apprehended since there are only three offenses.
- d. Hon. Allan Encina and Hon. Philip Tanauan expessed that the fines presented were already okay to the public.
- e. Some of the drivers disagree and wanted to lessen the fines.
- f. Hon. Letrodo explained how the penalties arose and that the committee conducted a committee meeting together with all the concerned agencies specifically the police personnel since they will be the apprehending authority and discuss further to all the participants.
- g. One of the drivers named Mr. Regie expressed that this is just some kind of a discipline to all the drivers and for him impoundment for the 4<sup>th</sup> offense is just okay.
- h. The Presiding Officer expressed that this law is for us to help us drivers lessen the fees since during checkpoints if the municipality will not create its own ordinance, the deputized personnel will apply LTO's law which is derived from the National agency and it costs us drivers too much if we are caught violating it.
- Hon. Letrodo expressed that traffic management personnel should be created at the same time to save time and not to create a separate ordinance anymore, instead it should be included in the proposed traffic ordinance.

- i. The Presiding Officer asked the Chief of Police for suggestions with regards to the penalties.
- k. The Chief of Police P/Capt. Amado Castillo Jr. explained that in the national law which they are applying in the absence of a municipal ordinance Php 5,000.00 for license and Php 8,000.00 for registration. The Chief of police explained further.
- 1. The Presiding Officer expressed that Chief Castillo is the third Chief of Police in the municipality that is implementing deputized personnel.
- m. Chief of Police P/Capt. Castillo expressed that out of 41 municipalities in Leyte Pastrana is one of which who has no municipal ordinance when it comes to traffic. And this is being tagged in his accomplishment. He added that Helmet may not be included in the violations presented.
- n. The Presiding Officer explained that as for now they can push through with two violations and just amend it in the future if there are additional violations to be proposed.
- o. Most of the drivers agreed to include in the proposed violation the exhaust muffler.
- p. One of the drivers named Regie asked if the driver is a minor will they be apprehended.
- q. Chief of Police P/Capt. Castillo exsplained that the parent/guardian of the minor will be the to be called and will be issued the citation ticket or the owner of the motorcycle since he should be responsible for it.
- r. Further discussion was conducted as to the process of the apprehension of the traffic violators.
- III. Finally, "AN ORDINANCE PROVIDING RULES AND REGULATIONS GOVERNING TRAFFIC IN THE MUNICIPALITY OF PASTRANA AND CORRESPONDING PENALTIES FOR VIOLATION THEREOF" presented was applauded by everyone present and thus, being moved by Hon. Armando Lagera, Barangay Chairperson of Barangay Sapsap for approval. And this was duly seconded by Chief of Police P/Capt. Amado Castillo Jr.
- IV. Since all participants were happy on the result of the Public Hearing with the approval of the majority participants present, so be it.

#### V. Adjournment

There being no other matters to be discussed, Public Hearing was moved for adjournment by Hon. Philip Tanauan, Barangay Chairperson of Barangay Lanauan and was duly seconded by Hon. Josephine R. Bohol Barangay Chairperson of Barangay Arabunog at 03:20 in the in the afternoon.

#### DELIBERATION

The Presiding Officer Hon. Gerardo S. Carian called the committee meeting at exactly 10:10 in the morning. Prayer was done through an overture. The Presiding Officer requested the Sangguniang Bayan Secretary-Designate to have the roll call. She declared the presence of a quorum.

The Presiding Officer presented the agenda which is the proposed ordinance "AN ORDINANCE PROVIDING RULES AND REGULATIONS GOVERNING TRAFFIC IN THE MUNICIPALITY OF PASTRANA AND CORRESPONDING PENALTIES FOR VIOLATION THEREOF." The Presiding Officer then requested the SB Secretary - Designate to read the draft ordinance for the committee to give their comments and suggestions after.

Hon. Federico M. Tan asked if the proposed ordinance is already open for corrections. He started correcting Section 1 for the violations driving without license by removing the phrase "first securing proper". He also corrected number 2 driving while under the influence of liquor and omitting and prohibited drugs.

Hon. Rodel M. Tobilla expressed that once the proposed ordinance will be approved and implemented wearing of helmets should be included which obliged only the drivers and exempt the passengers.

Hon. Gerardo S. Carian expressed that this practice is just to make the drivers used to this set up.

Hon. Rodel M, Tobilla explained that we will be imposing an ordinance regarding traffic violation and we will exclude the wearing of helmets.


Hon. Federico M. Tan expressed that if we have the Local Ordinance, it is better because we will be imposing with just few violations. He suggested to review the public disturbances that will be cited in the proposed ordinance.

Hon. Rodel M. Tobilla shared that as he understands when we say traffic ordinance it includes all, he added that those under the influence of drugs can only be identified when tested.

Hon. Federico M. Tan expressed that all of those really should be tested.

Hon. The Presiding Officer told the Body that they must be guided of the ordinance and also the supporting documents, that is why a public hearing will be conducted and comments/suggestions will be accommodated.

The Presiding Officer expressed that all of what they have discussed should be presented during the Public Hearing that will be conducted.
