¹(viii) Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs. projects, services, and activities of the municipal government;

² Section 76. Organizational Structure and Staffing Pattern. - Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

RESOLUTION NO. 33, S. 2025

CRAFTING MUNICIPAL ORDINANCE NO. 6, S. 2025

WHEREAS, Section 447, (a) of the Local Government Code of 1991 (R.A. 7160) states that the sangguniang bayan, as a legislative body, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code;

WHEREAS, DBM BC No. 2004-4, otherwise known as "Guidelines on the Organization and Staffing of Internal Audit Units (IAUs) provides that the LGU shall determine their own staffing modification that the establishment of IAU will require;

WHEREAS, Section 443, (C,2) of the aforesaid Local Government Code provides that the sangguniang bayan may create such other offices as may be necessary to carry out the purposes of the municipal government;

WHEREAS, Section 443, (3, d) of the same Code provides; further, that unless otherwise expressed herein, heads of departments and offices shall be appointed by the municipal mayor with the concurrence of the majority of the sangguniang bayan members, subject to civil service law, rules and regulations.

NOW, THEREFORE, on motion by the **HON. ROGELIO J. BAAY**, Chairman, SB Committee on Employment, duly seconded en masse, Be it

RESOLVED, as the Sangguniang Bayan in regular session assembled hereby resolved, that a legislative measure be enacted, to wit:

AN ORDINANCE ESTABLISHING THE INTERNAL AUDIT UNIT OF LGU-VILLABA AND PROVIDING FOR PLANTILLA POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I, SG 18 (MUNICIPAL INTERNAL AUDITOR III) IN THIS MUNICIPALITY

Section 1. TITLE. – This Ordinance shall be known by the title as shown above under the "RESOLVED" portion.

MC QUIRIE P. JMPAD, J. D. Seyretary to the Sangguniang Bayan **Section 2. ESTABLISHMENT OF INTERNAL AUDIT UNIT.** – There shall be established an internal audit unit in the Municipality of Villaba to augment and facilitate the auditing task herein.

Section 3. LEGAL BASIS. – The establishment of internal audit unit is upheld by Section 443, (C, 2) of the Local Government Code of 1991 which states that sanggunian may create such other offices as may be necessary to carry out the purposes of the municipal government.

Section 4. CREATION OF THE PLANTILLA POSITION OF THE MUNICIPAL GOVERNMENT DEPARTMENT HEAD 1, SG 18 (MUNICIPAL INTERNAL AUDITOR III). – In line with the establishment of Municipal Internal Audit Unit of LGU-Villaba, there shall be created a plantilla position of Municipal Government Department Head I, SG 18 (Municipal Internal Auditor III) to head the Internal Audit Department.

Section 5. QUALIFICATION OF MUNICIPAL INTERNAL AUDITOR. — The following are the Qualification Standards of the Municipal Internal Auditor III per CSC MC No. 12 dated June 22, 2006, to wit:

- > EDUCATION: Bachelor's Degree relevant to the job
- > EXPERIENCE: Two (2) years of relevant experience
- > TRAINING: Eight (8) hours of relevant training
- ➤ ELIGIBILITY : Career Service (Professional/Second Level Eligibility

Section 6. FUNCTIONS OF MUNICIPAL INTERNAL AUDITOR:

- 1. Under direction, supervises a division tasked with internal audit functions
- 2. Establishes the annual goals, objectives and performance targets
- 3. Establishes guidelines and procedure for the guidance of the internal audit staff
- 4. Does the final review of internal audit plans
- 5. Recommends approval of the internal audit plans
- 6. Reviews internal audit report
- 7. Determines training needs of internal audit staff
- 8. Responsible for work performance and discipline of audit staff
- 9. Does related work

Section 7. REGULATION. – The Omnibus Rules on Appointment provides in Section 1, Rule I,that "The State shall ensure and promote the constitutional mandate that appointments in the Civil Service shall be made only according to merit and fitness".

Section 8. SEPARABILITY CLAUSE. – Should any part of this Ordinance be declared unconstitutional by competent authority, the remaining parts not so affected shall continue to be in full force and effect.

Section 9. EFFECTIVITY CLAUSE. – This Ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code.
