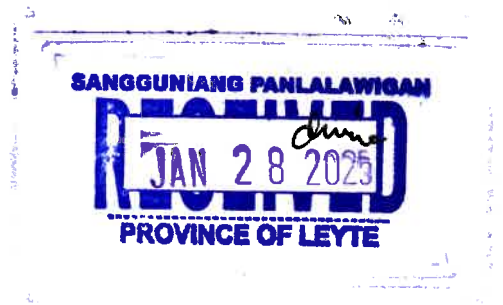



“AN ORDINANCE STRENGTHENING AND INSTITUTIONALIZING THE KADIWA-TIENDA PROGRAM IN THE MUNICIPALITY OF MAYORGA, LEYTE AND APPROPRIATING FUNDS THEREOF.”


Sponsor: Hon. Miguel G. Lumpas

EXPLANATORY NOTE

WHEREAS, it is the policy of the State to promote a just and fair environment for trade and other economic activities, and to provide effective mechanisms or measures to promote the well-being of its citizens, their livelihood, and the economy, in general;

WHEREAS, the TienDA Marketing Program now called as Kadiwa ni Ani at Kita initiative was designed by the Department of Agriculture to directly link up farmers and fishers to consumers to scale down food prices while ensuring growers income;

WHEREAS, the TienDA Marketing program now called as Kadiwa ng Pangulo designed by the Department of Agriculture is a market linkage facilitation program that has removed the unnecessary layers in the trading cycle. Less middlemen adds to the selling value of the products with consumers benefitting from freshly harvested crops and other food items at fair cost. It also capacitates the farmers and fisherfolk to be agri-preneurs.



WHEREAS, this municipalities initiated the Kadiwa TienDA Program/ Kadiwa ng Pangulo (KNP) to help farmers and fisherfolk sell their produce directly to consumer and provides consumers access to quality and safe food items, while ensuring farm producers have ready market.

WHEREAS, the Kadiwa ng Pangulo needs to be established in this municipality to promote direct marketing and address the high cost of agricultural commodities benefitting local producers and consumers.

WHEREAS, it is high time to strengthen and institutionalize the Kadiwa-TienDA Program of this Municipality to provide strong and continuous support to the local farmers and fisherfolks and ensure its sustainability.

WHEREFORE, on motion of the **Honorable Miguel G. Lumpas**, duly seconded by the **Honorable Joseph A. Amante**; be it

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

SECTION 1. TITLE.

This Ordinance shall be known as the “Kadiwa-Tienda Program Institutionalization Ordinance of Mayorga, Leyte.”

SECTION 2. OBJECTIVES.

- 2.1. To establish a permanent Kadiwa-TienDA facility, with necessary market fixtures and amenities;
- 2.2. To provide transportation vehicle/s for adequate use of the Kadiwa-TienDA Program;
- 2.3. To monitor the supply and demand in the local market, and accurately track down the inflow and outflow of farm products;
- 2.4. To help the small local farmers and fisherfolk market their product;
- 2.5. To capacitate the local agricultural and fisherfolk community organizations;
- 2.6. To promote locally produced products of the municipality;
- 2.7. To establish effective and efficient monitoring and evaluation system for Kadiwa- TienDA-Program;
- 2.8. To create a team that will oversee the implementation of the Kadiwa-TienDa Program;
- 2.9. To create Kadiwa-TienDa Association that will manage the program's activities and projects;
- 2.10. To promote partnership and cooperation among stakeholders;
- 2.11. To strengthen and institutionalize the LGU engagement in Kadiwa-TienDA Program.

SECTION 3. SCOPE and COVERAGE.

The Kadiwa-TienDA Program will be implemented within the Municipality of Mayorga, Leyte. This program will also promote networking and market linkages outside the municipality to help the local farmers and fisherfolks find institutional buyers for their locally produced farm products.

SECTION 4. PROGRAM DESCRIPTION.

The following are the key components of the program:


- 4.1. Increased income generation for small local agricultural producers;
- 4.2. Stable prices and food supply and other basic commodities in the local market;
- 4.3. Organizing and strengthening the local community organizations in agricultural and fisheries sector;
- 4.4. Promote Networking and Market Linkages;
- 4.5. Strengthening and Institutionalization of LGU engagement in Kadiwa-TienDA Program.

SECTION 5. DEFINITION OF TERMS.

- 5.1. Kadiwa- Farmers are being brought closer to markets so that middleman, the added cost will be minimized, and the people can buy the products at lower or reasonable cost;
- 5.2. Market Linkages- The market linkage model of social enterprise facilitates trade relationships between the target population or "clients," small producers, local firms and cooperatives, and the external market;
- 5.3. Network- A network marketing business can be a single-tier program, whereby you sell the products, or multi-tier, where you also recruit additional salespeople.
- 5.4. Agricultural Producer- An agricultural producer is a rancher or farmer. These parties produce crops, or breed livestock, or feed livestock prior to slaughter through day-to-day labor and field operations;
- 5.5. Local Community- A local community has been defined as a group of interacting people living in a common location.
- 5.6. Commodities- raw materials or primary agricultural products that can be bought and sold;
- 5.7. Stakeholders- a stakeholder has a vested interest in a company and can either affect or be affected by a business' operations and performance. Typical stakeholders are investors, employees, customers, suppliers, communities, governments, or trade associations.

1. **EXECUTIVE COMMITTEE** - The executive committee shall oversee the overall implementation of the Kadiwa-TienDA Program and provide policy direction and support in achieving the objectives of the program.
2. **LEGISLATIVE COMMITTEE** - This committee shall formulate ordinances, resolutions, and/or any legislative measures supporting the implementation of the Kadiwa-TienDA Program.
3. **MANAGEMENT COMMITTEE**
 - This committee shall provide technical assistance through trainings, seminars, coaching and mentoring to the Kadiwa-TienDA Association.
 - The committee shall assist the Kadiwa-TienDA Association in making financial reports until the Association becomes skillful enough in handling transactions and reporting.
 - This committee shall help the association in and to access to livelihood supports, post-harvest activities, technical assistance, marketing linkages and other programs and projects that can provide support to the implementation of the Kadiwa-TienDA Program.
 - This committee shall assist in planning the operational and management activities of the association.
 - This committee in coordination with the Executive Committee shall ensure that the products of the local farmers and fisherfolks should be transported from the farm site going to the Kadiwa-TienDA marketing site.
4. **MONITORING AND EVALUATION COMMITTEE**
 - This committee shall design the Monitoring and Evaluation tools of the program in both management and operational levels and conduct regular monitoring and evaluation.
 - This committee shall keep Monitoring and Evaluation data and records of the program.
 - This committee shall provide accurate data as needed during the planning sessions.
 - This committee shall provide data and records to the Executive Committee regularly and to other committees whenever they need.
 - Responsible in linking with government agencies and interested private sector key players in providing benchmark data as basis for further improvement.
5. **KADIWA-TIENDA ASSOCIATION**
 - The association shall be responsible in the operations of the Kadiwa-TienDA program including marketing, coordination, and financial transaction and bookkeeping.

- The association shall ensure that the operations of the Kadiwa-TienDA Program should be in line with the objectives of the program and should be smoothly implemented.
- The association shall hold monthly regular meetings to member associations then provide operational and financial reporting during the meeting.
- The association shall formulate operational and marketing plans, strategies and policies then provide a copy to the Executive, Legislative, and Management committees.
- The association in coordination with the Executive and Management Committee's shall help its member associations in improving their local production through access to technical assistance, access to market, and provision of farm inputs, equipment and machineries.
- The association in coordination with the Management committee shall access potential marketing partners and linkages to boost marketing.
- The association shall maintain partnership and coordination with the Department of Agriculture and other concerned agencies.

SECTION 8. PROGRAM SUPPORT.

The Local Government Unit of Mayorga shall support the Kadiwa-TienDa Program through:

- Technical Assistance.
- Free Access to market stall.
- Provide a market venue or market stall to the association who manages the Kadiwa TienDA but if the association fails to sustain the program, the Local Government Unit has all the right to relinquish the said market venue. The ownership of the market stall of Kadiwa TienDA Program belongs to the Local Government Unit of Mayorga who may also designate a market venue to the associations who would like to sell their products every market day in the municipality.
- Provision of farm inputs, equipments, and machineries to local farmers and fisherfolks through local funds or access to grants from other institutions.
- Source out funds from collaborating agencies for the improvement of Kadiwa-TienDA facilities.

SECTION 9. FUNDING.

The Local Government Unit of Mayorga through the Municipal Agriculturist Office shall allocate appropriate funds necessary for the implementation of this ordinance.

SECTION 10. SEPARABILITY CLAUSE

If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 11. APPLICABILITY CLAUSE

All other matters related to the impositions of this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

SECTION 12. REPEALING CLAUSE

All ordinances, resolutions, executive orders or regulations and other issuances inconsistent with the provisions and/or purposes of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 13. EFFECTIVITY CLAUSE.


This ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Leyte


