Hence, compliance with such requirement is recommended.



MUNICIPAL ORDINANCE NO. 2024-21

AN ORDINANCE NAMING THREE (3) UNNAMED STREETS IN THE MUNICIPALITY OF **HILONGOS**

Authored by: HON. EDWIN F. FALLER

Chairperson, Committee on Finance, Appropriations, Ways and Means and Economic **Enterprise**

WHEREAS, Republic Act No. 7160, also known as the Local Government Code of 1991, and the Revised Guidelines of the National Historical Commission of the Philippines grant the Sangguniang Bayan the authority to name, rename, or alter the names of streets, public places, and other structures owned by the municipality within its jurisdiction, thereby enabling local government to honor significant individuals and improve local infrastructure;

WHEREAS, the Municipality of Hilongos currently has several unnamed streets, which hinders easy identification and navigation for residents and visitors alike, creating challenges in locating specific areas within the municipality and leading to practical issues such as delays in postal and delivery services and difficulties for emergency response efforts;

WHEREAS, immediate action to assign names to these streets is essential to enhance public services, facilitate more efficient area identification, and strengthen community pride by commemorating notable public figures whose exemplary leadership, dedication, and contributions have left an indelible mark on the town's progress and identity:

WHEREAS, under Section 13 of the Local Government Code, local government units are empowered to name, rename, or change the names of streets, avenues, boulevards, and other public spaces, providing the legal basis for this ordinance to name certain unnamed streets in Hilongos in honor of the municipality's late mayors;

WHEREAS, the Local Government Code, particularly Article 3, Section 16 (General Welfare Clause), mandates local governments to promote and enhance the general welfare of the community, recognizing individuals who have significantly contributed to the municipality's growth and welfare, and fostering a sense of cultural heritage and community identity;

WHEREAS, naming these streets after past municipal mayors will serve as visible, enduring tributes to their service and leadership, creating a lasting legacy that serves both as an educational tool and a source of community pride, while reinforcing Hilongos' cultural heritage and local identity;

WHEREAS, the municipality acknowledges that honoring the legacy of former mayors through street names will enhance historical awareness among current and future residents, thereby strengthening the social and cultural fabric of Hilongos, and exemplifying the local government's commitment to upholding a sense of continuity and respect for the traditions and achievements that contribute to the municipality's unique identity;

Municipal Ordinance No. 2024-21:

An Ordinance Naming three (3) Unnamed Streets in the Municipality of Hilongos

BE IT ENACTED, by the 16th Sangguniang Bayan of Hilongos in its regular session assembled;

TITLE - This Ordinance shall be known as "An Ordinance Naming three (3) **SECTION 1.** Unnamed Streets in the Municipality of Hilongos."

DEFINITION OF TERMS – For the purposes of this Ordinance, the following SECTION 2. terms are defined as follows:

Road – An open way for vehicles, pedestrians, and animals to travel.

Street – A public thoroughfare within a city or town, typically lined with buildings on one or both sides and wider than an alley.

NAMING OF THREE UNNAMED STREETS - The following streets, all located SECTION 3. in Barangay Western Poblacion that are currently unnamed, are designated for naming, to wit:

- 1. The street located between the Hilongos Municipal Gymnasium and the Municipal Disaster Risk Reduction and Management (MDRRM) Building leading to the Hilongos Coastal Boulevard.
- The street situated between the Hilongos Municipal Gymnasium and the residences in Barangay Western, leading to the wet market and Bagsakan area.
- 3. The street at the corner of R.V. Villaflores Street, leading to the Brgy. Western Poblacion Gymnasium, and the street situated between the Legislative Building and Metro Gaisano.

SECTION 4. NAMES OF STREETS - The aforementioned streets shall be named as follows:

- a. A.N. Fulache Street In honor of the late former Municipal Mayor Armando Napoles Fulache, who was elected on February 3, 1988 until June 30, 1992. The street located between the Hilongos Municipal Gymnasium and the Municipal Disaster Risk Reduction and Management (MDRRM) Building leading to the Hilongos Coastal Boulevard shall be named in his honor.
- b. M.A. Cubio Street In honor of the late former Municipal Mayor Marcial Alfante Cubio, who served Hilongos in the years 1970 to 1978. The street situated between the Hilongos Municipal Gymnasium and the residences in Barangay Western, leading to the wet market and Bagsakan area shall be named in his honor.
- c. H.A. Viterbo Street In honor of the late former Municipal Mayor Harry Amper Viterbo, who was appointed in August 1986 during the EDSA Revolution and served for 18 months. The street at the corner of R.V. Villaflores Street, leading to the Brgy. Western Poblacion Gymnasium, and the street situated between the Legislative Building and Metro Gaisano shall be named after him.

SIGNAGE - The Office of the Municipal Engineer is hereby directed to install appropriate street name signs and markers at the designated locations within thirty (30) days after the effectivity of this ordinance.

Municipal Ordinance No. 2024-21:

- **SECTION 6. REPEALING CLAUSE** All provisions of previous Ordinances, Executive Orders, and Resolutions that are inconsistent with this Ordinance are hereby repealed or modified accordingly.
- **SECTION 7. SEPARABILITY CLAUSE** If any provision of this Ordinance is declared unconstitutional or invalid by a competent authority, the remaining provisions that are not affected thereby shall remain in full force and effect.
- **SECTION 8. EFFECTIVITY** This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
