

SECTION 1. PROGRAM DESCRIPTION. The following are the key components of the Program:

- \* Kadiwa Farmers are being brought closer to the markets so that the added cost (due to middlemen) will be minimized, and the people can buy the products at lower or reasonable cost.
- Market Linkages the market linkage model of the social enterprise facilitates trade relationship between the target population or "clients", small producers, local firms and cooperatives, and the external market.
- Network A network marketing business can be single-tier program, whereby you sell the products, or a multi-tier, where you also recruit additional salespeople.
- Agricultural Producer An agricultural producer is a rancher or farmer. These parties produced crops, or breed livestock or feed livestock prior to slaughter thru day-to-day labor and field on Agriculture operations.
- Local Community A local community has been defined as a group of interacting people living in a common location.
- Commodities raw materials or primary agricultural products that can be bought or sold.
- Stakeholders a stakeholder has a vested interest in a company and can either affect or be affected by a business operations and performance. Typical stakeholders are investors, employees, customers, suppliers, communities, governments, or trade associations.

- 6.3.3. This committee shall help the Association in and to access to livelihood supports, post-harvest activities, technical assistance, marketing linkages and other programs and projects that can provide support to the implementation of the Kadiwa-TienDA Program.
- 6.3.4. The committee shall assist in planning the operational and management activities of the association.
- 6.3.5. The committee in coordination with the Executive Committee shall ensure that the products of the local farmers and fishers shall be transported from the farm site going to the Kadiwa-TienDA marketing site.

## 6.4. MONITORING AND EVALUATION COMMITTEE

6.4.1. The committee shall design the Monitoring and Evaluation tools of the program in both management and operational levels and conduct regular monitoring and evaluation.

6.4.2 This committee shall keep M and E data and records of the program.

6.4.3 This committee shall provide accurate data as needed during the planning sessions.

6.4.4 This committee shall provide data and records to the Executive Committee regularly and to other committees whenever they need.

- 6.5.3 The association shall hold monthly regular meetings to member associations then provide operational and financial reporting during the meeting.
- 6.5.4 The association shall formulate operational and marketing plans, strategies and policies then provide a copy to the Executive, Legislative and Management committees.
- 6.5.5 The association in coordination with the Executive and Management Committees shall help its member associations in improving their local production through access to technical assistance, access to market, and provision of farm inputs, equipment and machinery.
- 6.5.6 The association in coordination with the Management committee shall access potential marketing partners and linkages to boost marketing.
- 6.5.7 The association shall maintain partnership and coordination with the Department of Agriculture and other concerned agencies.

## SECTION 7. ANNIVERSARY OF THE KADIWA-TIENDA PROGRAM.

The Local Government Unit of Matag-ob in coordination with the Program Committee and the Association will celebrate its Anniversary every September 13 every year with corresponding funding support, subject to usual accounting and auditing rules.

- 8.1. Technical Assistance.
- 8.2. Free transportation of products from farm site to marketing area or provision of vehicles for transportation of products and marketing.
- 8.3. Free access to marketing area (Public terminal) every market day or provision of Program owned marketing site or building.
- 8.4. Provision of farm inputs, equipment and machinery to local farmers and fishers through local funds or access to grants from other agencies.
- 8.5. Source out funds from collaborating agencies for the improvement of Kadiwa-TienDA facilities.

### **SECTION 9. FUNDING.**

The Municipal Agriculturist Office shall allocate the amount of Two Hundred Thousand Pesos (Php200,000.00) and other appropriate funds necessary for the implementation of this ordinance.

### **SECTION 10. SEPARIBILITY CLAUSE**

If for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 11. AMENDMENT CLAUSE. This ordinance may be amended or modified as necessary through the appropriate legislative process.

### **SECTION 12. EFFECTIVITY.**

This Ordinance shall take effect after the approval from the Sangguniang Panlalawigan and the requirement of posting prescribed in RA 7160 is complied with.


