Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 02 FY 2024** of the **Municipality of Merida**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 03 Series of 2024** with a total appropriation in the amount of **P7,365,514.00** reveals compliance with the same law and its implementing Rules and Regulations.

Compliance with CSC rules, DBM issuances and accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.
