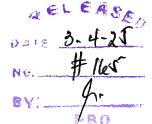

Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 03 FY 2024 of the Municipality of Merida, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 04 Series of 2024 with a total appropriation in the amount of P653,453.49 reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the reversion of appropriations is duly authorized by the concerned officials and are made available to support the expenditures under Supplemental Budget No. 03;
- 2. That the grant of Monetization of Leave Credits shall be subject to CSC Guidelines and Budget Circular No. 2016-2;

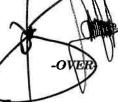

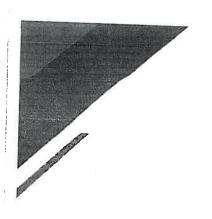
