

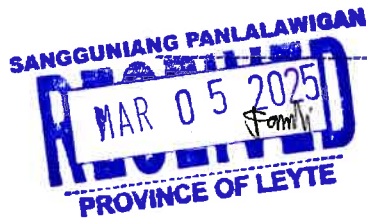
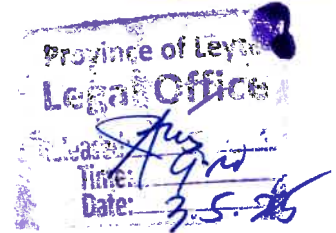

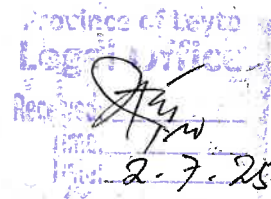

¹ (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.



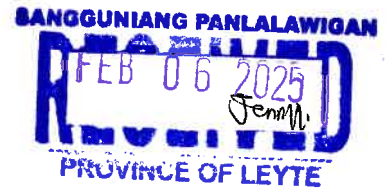

MUNICIPAL ORDINANCE NO. 2025-03

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF J.P. GILOS STREET (IN FRONT OF THE EL SHADDAI ADORATION CENTER) ON FEBRUARY 22, 2025, SATURDAY IN CONNECTION WITH THE 12TH ANNIVERSARY CELEBRATION OF THE PROVINCIAL FORMATION COORDINATING CENTER 42 COUNCIL (PFCC)

WHEREAS, Section 21 of RA 710, also known as the Local Government Code provides that:

- A local government unit may, pursuant to an ordinance permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction;
- Any national or local road, alley, park or square maybe temporarily closed during an actual emergency, or fiesta celebration of which the duration of which shall be specified by the Local Chief Executive concerned in a written order;

WHEREAS, the El Shaddai Community of the Diocese of Maasin asked for permission to temporarily close of J.P. Gilos Street in front of the El Shaddai Office on February 22, 2025 in connection of the 12th Anniversary Celebration of the Provincial Formation Coordinating Center 42;

NOW THEREFORE, on motion of Hon. Francisco M. Ortega in unanimous accord;

BE IT ENACTED by the 16th Sangguniang Bayan of Hilongos in a regular assembled that:

SECTION 1. It is hereby declared temporary closure to vehicular traffic of a portion of J.P. Gilos Street in front of the El Shaddai Office on Saturday, February 22, 2025 from 7:00 A.M. to 9:00 P.M. , however, residents living in the said area are allowed to pass through the area.

SECTION 2. The portion of J.P. Gilos Street will be temporarily closed to vehicular traffic for the sole purpose of conducting activities in relation to the above-mentioned activity;

SECTION 3. During the temporary closure, no barricades shall be installed on the said J.P. Gilos Street except a traffic sign indicating such closure.

SECTION 4. The Office of the Municipal Mayor will coordinate with Traffic Enforcers and the Philippine National Police to facilitate security of the concerned area.

SECTION 5. When circumstances so demand as when emergencies arise, the closure being temporary in nature may be lifted.






