Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 03 FY 2024 of the Municipality Jaro, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 4, S. 2024 with a total appropriation in the amount of P13,995,000.00 reveals compliance with the same law and its implementing Rules and Regulations.

Compliance with DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.


