

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 5 FOR FISCAL YEAR 2024 OF THE MUNICIPALITY OF BABATNGON, LEYTE IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED ONE THOUSAND EIGHT HUNDRED FORTY-TWO PESOS AND 63/100 (Php 1,701,842.63).

Be it enacted by the Sangguniang Bayan of the Municipality of Babatngon, Leyte in session assembled:

SECTION 1. – The Supplemental Budget No. 5 of the Municipality of Babatngon, Leyte for Fiscal Year 2024 in the amount of ONE MILLION SEVEN HUNDRED ONE THOUSAND EIGHT HUNDRED FORTY-TWO PESOS AND 63/100 (PhP 1,701,842.63) is hereby approved.

The following budget documents are incorporated herein and made integral part of this Ordinance:

- 1. Certificate of Availability of Funds signed by the Municipal Treasurer and Municipal Accountant;
- 2. Statement of Funding Sources signed by the Municipal Treasurer and the Municipal Accountant; and
- 3. Statement of Supplemental Appropriation signed by the Municipal Budget Officer and the Municipal Mayor

SECTION 2. Sources of Funds. The source of funds for Supplemental Budget No. 5 of the Municipality of Babatngon, Leyte in the amount of PhP 1,701,842.63 is derived from the General Fund Supplemental Budget No. 1 series of 2024 of the Municipality of Babatngon, Leyte.

SECTION 3. Use of Funds. The amount of PhP 1,701,842.63 is hereby appropriated for Supplemental Budget No. 5, FY-2024 of the Municipality of Babatngon, Leyte.

SECTION 4. Separability Clause. If, for any reason, any Section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

SECTION 5. Effectivity. This Appropriation Ordinance shall take effect upon approval.


