100	SECTION 20. Reclassification of Lands.
101	(a) A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for
102	the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically
103	feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential.
104	commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided. That such reclassification shall
