COMMITTEE REPORT

Referred to this Committee through SP Resolution No. 2024-097 dated February 27, 2024, from the Municipality of Leyte is Ordinance No. 096-24 entitled, ORDINANCE PROVIDING MINIMUM QUALIFICATIONS FOR CHILD DEVELOPMENT WORKERS, THEIR FUNCTIONS AND BENEFITS.

Upon perusal of said ordinance, the committee finds said ordinance congruent to Republic Act 6972 otherwise known as the Barangay Level Total Development and Protection of Children, Republic Act 8980 or the Early Childhood Care and Development Act, and Republic Act 10410 or the Early Years Act, which policies involve development and protection program for children, multi-sectoral and interagency collaboration among government service providers, families and communities at the national and local levels and strengthening of government's program for young children, respectively.

The ordinance recognizes the Child Development Workers' important role in society, hence, providing them support that they deserve to ensure that their well-being is protected by granting them with the compensation and benefits that they deserve.

The Committee therefore, recommends to this August Body the approval of Ordinance No. 096-24, entitled ORDINANCE PROVIDING MINIMUM QUALIFICATIONS FOR CHILD DEVELOPMENT WORKERS, THEIR FUNCTIONS AND BENEFITS AS ORDAINED by the Sangguniang Bayan of the Municipality of Leyte, Leyte.

REPOSAR: 1ST DISTRICT BOARD MEMBER 700 701 Thank you very much Honorable Presiding Chair and the Honorable Floor Leader. 702 This is in relation to the jurisdiction of the Local Government Units over the 15kilometer municipal waters. On December 18, 2024, the Supreme Court made public its 703 Resolution dated August 19, 2024, in the case of, before, D.A. versus a commercial 704 fishing corporation which is Mercedar Fishing Corporation. The said decision declared 705 Section 16 and Section 18 of Republic Act 8550 as amended by Republic Act 10654 or 706 the Fisheries Code of the Philippines with no binding and force or without legal effect. 707 Hence, a sudden shift as a legal consequence of the control of the municipal waters from 708 the LGU which means the Local government Units will now have a difficulty in prohibiting 709

big commercial fishing vessels entering the 15-kilometer prohibited zones for commercial

fishing. For the information of the members of the council, the means of the commercial fishing vessels which has 3 tons or more, are active fishing. For example, the use of trolls/ring nets and other active fishing gears which are very destructive to our sea grass areas and the coral areas, particularly within the said 15-kilometer zones.

In the advent of this decision, several local government units, public interest and civil society groups and academe or academic institutions have manifested their protest to the extent that to this date, a number of petitions have been filed by fisherfolk and environmental groups before the Supreme Court seeking to be allowed to intervene on the case and argue its reversal.

With that being said, Mr. Chair, and recently, in addition, the Province of Iloilo has actually filed already their legal actions seeking for the reversal of the said ruling. With the permission of the Chairperson of the Committee on Agriculture, Mr. Chair, I'd like to propose the passage of a Resolution expressing support to the said actions of the various communities, civil society organizations and local government units who seek or wish to protect the natural resources, coastal and marine resources, within the 15-kilometer zones. I so move, Mr. Chair.
