

¹ (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

⁽c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

Section 3. Traffic Management and Safety. To ensure the safety of both motorists and pedestrians, precautionary signages must be installed in the area. All necessary measures shall be taken to minimize disruption to both residents and businesses. Relevant authorities shall work closely to implement traffic diversions and provide alternative routes during the closure periods. Assigned personnel must direct traffic any time of the day and night.

Section 4. Separability. Should any provision of the ordinance be subsequently declared unconstitutional or invalid, the other portion not so declared shall remain in full force and effect.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval in accordance to law.

Section 8. Funding

The necessary funds for the implementation of this Ordinance shall be included in the Annual Budget of the Municipality of Tolosa, Leyte, and supplemented by grants, donations, or external funding sources as available.

Section 9. Monitoring and Evaluation

Monitoring Committee: A committee composed of representatives from various sectors shall be formed to oversee the implementation of modernization initiatives.

Periodic Reviews: Annual reviews shall be conducted to evaluate the progress and effectiveness of modernization efforts.

Transparency Reports: Regular reports on modernization progress and expenditures shall be published and made accessible to the public.

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality of Tolosa in session assembled that:

Section 1. Title. - This Ordinance shall be known as "An Ordinance Declaring the Temporary Closure to Vehicular Traffic the portions of the Streets in Barangays Poblacion and Imelda during socio-cultural and socio-economic activities pursuant to Tolosa Day Celebration"

Section 2. Scope. - Authority is hereby given for temporary closure of A. Mabini Street rom Imelda Lane to San Miguel from any form of motorized vehicles and pedicabs starting 4:00pm 12:00mn from April 9 - May 9, 2025 and be dubbed as "strEAT" where townsfolk can enjoy street foods, local cuisines, and local products in a safe and orderly manner.

Exemption is hereby granted to LGU Official vehicles, emergency transport vehicles, police mobile patrol vehicles, and fire trucks.

Section 3. Traffic Management and Safety. To ensure the safety of both motorists and pedestrians, precautionary signages must be installed in the area. All necessary measures shall be taken to minimize disruption to both residents and businesses. Relevant authorities shall work closely to implement traffic diversions and provide alternative routes during the closure periods. Assigned personnel must direct traffic any time of the day and night.

Section 4. Separability. Should any provision of the ordinance be subsequently declared unconstitutional or invalid, the other portion not so declared shall remain in full force and effect.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval in accordance to law.

> b. Temporary Closure of Streets in the Perimeter of the Municipal Town Plaza from Any Form of Motorized Vehicles and Pedicabs from April 27 - May 9, 2025.

The ordinance was also discussed, with Hon. Melanie Felisa M. Vivero emphasizing that emergency and LGU vehicles would still have access, ensuring no disruption to essential services. 
