WHEREAS, the August Body, deemed it proper to request the Sangguniang Bayan of Palo, Leyte to furnish the August Body copies of the certifications from the Municipal Agriculturist Office and Municipal Disaster and Risk Reduction Office and such other concerned local government functionaries, pursuant to existing local ordinances such as the Food Security Ordinance of Palo of 2012 (MO No. 2012-05), Ordinance Strengthening Disaster Risk Reduction and Management in Land Use of the Municipality of Palo, Province of Leyte and Providing Fines and Penalties Thereof, (MO No. 2012-06) and Ordinance Setting forth the Guidelines for Issuances of "A Resolution Interposing No Objection" Providing Fines and Penalties Thereof (MO No. 2018-03).
