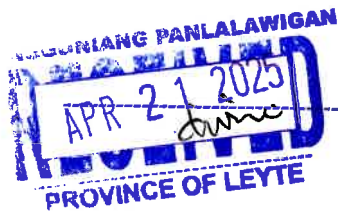
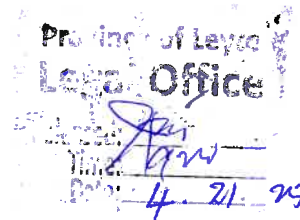

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 2025-003 of the Sangguniang Bayan of Sta. Fe, Leyte.

**Issues/concerns for review/recommendation/legal opinion is/are as follows:**

- Ordinance No. 2025-003 entitled: "An Ordinance prohibiting the nailing, pasting, posting, and hanging of streamers, posters, banners, etc."

**REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office is of the opinion that the subject Ordinance is generally in accordance with its power under Section 447(a)(vi)<sup>1</sup> of the Local Government Code of 1991 (R.A 7160). Hence, we recommend for the declaration of its validity, provided that Section 458(a)(1)(vi) be changed to Section 447(a)(vi) since the cited provision pertains to Sangguniang Panglunsod and not Sangguniang Bayan.

We hope to have assisted you with this request. Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.

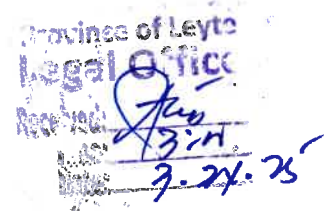

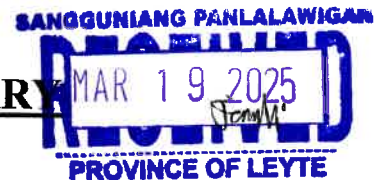

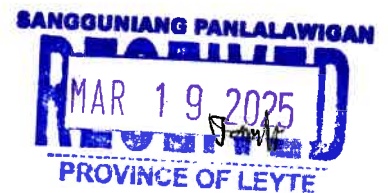

**WHEREAS**, Section 16, Article II of the 1987 Constitution declares that, "The state shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature".

**WHEREAS**, Section 3 of Republic Act 3571, otherwise known "An Act to Prohibit the Cutting, Destroying or injuring of Planted or Growing Trees, Flowering Plants and Shrubs or Plants of Scenic Value along Public Roads, in Plazas, Parks, School Premises or in any Other Public Pleasure", provides that no cutting, destroying or injuring of planted or growing trees, flowering plants and shrubs or plants in scenic value along public roads, in plazas, parks, school premises or in any other public ground shall be permitted save when the cutting, destroying or injuring of the same is necessary for the public safety or the pruning of the same is necessary to enhance its beauty".

**WHEREAS**, Section 458 (a)(1)(vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan shall approve ordinances and pass resolutions necessary for an efficient and effective government, and line with this, shall protect the environment and impose appropriate penalties for acts which endanger the environment;

**WHEREAS**, the nailing, pasting, posting and hanging of streamers, posters, banners, political ads and other similar materials on trees, especially when using iron nails, could severely or seriously damage the health of trees;

**WHEREAS**, a healthy tree is a source of oxygen, a trap for carbon dioxide and greenhouses gases, provides shade, coolness and promotes a livable environment;

**NOW THEREFORE**, be it ordained by the Sangguniang Bayan in a session assembled to enact:

**SECTION 1. TITLE.** This ordinance shall be known "AN ORDINANCE PROHIBITING THE NAILING, PASTING, POSTING, AND HANGING OF STREAMERS, POSTERS, BANNERS, POLITICAL ADS AND OTHER SIMILAR MATERIALS ON TREES AND SPECIES OF THE SAME NATURE IN THE MUNICIPALITY OF SANTA FE, LEYTE.

**SECTION 2. DECLARATION OF POLICY.** It shall be declared the policy of Municipality of Santa Fe to take an active rate in the management and conservation of its natural resources, to promote and conserve the beauty of objects of scenic and ornamental value and help preserve cool, fresh and healthful climate, to obtain the optimum benefits therefrom and preserve the same for the future generations.

**SECTION 3. SCOPE AND APPLICABILITY.** The provisions of the ordinance shall apply to all acts of nailing, pasting, posting, hanging or attaching any and all forms of streamers, posters, banners, political ads and other similar materials on trees and species of the same nature in public or private places within the territorial jurisdiction of the Municipality of Santa Fe, Leyte.

**SECTION 4. DEFINITION OF TERMS.** When used in this ordinance, the following terms shall mean:

- a) **TREE-** A usually tall plants that has thick, wooden stem and many large branches; a woody perennial plant having a single usually elongated main stem generally with few or no branches on its lower part; includes bamboo grass, banana shrubs.
- b) **POSTER-** Any material placed for posting often in a public place; usually decorative or has a picture.
- c) **STREAMER-** A long narrow piece of colored paper or plastic that is used as a decoration. It may be made of cloth or tarpaulin displayed to announce an event or promote a product.
- d) **BANNER-** A strip of any material, usually made of cloth with design, picture, or writing on it.
- e) **POLITICAL ADS-** Any political campaign paraphernalia used during elections and may be made of paper, cloth, or tarpaulin in varying sizes.
- f) **OTHER SIMILAR MATERIALS-** Any notices or announcements that promote a business, profession, service or entertainment, or a commodity sold or offered for public/private use, or for any other purposes.
- g) **NAILING-** The act of using a long, thin piece of metal that is sharp of one end and flat at the other end to attach things to wood; includes the act of tacking using a material that is capable of passing through the surface or body of a tree or its branches;
- h) **POSTING-** To publish, announce, or advertise through the use of a poster, streamer, or banner.
- i) **PASTING-** The act of causing something to adhere by applying paste or similar material.
- j) **HANGING-** To attach or place something so that it is held up without support from below.
- k) **PERSON AND JURIDICAL PERSON-** Include natural persons as well as board of directors, officer of corporations, partnerships, associations and cooperatives who cause and authorize the nailing, pasting, posting and hanging of streamers, posters, banners, political ads and other advertising materials on trees in Santa Fe.

**SECTION 5. PROHIBITED ACTS.** It shall be unlawful to nail, paste, hang, tack or attach streamers, posters, banners, political advertisements or any other similar materials on trees and species of the same nature, as defined in Section 4, Paragraph (a), in public and private places within the territorial jurisdiction of the Municipality of Santa Fe.

**SECTION 6. PERSONS LIABLE.** The following persons are liable and shall be personalized under this Ordinance, to wit:

1. Any person, including board of director or officers of corporations, partnership, associations and cooperatives who causes or authorizes the nailing, pasting, posting, tacking and hanging of streamers, posters, banners, political ads and other similar materials on trees and species of similar nature in;
2. Any person who actually and directly nails, posts, pastes, tacks, hangs, or attaches streamers, posters, banners, political ads or other similar materials on trees and species of similar nature and those who aids in the commission of the acts;
3. Owners of the lot where trees is located who consented to the same acts;

**SECTION 7. RULES AND REGULATIONS.**

1. Personnel of the Municipal Environment and Natural Resources Office (MENRO), Municipal Engineering Office (MEO), Municipal Planning and Development Office (MPDO), Barangay Officials and Barangay Tanods are hereby deputized as Enforcers of this Ordinance.
2. The Enforcers shall be tasked with the proper and strict implementation of this Ordinance. They should exercise close monitoring and enforcement of this Ordinance.
3. The Police (PNP) shall be tasked to conduct orientation to units deputized as Enforcers and shall assists them in the proper implementation of this Ordinance.
4. An IRR embodying the enforcement procedures of this Ordinance shall be formulated and shall provide for the following cases:
  4. A – If advertisement and other information materials are found already posted, nailed, hanged or pasted in the tree/s in both public and private places.
  4. B – If the offender is caught in the act.
  4. C – In cases of unidentified violators, their posted advertisement will be removed right away.

**SECTION 8. PENALTIES.** – Any person as defined in Section 6 hereof who violated this Ordinance shall be meted the following penalties, to wit:

FIRST OFFENSE. The violator shall pay a fine of ONE THOUSAND PESOS (P 1,000.00)

SECOND OFFENSE. The violator shall pay a fine of TWO THOUSAND PESOS (P 2,000.00)

THIRD AND SUCCEEDING OFFENSE. TWO THOUSAND FIVE HUNDRED PESOS (P 2,500.00).

**SECTION 9. SEPARABILITY CLAUSE.** – If for any reason/s any provision of this ordinance is rendered invalid or unconstitutional, such provisions not affected by such declaration shall remain to be in full force and effect.



During the deliberations of the relevant sections of the said ordinance, the focus shifted to Section 8. Penalties with questions from Hon. Charlito Lago, Barangay Chairman of Zone 1.

HON. CHARLITO LAGO: *"Nasiring ka waray ka magbutang hin imprisonment, aanhon mo man pagpenalize hiton?"*

CHAIRPERSON: *"During han amon seminar ha Vigan gindidiscourage iton imprisonment. Kun may ada kita proper protocol paghandle hinin mga penalties like magkamay ada kita implementing division, hira iton incharge under hiton mayor's office if incase diri magpakabayad ituturn over inin hira ngadto hiton court".*

HON. CHARLITO LAGO: *"Diri ka pwede magkadto ha korte kun diri ka magsabmiti hin kaso. Kinahanglan hihimuan anay ton hit Committee kun anu it dapat igkaso ha iya ngan asya ton it pagprocess na hit korte."*

Following a question-and-answer session between the Barangay Chairman of Zone 1, Hon. Charlito Lago and the Committee Chairperson, Hon. Amiel P. Enage, the Committee Chair noted Hon. Lago's suggestion. Other matters were discussed.

**VII. Summary:**

The Committee on Environmental Protection and Waste Management conducted a Public Hearing last January 17, 2025 at the Mayor's New Conference Hall to inform the public about a proposed ordinance, An Ordinance Prohibiting the Nailing, Pasting, Posting, and Hanging of Streamers, Posters, Banners, Political Ads and Other Similar Materials on Trees and Species of the Same Nature in the Municipality of Santa Fe, Leyte. During the deliberations of the relevant sections of the said ordinance, one of the main points of focus was the penalty clause. Hon. Charlito Lago, Barangay Chairman of Zone 1 commented on the absence of imprisonment as a possible penalty in the proposed ordinance. Upon the explanations from the Committee Chair that cases could be directly referred to the court, Hon. Lago countered and suggested that the Committee should first submit the case to the court for processing before any further action could be taken.


**VIII. Adjournment:**

As no further questions and clarifications from the attendees, the Public Hearing was **ADJOURNED** at 12:10 in the afternoon by **Hon. Amiel P. Enage** being no further business to discuss.

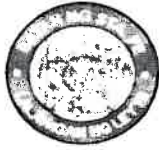

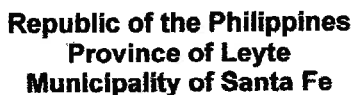
