Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 2024-218 of the Sangguniang Bayan of Carigara, Leyte.

Issues/concerns for review/recommendation/legal opinion is/are as follows:

• Ordinance No. 2024-218 entitled: "An Ordinance providing penalty for the abuse, misuse, falsification, etc."

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is generally in accordance with its power under Section 447(a)(1)(iii)¹ of the Local Government Code of 1991 (R.A 7160) in relation to Article 170-172² of the Revised Penal Code. However, it is recommended that the phrase "any ID issued by the government" found on Section 7 of the proposed Ordinance be changed and limited to ID's issued by Carigara LGU, consistent with the title of the Ordinance. Hence, we recommend for the declaration of its validity subject to consideration of the recommendation.

We hope to have assisted you with this request. Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.

"Section 9. The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all.

Section 10. The state shall promote social justice in all phases of national development."

WHEREAS, Section 16 of the Local Government Code 1991, provides that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare within their respective territorial jurisdictions, local government units shall ensure and support, among other things, improve public morals, enhance economic prosperity and social justice, and maintain peace and order."

WHEREAS, the Municipal Government of Carigara issues Identification Card as Competent Evidence of Identity (CEI), as well as to recognize an individual's belongingness, such as but not limited to PWD ID, OSCA ID, SOLO PARENT ID, Employee ID, Driver's Registration ID, and all other IDs issued by the Municipal Government of Carigara;

WHEREAS, the Identification Card Issued by the Municipal Government of Carigara are considered Competent Evidence of Identity (CEI) and/or documents being presented to claim benefits, receive salary in case of Employee ID-ATM, and grant of privileges to qualified possessor;

WHEREAS, to regulate the use and penalize the abuse in the use of ID being issued by the Municipal Government of Carigara, the Sangguniang Bayan hereby enact an ordinance for the purpose;

NOW, THEREFORE, be it ORDAINED as it is hereby ORDAINED by the Sangguniang Bayan of Carigara, in a session duly assembled that:

SECTION 1. TITLE - This Ordinance shall be known as, "ANTI-FAKE ID ORDINANCE".

SECTION 2. PURPOSE - This Ordinance is formulated to regulate the use of Municipal Government of Carigara issued ID and provide penalty for violations and prohibited acts.

SECTION 3. CONSTRUCTION - This Ordinance shall be construed and applied in accordance with and in furtherance of the policies and objectives of the law.

SECTION 4. LEGAL BASES AND MANDATES - The adoption of this ANTI-FAKE ID ORDINANCE is in line with the objective of the Municipal Government of Carigara to protect the rights and privileges of all citizens, as embodied in the following local and national mandates and policies, to wit:

- 1. Revised Penal Code (RPC) The RPC, as amended, provides foundational penal provisions on crimes involving falsification, deceit, and fraud. Of particular relevance are the following:
 - a. Falsification of Public Documents (Articles 170-172 of the RPC)
 - b. Falsification of Private Documents (Article 172 of the RPC)
 - c. Estafa (Article 315 of the RPC) or the Anti-Bouncing Checks Law (B.P. Blg. 129)
- 2. Identity Theft and Cyber-Related Offenses Laws cover unauthorized use of personal information and the use of computers and the internet in committing crimes:
 - a. Republic Act No. 10175 (Cybercrime Prevention Act of 2012
 - b. E-commerce Act (Republic Act No. 8792)
- 3. Data Privacy and Personal Information Protection
 - a. Data Privacy Act of 2012 (Republic Act No. 10173)
- 4. Anti-Financial Fraud Laws and Other Special Laws
 - a. Philippine Identification System Act (Republic Act No. 11055)
 - b. Access Devices Regulation Act (Republic Act No. 8484)
 - c. Anti-Money Laundering Act (Republic Act No. 9160, as amended)

SECTION 5. DEFINITION OF TERMS - The following terms, for purposes of this Ordinance, shall be defined as follows:

ALTERATION is an act of unauthorized changing by any means the figures, letters, words or signs contained in the identification card.

COMPETENT EVIDENCE OF IDENTITY (CEI). This refers to the identification of an individual based on, at least one current identification document issued by an official agency bearing the photograph and signature of the individual, such as but not limited to, passport, driver's license, Professional Regulations Commission ID, National Bureau of Investigation clearance, police clearance, postal ID, voter's ID, Barangay certification, Government Service and Insurance System (GSIS) e-card, Social Security System (SSS) card, PhilHealth card, senior citizen card, Overseas Workers Welfare Administration (OWWA) ID, OFW ID, seaman's book, alien certificate of registration/immigrant certificate of registration, government office ID, certification from the National Council for the Welfare of Disabled Persons (NCWDP), Department of Social Welfare and Development (DSWD) certification, as the case may be.

DRIVER'S ID shall refer to as the Identification Card issued by the Local chief Executive.

EMPLOYEE ID shall refer to the identification card being issued by Human Resources and Management Office to Municipal Government employees.

OSCA ID shall refer to the Identification Card issued by the Office of Senior Citizen's Affairs (OSCA) to residents or constituents of the Municipality of Carigara, who is already sixty (60) years old and above.

PWD ID shall refer to the identification card issued by the Persons with Disability Affairs Office (PDAO) together with the Purchase and Medicine Booklet. This is being used by the PWD by presenting the same to the merchant in claiming discounts he is entitled during purchase of goods and/or medicines.

SOLO PARENT ID shall refer to the Identification card issued by the Municipal Social Welfare and Development Office (Solo Parent Unit) to residents or constituents of the Municipality of Carigara, who fall under the categories of being Solo Parent as prescribed by RA 8972, as amended by Republic Act 11861

FALSIFICATION shall mean an act of altering, counterfeiting, intercalating or

submitting public and private documents or identification that is false or misleading. The following acts are considered falsification in this Ordinance: counterfeiting or imitating and handwriting, signature or rubric; making untruthful statements in a narration of facts, or information in applying for identification card; erasing, substituting, counterfeiting, altering or intercalating, or tampering by any means the figures, letters, words, signs, symbols, true dates contained in the identification card/s.

GOVERNMENT ISSUED IDENTIFICATION shall refer to any Identification issued by the Municipal Government of Carigara which includes, but not limited to PWD ID, OSCA ID, Employee ID, and SOLO Parent ID, among other.

MEDICINE BOOKLET. Shall refer to the booklet issued by the Persons with Disability Affairs Office (PDAO) and Office of Senior Citizens Affairs (OSCA) and being presented together with the identification card to the merchant during the purchase of medicine to avail of the discount he/she is entitled.

MUTILATION it is an act of tearing any part or portion of the identification card.

PURCHASE BOOKLET shall refer to the booklet issued by the Persons with Disability Affairs Office (PDAO) and Office of Senior Citizen's Affairs Office (OSCA) and being presented together with the identification card to the merchant during the purchase of commodity to avail of the discount he is entitled.

REPRODUCTION shall mean an act of making copy or duplication of the identification issued by the Municipal Government of Carigara.

TAMPERING is an act of unauthorized removing by any means, any figures, letters, words, symbols or signs, true dates contained in the identification card.

SECTION 6. COVERAGE - This Ordinance shall apply to any individual, resident or non-resident, and business establishment, who will ABUSE, ALTER, FALSIFY, MISUSE, MUTILATE, TAMPER AND OTHER SIMILAR ACTS, any identification card issued by the Municipal Government of Carigara, including but not limited to PWD, OSCA, Employee, Driver's Registration ID, and the likes.

SECTION 7. PROHIBITED ACTS - It shall be unlawful for any person who utilizes

any government issued ID in an unlawful manner or use the same to commit any fraudulent act or for any unlawful purpose/s.

The following acts or omissions are prohibited by this Ordinance:

- a. The willful submission or causing to be submitted a fictitious name or false information in the application, renewal, or updating of information contained in any Municipal Government issued identification card;
- b. The unauthorized printing, duplication, reproduction, manufacturing preparation or issuance of any invalid identification card purporting to be Municipal Government issued, for purposes of claiming benefits pertaining thereto without presenting the original.
- c. The unauthorized use of any Municipal Government issued identification card, without reasonable excuse by any person other than the one whom it was issued;
- d. Falsification, mutilation, alteration and tampering of Municipal Government Issued identification card.
- e. The possession of fake, falsified, mutilated, tampered or altered Municipal Government issued identification card;
- f. The use of fake, falsified, mutilated, tampered or altered Municipal Government issued identification card.

The penalties imposed in this Ordinance shall be in addition to those imposed on acts or omissions punishable by existing penal and other laws.

SECTION 8. ADMINISTRATIVE PENALTY - Any person who utilizes any government issued identification card in an unlawful manner or use the same to commit any fraudulent act or for any unlawful purpose/s shall be punished with administrative penalty:

- a. 1st OFFENSE Administrative penalty of Php 1,000.00 shall be imposed to any person found violating any provisions of this Ordinance.
- b. 2nd OFFENSE Administrative penalty of Php 1,500.00 shall be imposed to any person found violating any provisions of this Ordinance
- c. 3rd AND SUCCEEDING OFFENSES Administrative penalty Php 2,500.00 shall be imposed to any person found violating any provision of this Ordinance.

SECTION 9. CRIMINAL LIABILITY. In all cases, the Municipal Government of

Carigara through Task Force Disiplina and/or Public Order and Safety Group, in coordination with Municipal Administrator/Legal Officer, may file a criminal case against the offender for gross violation of this ordinance. He/ She shall be held liable for an additional charge of Five Hundred Pesos (Php 500.00) for the cost of filing and litigation of case filed in court for the offenses defined in this ordinance. Upon conviction thereof, he/she shall be punished by a fine of not more than Two Thousand Five Hundred Pesos (Php 2,500.00) or imprisonment of not more than Ten (10) months, or both, upon the discretion of the court, in addition to administrative penalty and cost of filing and litigation.

The penalties imposed in this section shall be in addition to those imposed on acts or omissions punishable by existing penal and other laws. Likewise, the payment of administrative penalty is without prejudice to the filing of civil/criminal case in court.

SECTION 10. IMPLEMENTING AGENCY - This ordinance shall be implemented generally by the Task Force Disiplina, in coordination with the Administrator's Office/Legal Officer, Human Resource and Management Office, Persons with Disability Affairs Office, Office of the Senior Citizens Affairs, and Municipal Social Welfare and Development Office.

The Philippine National Police (PNP), and Carigara Traffic Management Office (CATEMO) shall implement provisions of this Ordinance pertaining to <u>Driver's ID</u> issued by the Local Chief Executive.

In both cases, the Task Force Disiplina and/or the CATEMO shall coordinate with Administrator's Office for the filing of appropriate action in court.

Composition of Task Force Disiplina:

- 1. Municipal Administrator/Legal Officer
- 2. Human Resource Management Office
- 3. Persons with Disability Affairs Office
- 4. Office of the Senior Citizens Affairs
- 5. Municipal Social Welfare and Development Office

SECTION 11. PROCEDURE IN CASE OF VIOLATION – Upon reasonable belief that the identification card being presented is falsified, mutilated, altered or any provisions and prohibited acts of this Ordinance is being violated, the concerned office shall confiscate the

identification card being presented and report the matter to the Task Force Disiplina, PNP or CATEMO, as the case may be. Upon apprehension of any person found violating any provisions of this Ordinance, an Ordinance Violation Receipt (OVR) shall be issued and corresponding penalties to be paid accordingly.

The administrative penalties and cost of filing and litigation, as the case may be, under this Ordinance shall be paid directly to the Treasurer's Office of the Municipality of Carigara and shall form part of the General Fund.

SECTION 12. SEPARABILITY CLAUSE - If any provision of this Act is declared invalid or unconstitutional, other provisions hereof which are not affected thereby shall remain in full force and effect.

SECTION 13. REPEALING CLAUSE - All ordinances, rules and regulations and other parts thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 14. EFFECTIVITY CLAUSE - This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of local circulation and its posting in the bulletin board at the entrance of the LGU Municipal Hall and in two (2) conspicuous places in the municipality.
