

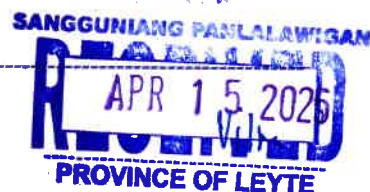
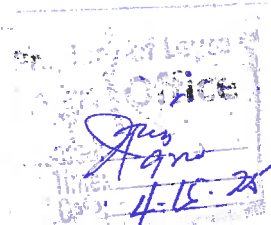

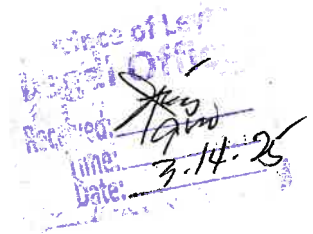

¹ (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

(1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government,

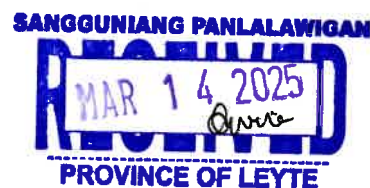



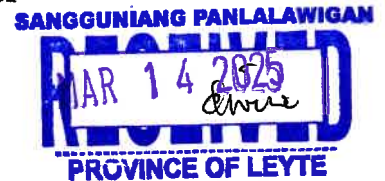

ORDINANCE NO. 16, S. 2024

AN ORDINANCE PROVIDING FOR A COMPREHENSIVE YOUTH WELFARE AND DEVELOPMENT OFFICE AND COUNCIL IN THE MUNICIPALITY OF BARUGO, LEYTE INSTITUTIONALIZING FUNDS THEREOF AND FOR OTHER PURPOSES.

EXPLANATORY NOTE

WHEREAS, Article II, Section 13 of our Constitution of 1987 mandates the State recognition of the vital role of the youth in nation-building and promotion and protection of their physical, moral, spiritual, intellectual and social well-being and states further its role to inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Presidential Decree 603 or The Child and Youth Welfare Code expresses that the child and youth are one of the important assets of the nation, thus, every effort should be exerted to promote their welfare and enhance opportunities for a useful and happy life;

WHEREAS, Republic Act 8044 otherwise known as the "Youth in Nation Building Act of 1995" creates the structures to implement a comprehensive and coordinated program for the youth and gives recognition to the youth's Responsibility in fulfilling their vital role in nation-building;

WHEREAS, Republic Act No 10742 also known as the Sangguniang Kabataan Reform Act of 2015 has introduced innovations such as the institutionalization of a local youth development council, creation of a youth affairs office, establishing mandatory training and providing an anti-political dynasty provision among others;

WHEREAS, the development and welfare of the youth sector in the Municipality of Barugo in terms of promotion of their well-being and total development, and their protection from exploitation, abuse, hazards and other circumstances prejudicial to their physical, mental, intellectual, emotional, social and moral development are utmost priorities;

WHEREAS, in the Municipality pursuit for progress and development, the youth sector must be fully assimilated in the mainstream so as to ensure an improved quality of life and youth-friendly environment where there are guarantees for educational opportunities, economic privileges, civil and political rights;

WHEREAS, to further realize these development approaches for the Municipality's youth constituents an ordinance shall be enacted by the Sangguniang Bayan for this purpose.

MUNICIPAL ORDINANCE NO. 16, 2024

AN ORDINANCE PROVIDING FOR A COMPREHENSIVE YOUTH WELFARE AND DEVELOPMENT OFFICE AND COUNCIL IN THE MUNICIPALITY OF BARUGO, LEYTE INSTITUTIONALIZING FUNDS THEREOF AND FOR OTHER PURPOSES.

ARTICLE I

Title, Policy, and Definition of Terms

SECTION 1. Title. This ordinance shall be known as the "Municipality of Barugo Youth Welfare and Development Code."

SECTION 2. Declaration of Policy.

- a) The Local Government recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, mental, emotional and social well-being and shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;
- b) The Local Government shall establish adequate, effective, responsive and enabling mechanism and support systems that will ensure the meaningful participation of the youth in local governance and nation building;
- c) The Local Government recognizes the vitality of youth involvement in the decision-making process on various issues affecting them and towards this end, shall ensure adequate and meaningful participation be afforded to them in both executive and legislative functions; and
- d) The Local Government recognizes the important role of the private youth organizations composed of various sectors and shall ensure that a rights based and economic based approach in development be integrated in the various processes and regulations of the Municipality.

SECTION 3. Definition of Terms. When used in this ordinance, the following words shall mean:

- a) **Adult Youth** - shall include all youth whose ages range from 25-30 years;
- b) **Barugon-ons** - refers to the People of Barugo
- c) **Child Youth** - shall include all youth whose ages range from 15-17 years;
- d) **Commission** - shall refer to the National Youth Commission or NYC whose main responsibility is to formulate policies, plan, implement, and oversee a national integrated youth promotion and development program;
- e) **Community-based Youth Organization** - refers to non-profit organizations that service a local community needs through volunteers, sponsorship, and donations;
- f) **Core Youth** - shall include all youth whose ages range from 18-24 years;
- g) **Council** - shall refer to Municipality of Barugo Local Youth Development Council or MBLYDC;
- h) **DILG** - shall refer to Department of Interior and Local Government;
- i) **Faith-based Youth Organization** - shall refer to a youth organization or youth-serving organization whose membership belongs to a certain religion or sect or religious belief;
- j) **In - School Youth** - refers to all youth of school age, whether organized or not, presently enrolled with any educational, vocational institution which include but not limited to the following school organizations (academic or non-academic), student government, fraternities and sororities;

- k) **Out-of-School Youth** - refers to all youth of school age, whether organized or not, who are unable to avail formal school system or who have dropped out from all levels of formal and informal education;
- l) **Political Rights** - are those rights which provide the youth the freedom to express themselves on matters affecting their lives;
- m) **School - Based Organization** – refers to a youth or youth - serving organization whose membership are students belonging to schools, universities or colleges legally recognized by the state;
- n) **MBYLA** - shall refer to Municipality of Barugo Youth Leadership Awards;
- o) **MBLYDC** - shall refer to Municipality of Barugo Local Youth Development Council;
- p) **BLYDO** – shall refer to Barugo Local Youth Development Office;
- q) **MBLJYO** – shall refer to Municipality of Barugo Local Junior Youth Official;
- r) **MBLYDP** - shall refer to Municipality of Barugo Local Youth Development Plan;
- s) **Working Youth** - shall refer to all youth whose ages range from 18-30 years who are employed either on a regular or temporary basis;
- t) **YORP** - shall refer to Youth Organization Registration Program;
- u) **Youth** – as defined in Republic Act 8044 otherwise known as The Youth in Nation Building Act of 1995, and for the purpose of this Code, it shall refer to those persons whose ages range from fifteen (15) to thirty (30) years old;
- v) **Youth Advisory Council** - refers to the body who shall oversee and monitor all programs of TCLYDC;
- w) **Youth Development Officer** - refers to the person duly appointed or designated by the local chief executive to serve as its agent in the Municipal with the task provided for in this ordinance or as may deemed necessary;
- x) **Youth - Serving Organization** – refers to registered, recognized, and accredited organizations whose primary objectives, programs and projects are youth-related and youth-oriented, and whose composition are not limited to the youth;
- y) **Youth Organization** – refers to any organization whose members are youth aged 15 to 30 years old; and
- z) **Youth with Special Needs** – refers to those youth who are suffering from restriction or different abilities as a result of a mental, physical, or sensory impairment to perform an activity in the manner or within the range considered normal for a human being.

ARTICLE II

Guiding Principles and Duties of the Youth

SECTION 4. Guiding Principles. Every Barugon-ons Youth shall be entitled to the rights herein set forth without distinction as to gender, social status, religion, political antecedents, and other factors:

- a) Every youth has the right to be informed of his inherent rights as stipulated in the Constitution and other related laws;
- b) Every youth has the right to bodily integrity and to the means necessary for the proper development of life, particularly food, clothing, shelter, medical care, rest, and the necessary social services;
- c) Every youth has the right not to be discriminated, intimidated, abused, bullied or humiliated despite of race, gender, ethnicity, belief, religion, and social standing;
- d) Every youth has the right to quality and responsive education from nursery to tertiary level, incorporating therein multicultural and multilingual curricula;
- e) Every youth has the right to freely and fully participate in the political processes and affairs of his/her community and country;

- f) Every youth has the right to economic development based on the precepts of justice and equity;
- g) Every youth right is coupled with a moral and legal obligation that must be fulfilled;
- h) Every youth has the right to exercise freedom of religion and be respected in his/her own set of beliefs;
- i) Every youth has the right to a decent job at a livable wage and provided with other additional compensations and benefits provided by laws; and
- j) Every youth is entitled to a mentally and emotionally healthy environment.

SECTION 5. Duties of the Youth. Every Barugon-on Youth regardless of the circumstances of his/her birth, sex, religion, social status, political antecedents, and other factors shall:

- a) strive to lead an upright and virtuous life in accordance with the tenets of his/her religion, the teachings of the elders and mentors, and the bidding of a clean conscience;
- b) love, respect and obey his/her parents, and cooperate with them in the strengthening of the family;
- c) if by reason of his/her studies or for other causes he/she does not live with his parents, the latter shall communicate with him/her regularly and visit them as often as possible;
- d) extend to his/her brothers and sisters his/her love, thoughtfulness, and helpfulness, and endeavor with them to keep the family harmonious and united;
- e) exert his/her utmost effort to develop his/her potentialities for service, particularly by undergoing a formal education suited to his/her abilities, in order that he/she may become an asset to himself and to society;
- f) respect not only his/her elders but also the customs and traditions of our people, the memory of our heroes, the duly constituted authorities, the laws of our country, and the principles and institutions of democracy,
- g) participate actively in civic affairs and in the promotion of the general welfare,
- h) always bearing in mind that it is the youth who will eventually be called upon to
- i) discharge the responsibility of leadership in shaping the nation's future; and
- j) help in the observance of individual human rights, the strengthening of freedom everywhere, the fostering of cooperation among nations in the pursuit of their common aspirations for programs and prosperity, and the furtherance of world peace.

ARTICLE III

Municipality of Barugo Local Youth Development Council

SECTION 6. Creation. To ensure wide and multi-sectoral youth participation in local governance, there shall be a creation of Municipality of Barugo Local Youth Development Council (MBLYDC) which shall be headed by the concerned Pambayang Pederasyon ng mga Sangguniang Kabataan President, co-chaired by the Pambayang Pederasyon ng mga Sangguniang Kabataan Vice- President and is composed of at least ten (10) but not more than nineteen (19) youth and youth-serving organizations. The MBLYDC shall assist in the planning and execution of projects and programs of its member organizations, the SK, and the Pederasyon;

- a) **Composition of the MBLYDC.** The MBLYDC shall be composed of 21 members including the 2 core members from the SK. The two (2) core members shall be composed of the President and the Vice-president of the Pambayang Pederasyon ng mga Sangguniang Kabataan and shall be supported by 19 other representatives from the various youth sectors – two (2) from Education; two (2) from

Environment; two (2) from Health; two (2) from Peace Building and Security; two (2) from Governance; two (2) from Global Mobility; two (2) from Social Inclusion and Equity; two (2) from Economic Empowerment; and three (3) from Active Citizenship:

Chairperson: SK Pederasyon President

External Vice Chairperson: SK Pederasyon Vice President

Internal Vice Chairperson: Elected Youth Organization Representative

Members: Eighteen (18) Elected Youth Organization and
Youth-Serving Organization

Secretariat: Municipal Local Youth Development Officer

- b) **Functions.** The MBLYDC Officers and Members shall perform the following functions:

The Council Chairperson shall:

1. Serve as the primary spokesperson of the MBLYDC;
2. Bear primary responsibility for the execution of all MBLYDC directives;
3. Determine the agenda of the meetings;
4. Preside the meetings of the MBLYDC;
5. Vote only in the event of a tie;
6. Keep the Council Officers apprised of all current business; and
7. Keep the Council members updated on all relevant issues.

The Council External Vice-Chairperson shall:

1. Assist the Council Chairperson in the fulfilment of his or her duties;
2. Assume the role of Council Chairperson in the event of the resignation, Impeachment, removal or ineligibility;
3. Have explicit knowledge of all youth-related laws, resolutions, and ordinances;
4. Represent the MBLYDC and council members at relevant
5. committee meetings that are not attended by the Council Chairperson; and
6. Attend any committee meetings that the President is required to attend but is unable to.

The Council Internal Vice-Chairperson shall:

1. Prepare the agenda prior to each weekly meeting subject to review and amendments by the Council Chairperson;

2. Facilitate the coverage of MBLYDC activities:
3. Have explicit knowledge of all youth-related laws, resolutions, and ordinances; and
4. Preside all meetings in the absence of council
Chairperson and Council external Vice-Chairperson.

The Council Secretariat shall:

1. Handle the administrative and technical activities of the council;
2. Supervise, direct and monitor the council
implementation of approved policies, plans and programs; and
3. Perform other functions as maybe provided by RA 10742.

c) **General Duties and Functions of the MBLYDC.** The MBLYDC shall discharge the following duties and functions:

1. Serve as the core of the advocacy on the ten (10) centers of youth participation in nation-building and youth empowerment;
2. Finalize the 3 (Three) year Municipality of Barugo Local Youth Development Plan that is anchored in the PYDP and the development plans in the Municipality of Barugo;
3. The Municipality of Barugo Local Youth Development Plan shall be initially drafted by the respective SK Pederasyon and shall be finalized by the MBLYDC. This shall be submitted to the Local Chief Executive for inclusion in the Local Development Plan and Annual Investment Plan (AIP) subsequently endorsed to the Sanggunian. These plans shall give priority to programs projects and activities that will promote and ensure the meaningful youth participation in nation building, sustainable youth development and empowerment, equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity, social protection, capability building and sports development;
4. Monitor and evaluate the implementation of the Local Youth Development Plan;
5. To formulate, adopt, and prescribe policies, guidelines, and rules and regulations that will guide the Municipal Planning and Development Office and Municipal Budget Office for the smooth operation of the BLYDO and MBLYDC;
6. To formulate and approve the internal rules and regulations of the Council including policies addressing representation, substitution, absence and delinquency of council members; and
7. Perform such other functions as may be provided by law or ordinances.

- d) **Qualifications of the Members of the MBLYDC.** A member of the MBLYDC must be a citizen of the Philippines, a resident of Barugo, Leyte for not less than one year immediately preceding the day of her/his election to the MBLYDC. She/he should be at least 15 years, but not more than thirty (30) years of age on the day of his/her election to the council, able to read and write, Filipino, English, or the local dialect and must not have been convicted by final judgment of any crime involving moral turpitude;
- e) **Manner of Election.** The BLYDO shall notify all the presidents or authorized representatives of the registered and accredited youth organizations and youth - serving organizations in the Municipality assemble them in a public venue, and by consensus or secret balloting per youth sector. These representatives shall serve for a term of three (3) years as members of the MBLYDC;
- f) **Convening of the MBLYDC.** Any of the Vice Chairpersons (External or Internal) with the concurrence of one another may call a meeting. The SK Pederasyon President, or in his/her absence, any of the Vice Chairpersons shall initially convene the council and shall be given preference to preside over the meeting;
- g) **Meetings and Quorums.** The MBLYDC shall schedule a meeting every quarter, or as often as needed. However, if the President, the External Vice President of the SK or the Internal Vice Chairperson fails to convene the MBLYDC as scheduled, at least one third of the total membership of the MBLYDC may call for a meeting. In both instances, a written notice shall be sent either through traditional or non-traditional means, to all members setting the date, time, place, and agenda of the meeting which must be received at least two (2) days in advance; and the presence of the majority (50% + 1) of all members of the TCYDC shall constitute a quorum.
- h) **Privileges of MBLYDC Members.** The MBLYDC members upon the discharge of all their duties shall receive a Quarterly honorarium of P 500.00 pesos only which shall be disbursed during the conduct of regular quarterly meetings.

SECTION 7. Institutionalization of Barangay Youth Development Council. In every barangay there shall be a youth development council which shall be headed by the respective Sangguniang Kabataan Chairperson to ensure multi-sectoral youth participation in every barangay.

SECTION 8. Municipality of Barugo Local Youth Development Plan. - A comprehensive plan for the youth formulated by the Barugo Local Youth Development Council in consultation with the Sangguniang Kabataan, youth groups, other government agencies, private sectors, and non-government organizations. Incorporated herein are the following, among others:

- a) Formulation, approval and implementation of the Local Youth Development Plan for the Barugo, Leyte youth for a period of Three (3) years and shall be reviewed and formulated a year before the end of its duration; and
- b) Programs and interventions on youth participation in sports; culture and the arts; leadership programs, locally, nationally and internationally; youth engagement in productive employment, education, livelihood services, cultural exchange, benchmarking and in gender development by laying down the necessary mechanisms and frameworks for policy direction, innovation and convergence.

SECTION 9. Local Youth Assessment Study. A local study on the "Progressive Monitoring and Situation of Youth in Municipality of Barugo," which identifies priority needs, prevailing attitudes and values of youth, existing services and gaps in the delivery of services of basic youth needs, which shall be done every five (5) Years thereafter;

SECTION 10. Funding. The MBLYDC programs, projects and activities shall be funded by the Local Government of Barugo subjected to Commission on Audit (COA) rules, policies and regulations.

ARTICLE IV

Municipality of Barugo Local Youth Advisory Council

SECTION 11. Creation. An Advisory Council shall be created to supervise and monitor the operation of the MBLYDC.

SECTION 12. Composition. The following shall be the members of the Municipality of Barugo Youth Advisory Council which shall shed light and advise the body on pertinent issues affecting the youth:

Chairperson : Local Chief Executive

Vice Chairperson: SK Pederasyon President

Members :

Municipal Planning and Development Officer

Municipal Social Welfare and Development Officer

Municipal Health Officer

Liga ng Mga Barangay Representative

Upon the approval of this ordinance, the Local Chief Executive shall issue an executive order stating specific names, and functions thereof.

SECTION 13. Roles and Responsibilities. The Municipality of Barugo Local Youth Advisory Council shall perform the following, to wit:

1. Review the operation plans and budget of the Council;
2. Provide reports and updates on all youth-related affairs and activities, including but not limited to plans, programs and projects intended for the youth sector of the Municipal;

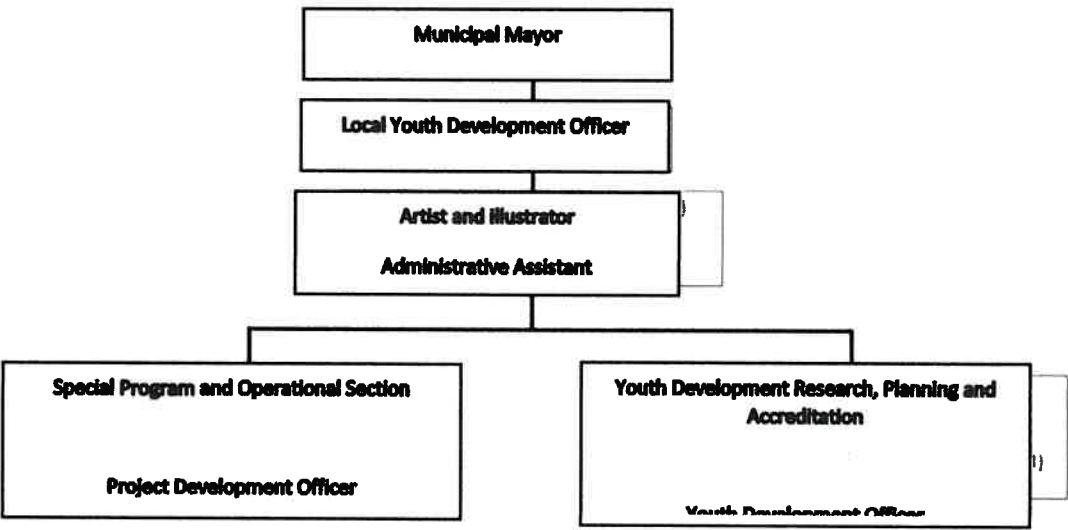
- 3. Coordinate with and recommend to the Municipal Local Youth Development Council strategies of implementation for a short, medium, and long-term youth development programs and activities of the Municipality; and
- 4. Recommend to the Municipal Local Youth Development Council the programs, projects, and activities (PPAs) for the youth based on the consolidated felt needs as discussed in the advisory council.

SECTION 14. Meetings. The Council shall meet once in every three (3) months or as often as maybe necessary, upon the call of its Chairperson or majority of its members, on important matters relating to youth affairs, welfare and development. The Barugo Local Youth Development Office shall serve as the Secretariat and shall provide technical support to the council.

ARTICLE V

Barugo Local Youth Development Office

SECTION 15. Creation. There shall be a Municipality of Barugo Local Youth Development Office which shall be headed by a Youth Development Officer with the rank of at least Division Chief. Such may be put under the Office of the Local Chief Executive, the Office of the Planning and Development, the Office of the Social Welfare, or in any other office deemed appropriate by the local government unit. If the fund of the local government unit are sufficient, it can be a separate department with divisions and unit for policy and planning, administration and finance, and programs and operations. In the event when the local government unit has exceeded the prescribed personal services limitations, the local chief executive may designate existing personnel whom he or she deems fit to serve this purpose until such time that the local government unit can already create this office (RA 10742).



- a) **Qualifications of the Local Youth Development Officer.** In addition to the requirements prescribed by the Civil Service Commission and reasonable standards set by the Human Resource Office, the Youth Development Officer and other staff of the office must meet the following qualifications:
 - 1. be a Filipino citizen;
 - 2. be of legal age at the time of the appointment;
 - 3. be preferably not more than thirty years of age at the time of his/her appointment;
 - 4. be of good moral character;

5. have acquired experience in youth development affairs or involvement in youth or youth-serving organizations for at least three (3) years; and shall be appointed by the Local Chief Executive, but in no case is he or she be within the fourth civil degree of consanguinity or affinity of the appointing authority.

Functions of the BLYDO Staff. The following staff and their functions shall comprise the Municipality of Barugo Local Youth Development Office:

One (1) Youth Development Officer IV (SG – 22) shall have the

following functions:

1. Directs all operations of the Office;
2. Establishes procedures for the effective operation of the Office;
3. Submits to the Local Chief Executive rules and regulations, and other guideline adopted by the Office and approved by the Council, which would require the Local Executive's attention including annual and periodic reports;
4. Prepares and submits the annual and supplemental budgets of the Office following existing budgetary rules and regulations;
5. Subject to the approval of the Local Chief Executive and recommendation from the Council, arrange for donations, grants, gifts, and to implement sports plans, programs, and policies;
6. Performs such other functions as may be assigned by the office of the Local Chief Executive or the Council;
7. Represents Municipality of Barugo in any regional, national or international forum, meeting and functions related to youth development together with other youth representatives from the council; and
8. Submits Individual Performance Commitment and Review (IPCR) with Monthly Performance Output Report (MPOR) and IPCR Target every semester.

One (1) Artist Illustrator III (SG – 11)

1. Prepares publicity materials and graphic works as needed in the implementation of all TCLYDO programs and activities;
2. Plans concept by studying information and materials provided;
3. Illustrates concept by designing layout of art and copy regarding arrangement, size, type size and style, and related aesthetic concepts;
4. Obtains approval of concept by submitting layout for approval by the Youth Development Officer IV;
5. Prepares finished copy and art by operating typesetting, printing, and similar equipment;
6. Prepares final layout by marking and pasting up finished copy and art;
7. Completes publicity material projects by coordinating with TCLYDO personnel, programs partners and involved key stakeholders;
8. Maintains technical knowledge by attending design workshops; reviewing professional publications; and participating in professional societies;
9. Contributes to team effort by accomplishing related results as needed; and
10. Performs other duties within capabilities and/or consistent with the level of this position as required; and
11. Submits Individual Performance Commitment and Review (IPCR) with Monthly Performance Output Report (MPOR) and IPCR Target every semester.

One (1) Administrative Assistant (SG – 8) shall have the following functions:

1. Performs administrative and office support activities for the Division;
2. Performs administrative duties which may include fielding telephone calls, receiving and directing visitors, word processing, creating spreadsheets and presentations, and filing;
3. Manages and distributes information within the Division;
4. In-charge of receiving and sending correspondence from and to other Offices;
5. Drafts messages for the Division Head;
6. Schedule appointments of the Division Head;
7. Performs other functions as may be assigned by the supervisor; and
8. Submits Individual Performance Commitment and Review (IPCR) with Monthly Performance Output Report (MPOR) and IPCR Target every semester.

SPECIAL PROGRAMS AND OPERATIONS SECTION

One (1) Project Development Officer who shall act as the

Special Programs and Operations Focal and shall have the following functions:

1. Mobilizes program resources and timeline of activities to achieve desired objectives;
2. Develops program reports, formulate proposals and policies and devise strategies to ensure the implementation of community development programs;
3. Plan, attend and coordinate meetings when necessary;
4. Performs other duties within capabilities and/or consistent with the level of this position as required;
5. Design, devise and expand training and development programs and strategies based on the needs of the organizations and concerned stakeholders;
6. Create, manage and produce training materials for in-house youth leadership courses;
7. Performs all duties incidental to the office and those that may be delegated or assigned to her/him by the Youth Development Officer IV; and
8. Submits Individual Performance Commitment and Review (IPCR) with Monthly Performance Output Report (MPOR) and IPCR Target every semester.

YOUTH DEVELOPMENT RESEARCH, PLANNING AND ACCREDITATION SECTION

One (1) Development Management Officer who shall act as

the Development Research, Planning and Accreditation Focal and shall have the following functions:

1. Conducts regular accreditation promotion and facilitate the accreditation process as provided for by this ordinance;
2. Develops and implements a comprehensive and effective communications plan for and within the office which shall take into consideration the enhancement of youth participation and involvement in nation-building, promotion of values, and deliberation of pertinent youth-related issues;
3. Conducts all youth development research and formulation of program plans as required by the Youth Development Officer IV or the LCE;
4. Disseminates incoming opportunities for collaboration & participation with organizations and community partners in a timely manner;
5. Provides direct input into the development of program partnership plans and policies;

6. Enhances external linkages and maintain positive relations among private and non-government institutions;
7. Performs other duties within capabilities and/or consistent with the level of this position as required; and
8. Submits Individual Performance Commitment and Review (IPCR) with Monthly Performance Output Report (MPOR) and IPCR Target every semester.

SECTION 16. Accreditation/Registration. Only those youth and youth-serving organizations which is registered in YORP shall be accredited by the accreditation committee.

- a) **Local Registration of Youth Organization and Youth - Serving Organization.** All youth organization and youth - serving organizations, with a minimum of active ten (10) members in good standing and which are operating in Municipality of Barugo shall be registered in YORP Registration in the Barugo Local Youth Development Office;
- b) **Local Verification of Youth Organization and Youth - Serving Organization.** The Municipality Local Youth Development Officer shall verify the registration information provided by these organizations. The officer shall then send a list of registered and verified youth organizations and youth - serving organizations to the National Youth Commission or NYC;
- c) **Requirements for Registration and Accreditation.** The requirements for accreditation/registration to the Council are as follows;
 1. Endorsement Letter/ Certification;
 2. Duly accomplished Registration Form;
 3. Constitution and By-Laws;
 4. List of current officers and members with their residential mailing addresses;
 5. List of Officers and Advisers
- d) **Renewal, Verification and Continuing Local Registration.** Registered youth and youth serving - organizations shall renew their local registration and verification every three years. The MBLYDO shall conduct a continuing registration procedure taking into consideration the budgetary and manpower requirements and the presence of youth and youth-serving organizations;
- e) **Condition Precedent.** Local registration and verification of youth organization and youth - serving organization is a condition precedent for participation in the MBLYDC elections. However, if a youth organization or youth-serving organization is denied local registration and verification, such organization can apply for special registration and verification to the National Youth Commission as provided for by law. Such special registration and verification entitle the organization to participate in the MBLYDC elections;

SECTION 17. Subsidy to Accredited Youth Organizations. The accredited youth organizations shall be subsidized amounting to not less than 1% of the total budget of the LYDC every year for the operationalization of programs and activities provided that they shall comply with the guidelines set by the Accreditation Committee.

SECTION 18. Non-Partisan Nature of the MBLYDO. The Municipality of Local Youth Development Office shall not allow itself to be used for the purposes of partisan politics and shall adopt measures to ensure that it is adequately shielded from any political partnership or influence.

SECTION 19. Funding. In pursuant to R.A. 11768, Section 11. the revision of the Section 27 of the RA 10742 States that the local government unit may appropriate not less than one percent (1%) of its annual budget for the Local Development Office, which shall be used for the implementation of the LYDP, convening the meetings of the concerned Pederasyon ng mga Sangguniang Kabataan and LYDC, as well as its operations and effective functioning and in accordance with the COA accounting and auditing rules and regulations.

ARTICLE VI Programs for the Youth

SECTION 20. General Framework. All youth policies shall be anchored to the Ten (10) centers of participation stipulated in the Philippine Youth Development Plan and Barugo Youth Development Plan.

SECTION 21. Education. The Local Government Unit shall increase and improve youth participation in education and shall improve educational quality and performance through the following programs:

- a) **Alternative Learning System (ALS).** The Local Government Unit of Barugo shall encourage less fortunate and out-of-school youth (OSY) earn their basic education diploma through Alternative Learning System (ALS);
- b) **Provide Educational Gadgets and WIFI** - The Local Government Unit of Barugo shall give students educational and strong internet connections that they can access in the new learning modality.
- c) **Provide Accessible Educational Facilities/ Equipment / Materials including those in the Online and /or Modular Distance Learning** - the Local Government Unit must improve the accessibility to education facilities, equipment and materials to avail easy access to educational facilities and materials.
- d) **Youth Scholarship Programs.** The Local Government Unit of Barugo through the Public Education Employment Services Office shall provide scholarship programs to deserving youth such as Municipal Educational Scholarship Program (CESPRO), Municipal Vocational Technical Educational Assistance Program (CIVOTESPRO), and Sulong Dunong Scholarship Program which will give the youth an opportunity to earn a four-year degree courses, technical – vocational certifications that will help them uplift their socio-economic status;
- e) **Free Printing and Computer Services** -The Local Government Unit of Barugo through the Local Youth Development Office shall provide assistance in printing and use of computer. To aid students' financial problem in paying volume of documents need to passed in school.
- f) **Special Education.** SPED centers and schools shall be encouraged in the Municipality of Barugo for the benefit of youth with special needs, and shall provide the needed support and assistance to capability building activities of SPED teachers;
- g) **E-Library** – The Local Government of Barugo shall provide a facility and shall be maintained by the Local Youth Development Office.
- h) **Basic Literacy Program.** The Local Government Unit of Barugo shall promote Basic Literacy Program to eradicate illiteracy among OSY and underprivileged youth by developing basic literacy skills of reading, writing and numeracy and provide space for enriching cultural education;
 1. **Project L.E.T.R.A (Lifting Education Through Reading Activities).** It is a fifteen (15) day learning camp and reading intervention intended for high school learners with reading difficulties endorsed by different public schools in

Municipality of Barugo in which teachers and volunteers are education students from Colleges and Universities in the Municipal.

2. **i-LEARN Boot Camp.** It is an activity which aims to address the multiple Intelligences specifically in performing arts of the Barugon-ons Youth like hosting, dancing, singing, drama and theater arts through a series of seminar workshops.
3. **Balik Eskwela Program.** A program of the Local Government Unit of Barugo that aims to provide school supplies for underprivileged students in Municipality of Barugo.

SECTION 22. Environment. The Local Government Unit of Barugo shall strengthen youth participation in environmental protection through the following programs:

- a) **Bangon Kalikasan Program (Tree Growing, Coastal Clean Up and Synchronize Bayanihan Drive).** The Local Government Unit of Barugo shall encourage the youth in their involvement to environmental actions such as Tree Growing Activities, Coastal Cleanup, and Synchronize Bayanihan Drives that aims to inculcate to the youth the practice of environmental awareness and care;
- b) **Conduct IECs on proper waste** - The Local Government Unit shall ensure the equip the youth on R.A. 9003 (Ecological Solid Waste Management Act) to discipline the youth regarding the proper waste disposal in the community
- c) **Disaster Risk Reduction Preparedness and Mitigation.** Recognizing the vital role of the youth in disaster preparedness, prevention, and mitigation, the Local Government Unit of Barugo through the Municipal Disaster Risk Reduction Management Office shall provide avenue adequate training and capability building for the youth in response to relevant emergencies in the community;
 1. **Junior Youth Responders.** A YORP and locally accredited organization that focuses on emergency responses, a youth-wing of the Municipality Disaster Risk Reduction Management Council that empowers the youth to provide training in the Barangay Level and to respond in emergencies like natural emergency, accidents, and medical emergencies.

SECTION 23. Health. The Local Government Unit of Barugo shall ensure youth participation in strengthening and addressing health and psycho-social concerns through the following programs:

- a) **Youth Medical Services.** The Local Government Unit of Barugo shall endeavor free, if not, affordable but reliable medical services in local public hospitals and health centers. The Local Government Unit of Barugo shall give due acknowledgement to private hospitals and medical service providers in Municipality of Barugo that will render free medical services to Barugo-ons youth;
- b) **Conduct symposium on Mental Health and Suicide Prevention** - The Local Government Unit must aim to decrease the number of youths committing suicide. To remove circumstances which can lead to children and young people taking their lives and identity early factors and attempt to break stigmatized trends of suicide and attempted suicide in target groups.
- c) **HIV/ AIDS Awareness and Prevention Campaign** - The Local Government Unit must conduct a massive information on values-based sexuality education, how to prevent HIV/AIDS with the observance of HIV/AIDS awareness month. Promotion and provision service such as counselling and STI/HIV/AIDS management and Health facilities in order to reduce the rate of infection and provide care and support for the people living with HIV/AIDS and their families.
- d) **Health Education for the Youth.** The Local Government Unit of Barugo shall join and support the National Government in providing age and development appropriate reproductive health education to the youth which shall be taught by

adequately trained teachers, informal and non-formal educational system, and integrated in relevant subjects such as, but not limited to, values formation, knowledge and skills in self-protection against discrimination, sexual abuse and violence against women and children and other forms of gender-based violence and teen pregnancy, physical, social and mental changes in adolescents, women's rights and children's rights, responsible teenage behavior, gender and development, and responsible parenthood;

- e) **Teen Tambayan.** The Local Government Unit of Barugo shall institutionalize the Teen Tambayan in each Barangay to intensify the social development programs for the youth amid various issues that would establish and strengthen the community-based teen centers and continuous implementation of sports and development programs to be facilitated by the Sangguniang Kabataan in coordination with Barangay Health Worker and shall be supervised by the Municipal Health Office;
- f) **Youth Sports Program.** The Local Government Unit of Barugo shall strengthen physical and sports activities for the children and youth so as to ensure their active involvement in sports and development including sports organized in school or out of school educational system, whether formally or informally organized;
- g) **Youth Health Volunteers.** The Local Government Unit of Barugo shall provide avenue for young medical practitioners or health volunteers to render voluntary works in times of humanitarian needs.
- h) **Conduct of IECs on the ill-effects of excessive drinking of alcohol and cigarette smoking -** The Local Government Unit shall conduct a series of activities and seminar to decrease the youth going into excessive alcoholic drinks and cigarette smoking.

SECTION 24. Peace Building and Security. The Local Government Unit of Barugo shall strengthen youth participation in promoting peace and order through the following programs:

- a) **Safe and Sustained Police and Civilian Visibility.** Safe and sustained police and civilian visibility in the barangays are keys in protection and prevention of youth from becoming victims of crimes and violence at the grassroots level. Round the clock patrol of policemen assigned in community precincts together with barangay authorities and volunteers shall be made in every barangay in order to protect the Barugon-ons Youth;
- b) **Youth Rehabilitation Assistance.** The Local Government Unit of Barugo abhors all forms of illegal narcotics, but not the victim end-users. Youth victims of drug abuse shall be treated with care and supervision by the barangay where they belong through various intervention programs prior to their reintegration to the community;
 - 1. **Barugo Against Drugs (BADs).** A long-term program of the Local Government Unit of Barugo surrenderers in including the youth which will provide a series of intervention and constant checking and counseling. This program aims to integrate the surrenderer back to the community and provide a sustainable source of living for the youth.
 - 2. **Boys and Girls Rescue Center - Children in Conflict with the Law (CICL), Sagop Bata Quick Action Team (SBQAT).** A proactive response of the Local Government Unit of Barugo that rescues child youth from possible harm and provide them temporary shelter in a therapeutic environment;
 - 3. **Moral Recovery Program.** Mandated under Section 444 of RA 7160 also known as local Government Code of 1991, the Local Government Unit of Barugo strengthened this program by providing moral resources cognizant to the resiliency of the National Government to affect moral recovery through the retreat and recollection program provided by the Spiritual and Values Education Section of the Local Government Unit of Barugo;

4. **Barangay Youth Peacekeeping Program.** A youth barangay-based response program focuses on the peace building initiatives with the Sangguniang Kabataan officials of each barangays.

SECTION 25. Governance. The Local Government Unit of Barugo shall promote youth participation in government and bureaucracy with the following programs:

- a) **Mandatory and Continuing Training for SK Officials and MBLYDC.** For the purpose of emphasizing the role of the youth in nation-building and molding them to become better citizens with the values of patriotism, nationalism and honor as a Filipino, SK official, whether elected or appointed and members of the MBLYDC must undergo mandatory training programs.
 - b) **Barugo Youth Parliament.** The Local Government Unit of Barugo, in recognition to the vital role of the youth in nation-building and perform their civic and political rights shall provide an avenue for the youth to discuss youth issues/concerns anchored on the Barugo Youth Development Plan and develop young policymakers in the Municipality aged 15-30 years old in addressing the concerns and agenda of the youth;
 - c) **Barugo Junior Youth Officials.** The Local Government Unit of Barugo shall provide opportunity for the youth aged 15-17 years old to gain first-hand knowledge of government functions as related to community problems and development;
 - d) **Barugo Youth Leadership Award.** The Local Government Unit through the Local Youth Development Office shall provide an opportunity for the youth to recognize the outstanding youth leaders and organizations duly registered in Youth Organization Registration Program (YORP) of the National Youth Commission (NYC) in the Municipality that have distinguished themselves by their exemplary achievements in various fields and have contributed positively to Barugo, Leyte social development thrust and core values' development, honor, and glory;
 - e) **Barugo Youth Leadership Academy.** The Local Government Unit of Barugo shall create a course and a module for effective leadership that will include the topics on planning, group management, people relations, and the like that will cover six (6) months of formal schooling that will be done every Saturday;
 - f) **Representation of Youth in Special Bodies.** The Local Government Unit of Barugo shall ensure youth participation in local government councils, bodies or board to effectively represent the interest and sentiments of youth;
 - g) **Participation of the Youth in Legislation.** The Sangguniang Panlungsod of Barugo and their committees, in the conduct of hearings in aid of legislation, shall always invite and solicit the comments and opinions of youth organizations;
 - h) **Youth Desk.** The Local Government Unit of Barugo will set up a Youth Desk that will help the youth in all youth-related concerns and problems, as well as facilitate delivery of youth-related programs and activities of the Municipality;
 - i) **Youth Relations Officer and Police Procedures.** The Municipality of Barugo Police Office shall assign a Youth Relations Officer who will be tasked to handle cases involving the youth;
 - j) **Political Views of the Youth.** Considering the increased involvement of youth worldwide in mainstream political discussions over the last four years from gun violence activists to climate justice advocates and young individuals running for office. The youth shall freely express their concerns on various political topics/issues. We believe the right to be free from government censorship applies to everyone regardless of age;
 - k) **Youth Voter's Education Program.** The Local Government Unit of Barugo shall facilitate the youth on voters' registration and implement an education campaign to encourage active participation in both local and national elections;
1. **Youth Mainstreaming.** Youth Mainstreaming shall be enforced to engage youth as partners throughout every part of an organization to promote efficacy, equity and

empowerment for everyone involved. It's the active, visible engagement of youth throughout the entirety of a defined institution;

SECTION 26. Active Citizenship. The Local Youth Development of Barugo shall strengthen enabling mechanisms for youth organization and participation through the following programs:

- a) **Barugo Youth Festival.** In accordance with the Barugo, Leyte Code of Festivals, the Local Government Unit of Barugo shall have an annual gathering of Barugo-ons youth from ages 15 to 30 years old where they can participate and showcase their talents and potentials in art, music, dance, sports and academics, at the same time giving recognition to the outstanding youth and youth organizations, passionate in promoting self-improvement through leadership, training and nation building. This festival is celebrated every month of May;
- b) **Youth Organization Registration Program (YORP).** Pursuant to RA 8044 known as the Youth in Nation Building Act of 1995, the National Youth Commission is mandated to have a registry of youth organizations nationwide. The Local Government Unit of Barugo shall assist youth and youth - serving organizations in the registration to the Youth Organization Registration Program of the National Youth Commission;
- c) **Observance of Linggo ng Kabataan.** The Local Government Unit of Barugo shall conduct an annual activity to be known as Linggo ng Kabataan on the week where the 12th of August falls to coincide with the International Youth Day;
- d) **Youth Volunteer Program.** The Local Government Unit of Barugo shall maintain a pool of youth volunteers which helps mobilize the programs and activities of the Local Government Unit of Barugo in youth development programs, projects, and activities;
- e) **Youth Leadership Summit.** The Local Government Unit of Barugo shall implement one stop shop leadership training for the youth that gives more emphasis on becoming responsible, and proactive citizens that advocates for the government's peace and development initiatives;
- f) **Scouting Program.** The Local Government Unit of Barugo shall encourage the physical, intellectual, social, emotional, and spiritual development of young people so that they take a constructive place in society as responsible citizens, and as a member of their local, national, and international communities.

SECTION 27. Global Mobility. The Local Government Unit of Barugo shall promote youth participation in cross border activities through the following programs;

- a) **Inter-Cultural Exchange Programs.** The Local Government Unit of Barugo shall provide an opportunity for the youth to learn and understand the global context that fosters harmonious international relationship and peace among different cultural perspective;
- b) **Youth Trafficking.** The Local Government of Barugo shall strengthen and establish programs related to child and youth trafficking as instituted in RA 9208 also known as Anti-Trafficking in Persons of 2003 that signifies to prevent, protect, suppress, and punish trafficking in persons, especially women, child and youth;
- c) **Sustainable Development Goals (SDGs).** The Local Government Unit of Barugo shall raise awareness about the 2030 Agenda for Sustainable Development among youth, build a platform for discussion, and create the conditions for active engagement.

SECTION 28. Social Inclusion and Equity. The Local Government Unit of Barugo shall promote inclusive and prosocial participation of youth through the following programs;

- a) **Youth with Specific Needs.** The Local Government Unit of Barugo shall provide opportunities for youth who are suffering from restriction or different abilities as a result

- of a mental, physical, or sensory impairment that will promote their physical and morale well-being;
- b) **Conduct of symposium and IEC's on related laws pertaining to CICL, CAR delinquently youths and youth offenders** - the Local Government Unit of Barugo shall ensure to decrease cases of delinquents, youth offenders CAR and CICL .
 - c) **Anti-Discrimination towards Youth.** The Local Government Unit of Barugo shall endeavor to stop all forms of discrimination on basis of youth disability, age, health, sexual orientation, gender identity, ethnicity and religion;
 - d) **Compliance with Accessibility Law.** The Local Government Unit of Barugo shall ensure compliance of government and private establishments and offices of the Accessibility Law for the benefit of the special youth, together with the elderlies and pregnant;
 - e) **Youth Gender and Development.** The Local Government Unit of Barugo shall implement gender sensitivity and awareness programs for the youth.

SECTION 29. Economic Empowerment. The Local Government Unit of Barugo shall optimize and strengthen youth participation in entrepreneurial activities and employment enrichment through the following programs;

- a) **Youth Entrepreneurial and Livelihood Programs.** The Local Government Unit of Barugo, through the various local agencies, shall provide the unemployed, undergraduate and out-of-school youth (OSY) highly employable skills training and non-formal courses, and livelihood trainings geared towards empowering the youth for sustainable livelihood and employment;
- b) **Youth Agricultural Program.** The Local Government Unit of Barugo through the Municipal Agriculture Office shall provide programs for the youth that engage in food production;
- c) **Youth Financial Literacy Program.** The Local Government Unit of Barugo shall promote the youth to becoming financially literate and equips them with knowledge and skill that allow them to strategically manage, save and invest their money;
- d) **Youth Employment Programs.** The Local Government Unit of Barugo, through the Public Education Employment Services Office (PEESO), shall establish linkages with the private sector and companies for diverse job opportunities for the youth seeking for employment such as working youth, single and solo parents, etc.:
 - 1. **PESLA. A Pre-employment Seminar** for Local Applicants provides job seekers in the region better employment opportunities, both local and overseas;
 - 2. **Job Start.** A program of the Department of Labor and Employment adapted and implemented in the Municipality of Barugo by providing life skills and technical skills required by industries that enhances the employability of the youth by reducing their job-search and increasing their employability through training, paid internship and full cycle employment facilitation services;
 - 3. **Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD).** A community-based package of assistance that provides emergency employment for displaced workers, underemployed and seasonal workers, for a minimum period of 10 days, but not to exceed a maximum of 30 days, depending on the nature of work to be performed;
 - 4. **Special Program of the Employment of Students (SPES).** A program of the Department of Labor and Employment facilitated through the Public Education Employment Services Office of the Local Government Unit of Barugo which aims to provide temporary employment to poor but deserving students, out-of-school youth, and dependents of displaced or would-be displaced workers during summer and/or Christmas vacation or any time of the year;

5. **Government Internship Program (GIP).** A government run program that aims to employ youth. GIP is a 3- 6-month internship opportunity for youth aged 18-30, who are in high school or technical vocational institutes, college graduates and out of school youth to pursue work in the public service sector, both local and national government units. GIP serves as a training ground for future government employees. It aims to create a competitive and experienced workforce.

SECTION 30. Other Programs for the Youth. The Youth Advisory Council has the authority to integrate youth development programs and allocate funds as may deemed necessary.

ARTICLE VII Monitoring and Evaluation Mechanisms

Section 31. Monitoring, Evaluation and Oversight Mechanisms. The Local Government Unit of Barugo shall establish, enhance, strengthen, and maintain a youth development Monitoring & Evaluation (M&E) System. In establishing and/or strengthening the M&E system, the local chief executive shall issue an Executive Order or Administrative Order creating the M&E Team which shall monitor the implementation of the annual budget of Barugo Local Youth Development Office, Municipality of Barugo Local Youth Development Council, and Sangguniang Kabataan. It shall prepare annual status reports on the institutional mechanisms for youth development mainstreaming. The M&E Team shall also evaluate the outcomes of the Municipal's youth development policies, programs and projects, and report the same to the Local Chief Executive.

ARTICLE VIII Final Provisions

Section 32. Issuance of Implementing Rules and Regulations (IRR). The Local Chief Executive shall formulate and issue rules and regulations for the efficient and effective implementation of any article or provisions of this code. The no issuance of the rules and regulations shall not in any manner forestall the effectivity and implementation of this code.

Section 33. Appropriations. To effectively implement this Ordinance, Youth Development Fund shall be appropriated annually under the General Appropriation to cover specific programs for the youth sector.

Section 33. Separability Clause. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

Section 34. Repealing Clause. All ordinances, local issuance or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 35. Effectivity Clause. This Ordinance shall immediately take effect upon approval.
