REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is generally in accordance to its power under Section 447(a)¹ and (a)(1)(iii)² of the Local Government Code of 1991 (R.A 7160). However, it is recommended that the clerical errors "Cluse" and "Repeling" found on Section 11, 12 and 13 of the same Ordinance be corrected accordingly. Hence, we recommend for the declaration of its validity subject to corrections of the clerical errors.

Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.



A RESOLUTION ENACTING ORDINANCE NO.4, S.2025



AN ORDINANCE ESTABLISHING THE "LUNGSOD NGA AMONG NATAWHAN" AS THE OFFICIAL HYMN OF THE MUNICIPALITY OF VILLABA, LEYTE, AND PRESCRIBING ITS MANDATORY SINGING IN OFFICIAL AND FUNCTIONS OF ALL PUBLIC AND PRIVATE INSTITUTIONS IN VILLABA, LEYTE AND FOR OTHER PURPOSES

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 mandates LGUs to ensure and support, among other purposes, the preservation and enrichment of their culture;

WHEREAS, there is an indispensable need to declare and adopt the song "Lungsod nga Among Natawhan" as the official hymn of the Municipality in order to foster among its people sense of identity, self-esteem and pride being a resident of Villaba, Leyte;

WHEREAS, "Lungsod nga Among Natawhan "aims to preserve and uphold the citizens' unique identity as Villabanons and thus, this hymn represents a patriotic symbol that carries our history, struggles and victories as a town;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Villaba, Leyte, in regular session assembled that;

<u>ARTICLE - I</u>

GENERAL PROVISION

TITLE, SCOPE AND DEFINITION OF TERMS

SECTION 1. SHORT TITLE. This ordinance shall be known as, the "VILLABA HYMN ORDINANCE" in the Municipality of Villaba, Leyte.

SECTION 2. SCOPE. This ordinance shall be enforced during all official and formal functions, activities and programs held within the territorial jurisdiction of the Municipality of Villaba.

- a. Official Hymn shall refer to a song, entitled "Lungsod nga Among Natawhan", written and arranged by Mr. and Mrs. Christoper & Josefa Lipon;
- b. Official & Formal functions, activities and programs Any event or occasion conducted within the territorial jurisdiction of the Local Government Unit of Villaba that involves the general public as participants or audiences.

ARTICLE - II

REGULATORY PROVISION

SECTION 4. OFFICIAL LYRICS. The "Lungsod nga Among Natawhan" must always be sang in original language (Cebuano) in which it was compose:

SECTION 5. RHYTHM OF THE OFFICIAL HYMN – the "Lungsod nga Among Natawhan", shall have a rhythm in two – fourth (2/4) beat;

SECTION 6. SINGING OF THE OFFICIAL HYMN – the "Lungsod nga Among Natawhan" shall be sang after the singing of the National Anthem and during official and functions, activities and programs conducted within the Local Government Unit of Villaba; while singing the official hymn, all persons shall stand in attention, with the hands down.

SECTION 7. IMPLEMENTING OFFICE – the Office of the Municipal Tourism shall be tasked to carry out the implementation of the provision of this ordinance. It shall be responsible in the circularizing and enhancement of the musical arrangement of the hymn, including audio-visual and cinematographic of the official hymn. Further, digital or video copies shall be distributed to all schools and to the thirty-five (35) barangays.

To fully implement the use of the official hymn, the rights and ownership reserved to the composer shall be transferred to the Local Government Unit of Villaba.

SECTION 8. PROHIBITED ACTS ON THE USAGE OF THE HYMN — it shall be prohibited to:

- a. By any act to change the lyrics and rhythm of the official hymn with the intention to dishonour or ridicule the official hymn;
- b. To sing or play the official hymn for mere recreation, amusement, or entertainment purposes, either in the stage or social media sites;
- c. To display the official hymn whether its title or lyrics for business purposes;
- d. To print, paint or attach the lyrics whether full or partial on any articles of merchandise, except upon for LGUs government official representations;
- e. To use the official hymn for political activities or for election propaganda;
- f. To be used by any individual, organization or association whether for legitimate purpose, except approved by the local government unit of Villaba;
- g. To plagiarize the lyrics of the Official Hymn;
- h. Any other circumstances of a similar acts analogous to those above mentioned.

SECTION 9. MODIFICATION IN THE LYRICS OF THE MUNICIPAL HYMN – the official hymn shall not be modified, unless:

- a. By enactment of an ordinance modifying the same;
- b. Any modification shall be made upon the recommendation of the Culture and Arts Board and only once every ten (10) years, unless otherwise provided by law or ordinance.

ARTICLE III PENAL PROVISIONS

SECTION 10. PENALTY – Any person or persons who by acts or omission violates the provision this ordinance shall be penalized by:

- 1. First Offense...... Reprimand
- 2. Second Offense..... Php. 1,000.00
- 3. Third Offense...... Php. 2,500.00 or an imprisonment of not less than one (1) month nor more than six (6) months or both at the discretion of the court.

ARTICLE IV - FINAL PROVISION

SECTION 11. SEPARABILITY CLUSE. Any provision held to be invalid or declared unconstitutional, all other provisions hereof which are not affected thereby shall continue to be in full force and effect;

SECTION 12. REPELING CLUSE. All ordinance, rules and regulations or parts thereof inconsistent with or in conflict with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY CLUSE. This Ordinance shall take effect ten (10) days after it has been posted in two (2) conspicuous places and publication in a newspaper of general circulation.

The hearing started when the majority of the invited persons personally appeared and was presided over by the concerned SB Committee Vice-Chair. The Hon. Inopiquez began by greeting everyone present. Hon. Inopiquez explained that the purpose of the committee hearing was for the passage of the ordinance institutionalizing "Lungsod nga Among Natawhan" as the official hymn of Villaba. The author presented the ordinance, and Hon. Inopiquez asked the composer about his inspiration for the hymn. The author explained that as a former ALS Coordinator assigned here in Villaba, he experienced the warmth, welcoming nature, respect, and talent of the people. He further emphasized that Villabanons are passionate about life.

Mr. Lolito Devota inquired whether the word "hingyap" is a Cebuano or Waray-Waray word. Mrs. Marquez responded that the meaning of "hingyap" is hope or being hopeful. The author clarified that "hingyap" in Waray-Waray means aspiration, while in Cebuano, it means to hope. The Vice Mayor also commented on the word "Mabulokon," asking if there were other words for it. The author stated that it is indeed the correct term to use.

Following the discussion, the composer played the hymn for any corrections or suggestions.

There were no other concerns raised. Mr. Ronie Lucañas moved to adjourn the meeting, and the motion was seconded by Mr. Edmondo Albacite.

The hearing adjourned at 3:45 in the afternoon.
