#### PREFATORY STAMENTS

Katuwang sa Diwa at Gawa para sa Masaganang Ani at Mataas na Kita (KADIWA) was launched and spearheaded by the Department of Agriculture (DA) in 2019 in collaboration with farmers and enterprises registered in the Sagip Saka Registry System for Basic Sector Agriculture (RSBSA) which seeks to empower the community by providing a direct and effective farm-to-consumer, food supply chain. The implementation of this program is reiterated by President Ferdinand Marcos, Jr. during his State of the Nation Address (SONA) citing "The KNP system has enabled the public to buy goods at cheaper rates and the farmers to sell their crops without having to worry about transportation cost."

The One Town, One Product (OTOP) is the priority stimulus program for Micro, Small and Medium - Scale Enterprises (MSMES), as government intervention to drive inclusive local economic growth. Thru the leadership of Department of Trade and Industry, OTOP enables localities and communities to determine, develop, support and promote products or services that are rooted in its local culture, community resources, creativity, connection and cooperative advantage.

The revival of the KADIWA food terminal shall be a big step towards providing for our citizens in depressed areas and, further sparking awareness, particularly, of which may spread towards the involvement of local farmers and large enterprises in production of these basic commodities.

In conformity with the foregoing information, the Local Government Unit of Villaba, Leyte, shall conduct the Kadiwa ng Pangulo (KNP) in the Municipality, THUS

Be it ordained, as the Sangguniang Bayan in regular session assembled hereby ordained, that:

**Section 1. SHORT TITLE.** – This legislative enactment shall be known as "The Kadiwa ng Pangulo (KNP) Ordinance of the Municipality of Villaba."

Section 2. OBJECTIVES. – This Ordinance is aimed to uphold the implementation of Kadiwa ng Pangulo in this Local Government with the assistance of the Department of Agriculture (DA), Department of Trade and Industry (DTI), Department of Labor and Employment (DOLE), Department of the Interior and Local Government (DILG) and other concerned agencies and sectors in the community.

The activities involved in this nation-wide government program shall be geared towards its goal through the execution of the following objectives, to wit:

- 1. To increase participation of local farmers and enterprises as well as consumers to KNP;
- 2. To ensure food security, delivery of nutritious and access to affordable goods and commodities;
- 3. To support farmers to sell agri-produce, to facilitate product regional exchange of OTOP products and to provide opportunity for local micro- entrepreneurs to market their product:
- 4. To provide market opportunities to MSMEs through local product promotion and eliminate as many marketing layers/middle men as possible, allowing producers to earn bigger income from directly selling their products instead of using trader intermediaries;
- 5. To encourage consumer spending, thereby jumpstarting and reviving local economies.

#### Section 3. POLICY CONTENT AND GUIDELINES. -

- 1. KNP shall run every 15th and 30th day every month starting January 30, 2026;
- 2. The grand launch held last July 17,2023 commenced the opening of KNP nationwide;
- 3. KNP shall have three (3) market areas or product clusters, However, a beginner municipality may have one (1) market area in the meantime, or at the discretion of the LCE;
- 4. Agriculture products such as rice, vegetables and fruits by farmers of the different barangays;
- 5. Processed goods both and non-food produced by MSMEs as OTOP products of different localities;
- 6. Macato stalls (ready-to eat-food) for micro-enterprises of the host LGU;
- 7. The venue of the KNP may be in a closed or an open space area provided there are available tents, tables and chairs. It should be well ventilated and with area that can accommodate stalls for selling products, area for eating and parking;
- 8. No registration fee shall be collected from participating farmers/MSME merchants nor from visiting consumers.

### Section 4. ROLES AND RESPONSIBILITIES.-

KADIWA ng Pangulo (KNP) is a joint program and collaborative arrangement among concerned government agencies of national and government units. It also encourages full participation and support of non-government organizations, business sectors and cooperatives. The MLGU shall have the following responsibilities in the implementation of the KNP as:

#### Section 5. MONITORING AND EVALUATION. -

The Municipal Agriculture Office (MAO) shall establish a monitoring and evaluation system in order to evaluate the impact on the local economy, which shall provide the estimated number of people that visited the KNP, time and place of KNP activity, number of consumers and sellers/entrepreneurs that participated, including the revenue generated during the KNP day, and shall submit report to the Municipal Mayor, copy furnish the DILG.

**Section 6. FUNDING.** – The Municipal Government of Villaba shall allocate funds for the initial implementation of this Ordinance.

**Section 7. SEPARABILITY CLAUSE**. – If for any reason, any provision or part of this Ordinance is held invalid or unconstitutional, the remaining provisions not affected thereby, shall remain in full force and effect.

Section 8. EFFECTIVITY CLAUSE. – This Ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places pursuant to the posting provision of the Local Government Code.

On motion for approval by the Hon. Rogelio J. Baay, this Ordinance was unanimously approved on March 3, 2025.

Minutes of the Public Hearing conducted by the Committee of Laws and Rules on Februart 28, 2025 at the New SB Session Hall at 1:00 P.M. on the proposed Ordinance Formulated to Institutionalize Katuwang s Diwa at Gawa sa Masaganag Ani at Mataas n akita (KADIWA) ng Pangulo (KNP) in the Municipality of Villaba, Leyte"

#### NO MEMBERS PRESENT

This public hearing was originally scheduled at 9:00 a.m. on February 28, 2025, but due to the Exit Conference of the Commission on Audit (COA) with all the Department Heads of the LGU which was also held on the same day and time, the hearing was reset in the afternoon.

During the deliberation of this Ordinance, The Local Finance Committee showed concern about how the KADIWA would start and continue to operate. The chair voiced his belief that since this program is under the control of the MAO and there is the farmers Federation behind him, the operation of the KADIWA is not a problem. On this score, the HRMO Head manifested that in reference to the KADIWA Center, there is an existing building occupied by the cooperative organization which is not fully operational. This can be utilized for the purpose. The other members of the group corroborated the statement of the HRM Officer as they also mention that there had been a KADIWA established several years ago in the municipality, so the idea about this is not new. The chair added that, at any rate, the Ordinance is providing guidelines on the management thereof.
