Issues/concerns for review/recommendation/legal opinion is/are as follows:

• Ordinance No. 500-030325 entitled: "An Ordinance adopting and implementing Tax Amnesty on Real Property Taxes under RA 12001, etc."

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is generally in accordance to its power under RA 12001¹. It is however noted that further scrutiny of the said Statute provides that;

This amnesty shall not extend to the following real properties:

- (a) Delinquent real properties which have been disposed of at public auction to satisfy the real property tax delinquencies;
- (b) Real properties with tax delinquencies which are being paid pursuant to a compromise agreement; and
- (c) Real properties subject of pending cases in court for real property tax delinquencies

Hence, we recommend that the abovementioned provision be incorporated in the proposed Ordinance.

We hope to have assisted you with this request. Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.

MUNICIPAL ORDINANCE NO. 500-030325

AN ORDINANCE ADOPTING AND IMPLEMENTING TAX AMNESTY ON REAL PROPERTY TAXES UNDER REPUBLIC ACT NO. 12001, OTHERWISE KNOWN AS THE "REAL PROPERTY VALUATION AND ASSESSMENT REFORM ACT", IN THE **MUNICIPALITY OF PALOMPON UNTIL JULY 5, 2026**

Be it ordained by the Sangguniang Bayan of Palompon, Leyte, in session assembled:

SECTION 1. Title. This ordinance shall be known as the "Real Property Tax Amnesty Ordinance of 2025."

SECTION 2. Authority. This ordinance is enacted pursuant to Republic Act No. 12001, otherwise known as the "Real Property Valuation and Assessment Reform Act," which grants local government units the authority to provide for tax amnesty programs on real property taxes.

SECTION 3. Purpose. The purpose of this ordinance is to provide taxpayers in the Municipality of Palompon with an opportunity to settle their delinquent real property taxes, penalties, and interest by availing of the tax amnesty program, in order to improve the collection of local revenue, ensure the proper implementation of the Real Property Valuation and Assessment Reform Act, and encourage compliance with local tax laws.

SECTION 4. Coverage. The tax amnesty shall apply to all real properties within the jurisdiction of the Municipality of Palompon, including all delinquent real property taxes, penalties, and interest assessed as of the date of effectivity of this ordinance.

SECTION 5. Period of Availment. The tax amnesty program shall be available to all qualified taxpayers from the date of effectivity of this ordinance until July 5, 2026.

SECTION 6. Benefits of Tax Amnesty.

- 1. Full Waiver of Penalties and Interest: Taxpayers who avail of the tax amnesty shall be granted a full waiver of all penalties and interest that have accrued on their real property tax obligations.
- 2. Reduction of Principal Tax Liabilities: Taxpayers shall be required to settle only the principal amount of their real property tax liabilities.
- 3. No Legal Actions: No legal actions for the collection of delinquent real property taxes shall be initiated against taxpayers who avail of the amnesty program.

SECTION 7. Procedure for Availing of Tax Amnesty.

1. Application: Taxpayers wishing to avail of the tax amnesty must submit a duly accomplished application form to the Municipal Treasurer's Office, indicating the real properties for which they wish to settle their tax liabilities.

2. Payment: Upon verification of the tax liabilities, the taxpayer shall be required to pay the principal amount of their real property taxes due.

3. Issuance of Certificate: After payment, the Municipal Treasurer's Office shall issue a Certificate of Tax Amnesty to the taxpayer, signifying the full settlement of the tax obligations.

SECTION 8. Conditions for Availment.

- 1. Only those taxpayers with delinquent real property tax obligations, including penalties and interest, are eligible to avail of the tax amnesty.
- 2. Taxpayers must settle all applicable real property taxes by the deadline of July 5, 2026 to avail of the benefits under this ordinance.

SECTION 9. Implementation. The Municipal Treasurer's Office, with the assistance of the Local Assessor's Office, shall be responsible for the implementation of this tax amnesty program. Information dissemination about the tax amnesty shall be conducted through public announcements, social media, and other means to ensure that all taxpayers are informed about the program.

SECTION 10. Non-Availing of Tax Amnesty. Taxpayers who do not avail of the tax amnesty program by the deadline of July 5, 2026 shall be subject to the regular tax collection procedures, including the imposition of penalties and interest as prescribed by law.

SECTION 11. Funding. The funding necessary for the implementation of this ordinance shall be sourced from the general fund of the Municipality of Palompon.

SECTION 12. Separability Clause. If any part, section, or provision of this ordinance is held to be invalid or unconstitutional, the other provisions not affected shall remain in full force and effect.

SECTION 13. Repealing Clause. All ordinances, resolutions, and executive orders of parts thereof inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

SECTION 14. Effectivity. This ordinance shall take effect immediately upon approval and publication in a newspaper of general circulation or posting in conspicuous places within the Municipality of Palompon.
