#### **ORDINANCE No. 2025-07**

AN ORDINANCE PROHIBITING ANY PERSON OR PERSONS OR ESTABLISHMENTS TO SELL OR DISPENSE ALCOHOLIC DRINKS OR BEVERAGES TO MINORS AND PROVIDING PENALTIES THEREOF.

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Javier, Leyte, THAT:

SECTION 1. This Ordinance shall be known as " An Ordinance Prohibiting Minors Access to Alcoholic Drinks and Beverages in the Municipality of Javier, Leyte".

# SECTION 2. As used in this Ordinance, the following shall mean:

a. Minor

- Person whose age is below 18 years old

b. Establishment

-Any store, bars, beer houses/gardens, disco houses, restaurants,

nightclubs or public eating-

Dispense

-to sell, distribute, serve, deal out, and give away with or without

monetary consideration

d. Alcoholic Drinks or Beverages - Drinks that contains alcohol of no less than 4% of its total total volume or contents

SECTION 3. It shall be unlawful and prohibited to any person or persons or establishments to sell or dispense alcoholic drinks or beverages to minor or minors.

SECTION 4. Violating the provisions of this Ordinance shall be meted with penalty as follows:

First Offense

- One Thousand Pesos ( P 1,000.00)

Second Offense- One Thousand Five Hundred Pesos (P 1,500.00)

Third and Succeeding Offenses-Two Thousand Pesos ( P 2,000.00)

**SECTION 5.** Any provision or portion of this Ordinance found to be unconstitutional or invalid shall not affect the other provisions or parts hereof which shall continue to be enforced and in effect.

**SECTION 6.** All ordinances, rules, orders and regulations or parts hereof which are inconsistent or in conflict with any of the provisions of this ordinance are hereby modified and/or repealed accordingly.

SECTION 7. This Ordinance shall take effect immediately upon approval.
