Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 2 CY 2024** of the **Municipality of Mayorga**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 03**, series of 2024 in the amount of **P1,216,000.00** reveals compliance with the same law and its implementing Rules and Regulations.


