April 4, 2025

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through SP Secretary, the attached Ordinance No. 09 S. 2024 of the Sangguniang Bayan of Villaba, Leyte.

Issues/concerns for review/recommendation/legal opinion is/are as follows:

- Ordinance No. 09 S. 2024 entitled: "An Ordinance reclassifying parcel No.1: Lot No. 3612-B, etc."

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit particularly covered under Section 447(a)(2)(viii)¹ of the Local Government Code.

It must be noted however, that the power of the LGUs to reclassify agricultural lands is without prejudice to the authority of the DAR to approve conversion of agricultural lands covered by Republic Act No. 6657 to non-agricultural uses and has been validly recognized by Section 20 of Republic Act No. 7160 by explicitly providing therein that, *"nothing in this section shall be construed as repealing or modifying in any manner the provisions of Republic Act No. 6657."*

Furthermore, pursuant to DILG opinion No.22, S. 2020 dated January 31, 2020 citing the Supreme Court Decision in the case of "Chamber of Real Estate and Builders Associations, Inc. (CREBA), vs The Secretary of Agrarian Reform², reclassification alone will not suffice to use the agricultural lands for other purposes. Conversion is needed to change the current use of the reclassified lands.

¹ (viii) Reclassify land within the jurisdiction of the municipality, subject to the pertinent provisions of this Code;

Considering the foregoing, the proposed authority to reclassify is recommended for approval without prejudice to the conversion requirement to conform with the current and actual use of the reclassified land.

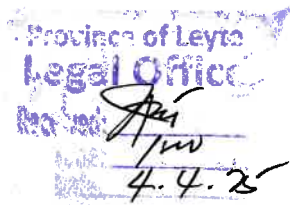











WHEREAS, the Reclassification of lands, Section 20 of RA 7160 states that (a) municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial or industrial purposes, as determined by the sanggunian concerned;

WHEREAS, the Implementing Rules and Regulation of the Local Government Code provides that a municipality shall continue to prepare their respective comprehensive land use plans (CLUP), enacted through zoning ordinances, subject to applicable laws and regulations;

WHEREAS, the said IRR also prescribes that such plans shall serve as the primary and dominant bases for future use of land resources and reclassification;

WHEREAS, as explained in DAR Memorandum Circular No. 7, Series of 1994, cited in 2009 case of Roxas and Company, Inc. vs DAMBA-NFSW and the DAR, reclassification of lands denoted their allocation into some specific use and providing or the manner of their utilization and disposition or the act of specifying how agricultural lands shall be utilized for non-agricultural uses such as residential, commercial or industrial as embodied in the land use plan. For the reclassification lands, therefore to be used for the purpose to which they are intended there is still a need to change the current use thereof through the process of conversion;

WHEREAS, due to the absence of an existing Comprehensive Land Use Plan (CLUP) and Zoning Ordinance which must be submitted in application for conversion, hence this passage of the Municipal Ordinance for Reclassification;

WHEREAS, in support to this legislation, the Certification from the Office of the Municipal Agriculture which states that the said land does not exceed the limitation as prescribed under the Department of Agriculture Memorandum Circulars and that the said land ceased to be economically feasible and sound for agricultural purpose, shall be an integral part of this legislation;

WHEREAS, this request is made for the purpose of facilitating the development and utilization of the subject properties for industrial purposes by the Omaganhan Farmers Agrarian Reform Cooperative, OFMPC, represented herein by its Chief Operation Officer (COO), IVY O. FUENTES;

WHEREAS, copies of the Transfer Certificate of land Title, Deed of Absolute Sale, Certification by the Community Environment and Natural Resources (CENRO), and other pertinent documents attached to this resolution, shall also be a vital part of the proposed Ordinance.

Be it ordained, by the Sangguniang Bayan of Villaba, Leyte, in regular session assembled that:

Section 1. AUTHORITY TO RECLASSIFY. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1961 empowers the Sangguniang Bayan to enact the ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization;

Section 2. DEFINITION OF TERMS. As used in this ordinance, the following terms shall mean as follows:


- a. **Reclassification** – the act of reclassifying agricultural lands to non-agricultural uses simply specifies how agricultural lands shall be utilized for non-agricultural uses such as: residential, industrial and commercial as embodied in the land use plan. It also includes the reversion of non-agricultural lands to agricultural one.
- b. **Agricultural Land** – refers to land use devoted to agricultural activity and not classified as mineral, forest, residential, commercial or industrial land (Section 3, (c) of Republic Act No. 6657).
- c. **Agricultural Zone** – refers to an area within the municipality devoted primarily for agricultural purposes.
- d. **Industrial Zone** – refers to an area within the municipality principally intended for the following types of industries:
 - Non-pollutive/ non hazardous
 - Pollutive/ hazardous
- e. **Conversion** – for the reclassified lands, therefore, to be used for the purpose to which they are intended there is still a need to change the current use thereof through the process of conversion (*Roxas and Company, Inc. vs. DAMBA_NFSW and the DAR*);


Section 3. DOCUMENTARY REQUIREMENTS. The documents consisting of the following are incorporated herein and shall be made as an integral part of this Ordinance:

1. Photocopy of Tax Declaration of Real Property;
2. Proof of ownership of Land e.g. Certified True Copy of the Original Certificate of Title or Transfer Certificate of Title (OCT/TCT) and or documents establishing ownership certified by Registry of Deeds not later than Thirty (30) days prior to filling;
3. Affidavit of Undertaking to comply the following requirements: Certification from DENR Community Environment and Natural Resources Officer (CENRO) that the landholding has been classified as alienable and disposable;
4. Certification from the Department of Agrarian Reform (Certificate of Non-CARP Coverage) to be signed by MARO or PARO;
5. Certification from the Municipal Agriculture's Office (MAO), stating that the said land ceases to be economically feasible and sound for agricultural purposes and does not exceed to 10% of the total Agricultural Land are of the Municipality;
6. Deed of Absolute Sale and Acknowledgement Receipt;
7. Vicinity Maps of the area with sufficient reference points;
8. Clear, Colored photographs of the area (5R size);
9. Special Power of Attorney;





Section 6. CONVERSION. This ordinance shall not be construed as a conversion order, which shall be issued merely by Department of Agrarian Reform (DAR).

Section 7. REPEALING CLAUSE. All ordinances, resolutions, executive orders and other issuances, which are inconsistent with any of the provisions of the Ordinance, are hereby repealed or modified accordingly.

Section 8. SEPARABILITY CLAUSE. Should any section or provision of this Ordinance be declared as unconstitutional or invalid, other provision which are not affected thereby shall continue to be in full force and effect.


Section 9. EFFECTIVITY. This Ordinance shall take effect fifteen (15) days following the completion of their publication.


