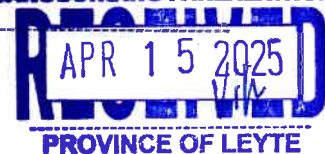

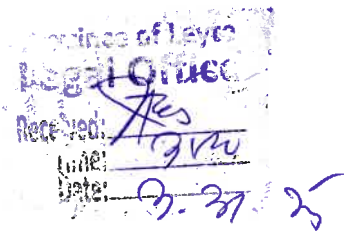
(1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government

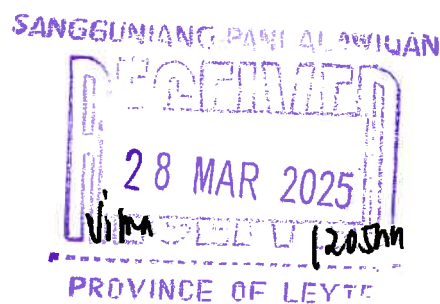

ORDINANCE NO. 03, SERIES 2025

AN ORDINANCE ADOPTING THE IMPLEMENTING GUIDELINES FOR THE PHILHEALTH KONSULTASYONG SULIT AT TAMA (PHILHEALTH KONSULTA PACKAGE REVISION 2) AND ESTABLISHING THE DISPOSITION AND ALLOCATION OF THE CAPITATION PAYMENTS IN THE MUNICIPALITY OF ABUYOG, LEYTE

BE IT ENACTED by the Sangguniang Bayan of Abuyog, Leyte in session duly assembled that:

Section 1. TITLE – This ordinance shall be known as the “Adopting the Implementing Guidelines for the PhilHealth Konsultasyong Sulit at Tama (PhilHealth Konsulta Package) and Establishing the Disposition and Allocation of the Capitation Payments in the Municipality of Abuyog, Leyte”.

Section 2. POLICY – It shall be the policy of the Municipality of Abuyog, Leyte to fully support and ensure the effective implementation of PhilHealth Circular 2023-0013 entitled Implementing Guidelines for the PhilHealth Konsultasyong Sulit at Tama (PhilHealth Konsulta Package Revision 2).

Section 3. PROVIDER PAYMENT MECHANISM

- PhilHealth shall pay using the Auto-Credit Payment Scheme (ASCPS) for services provided under the Konsulta Package (ASCPS) for services provided under the Konsulta Package per PhilHealth Circular 2023-0013.

Section 4. DISPOSITION AND ALLOCATION OF CAPITATION PAYMENTS – The capitation reimbursements of the PhilHealth Konsulta Package per PhilHealth Circular 2023-0013, Part V, Section E Paragraphs 1, state that capitation payments shall be utilized to cover all essential services, medicines, and other operating expenses to support the delivery of health care and shall be allocated as follows:

60%	For essential Services and Medicines under PhilHealth Circular 2023-0013 Other Operating Expenses such as but not limited to 25% Medicines 16% Laboratory reagents, equipment's and other logistics 3% hiring of health workers, non-health workers such as encoders 1% Internet subscription, EMR service provider subscription fees, and IT Hardware equipment 5% Maintenance of Health Facility 5% Service Delivery Programs 5% Capacity Building
40%	Performance Incentives for Primary Care Workers and Administrative Staff 10% Certified and Accredited Primary Care Physician 15% Certified and Accredited Primary Care Nurses, Midwives and other/permanent Health Workers 10% Allied Professionals (Barangay Health Workers and Barangay Nutrition Scholars) 3% Administrative and IT staff directly involved in Konsulta package 1% Other Job Order or Contractual support staff at the RHU 1% LGU Administrative Staff directly involved in the Konsulta Package (including the head of the MSWDO & his/her designated staff, Mun. Treasurer, Mun. Accountant, Disbursing Officer, DOH deployed HRH

Utilization of Funds: In the event of a lack of funding the utilization funds can be realigned to other operating expenses needed and shall be subject to the discretion of the Accredited Physician.

Staff Sharing Scheme: The sharing of the RHU personnel must be under the discretion of the Accredited Physician, ensuring equality among the staff and must ensure an output-based sharing scheme.

Section 5. SEPARABILITY CLAUSE– In the event that any section, paragraph, sentence, clause, or word of this Ordinance is declared invalid for any reason, other provisions thereof should not be affected thereby.

Section 6. REPEALING CLAUSE – All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.


Section 7. EFFECTIVITY – This Ordinance shall take effect immediately upon approval.
