WHEREAS, the Karayhakan Festival is an annual celebration commemorating the vibrant customs and tradition-rich history of Javier, Leyte;

WHEREAS, the festival has become a fast rising widely known cultural event that continuously attracts people with its own social activities, food and ceremonies;

WHEREAS, the fixing of the 27th day of May of every year as permanent date for the festival will help the people both local and abroad to make travel plan to come and witness the event;

NOW THEREFORE, be it Ordained by the Sangguniang Bayan of Javier, Leyte, THAT:

SECTION 1. Title. This shall be known as the Ordinance declaring the 27th day of May of every year as Karayhakan Festival Day and further declaring it as the highlight presentation of the Municipality of Javier, Leyte Socio-Cultural Activities.

SECTION 2. Funding Support. The event shall become a regular annual activity of the Municipality and shall be supported each year with an initial budget of Five Hundred Thousand Pesos (P 500,000.00) for the succeeding yearly presentations to defray the necessary expenses for the conduct of various activities during the celebration.
