

<sup>&</sup>lt;sup>1</sup> (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

<sup>(</sup>c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

ORDINANCE PROVIDING FOR THE REGULATIONS IN THE TEMPORARY CLOSURE THE PORTIONS OF CAPT. VILBAR AND CAPT. FLORDELIS STREETS IN THE URBAN HILONGOS AND RE-ROUTING OF TRAFFIC DUE TO THE ON-GOING ROAD REHABILITATION

WHEREAS, Section 21 of RA 7160, otherwise known as the Local Government Code of 1991 states that any national, or local road, alley, park or square may be temporarily closed during an actual emergency, fiesta celebration, public rallies, agricultural or industrial fairs or an undertaking of public works and highways, telecommunications and waterwork projects, the duration of which shall be specified by the Local Chief Executive ence ned in a written order:

WHEREAS, the Local Government of Hilongos has an approved project in the 20% Local Development Fund entitled: Rehabilitation of Municipal Roads at Capt. Flordelis to Capt. Vilbar Streets;

WHEREAS, to avoid confusion to drivers and road users, maintain adequate protection for the workers and minimize disruption to traffic, a re-routing plan is needed;

WHEREAS, there is a need to enact an ordinance providing guidelines for the Executive Department in implementing the temporary and road closure;

BE IT ENACTED by the 16th Sangguniang Bayan of Hilongos during the 6th Regular Session assembled that:

SECTION 1. TITLE - This Ordinance shall be known as the Temporary Closure of a portion of Capt. Vilbar Street to Capt. Flordelis Street Due to the Road Rehabilitation.

SECTION 2. TEMPORARY CLOSURE AUTHORIZATION - The Municipal Mayor is hereby authorized to temporarily close a portion of Capt. Vilbar to Capt. Flordelis Streets for a period not exceeding One Hundred Twenty (120) Calendar Days.

SECTION 3. TRAFFIC MANAGEMENT - The Local Chief Executive thru the Traffic Enforcers shall implement the following, to wit:

- a) Install clear and visible signages indicating the closure and alternative routes based on the re-routing plan prepared.
- b) Deploy traffic enforcers to manage the traffic flow in the designated area.

SECTION 4. SEPARABILITY CLAUSE - If for any reason or reasons, any part or provision of this Ordinance is declared unconstitutional or invalid, other parts or provisions hereof which are not affected shall remain to be in full force and effect.
