Be it enacted by the Sangguniang Bayan of the Municipality of Babatagon, Leyte in session assembled:

SECTION 1. These- This ordinance shall be known as the "Adopting the Implementing Guidelines for the PhilHealth Konsultasyong Sulit at Tama (PhilHealth Konsulta Package) and Establishing the Disposition and Allocation of the Capitation Payments in the Municipality of Babatngon Leyte.

SECTION 2. Policy - It shall be the policy of the Municipality of Babatagon, Leyte to fully support and ensure the effective implementation of PhilHealth Circular 2023-0013 entitles Implementing Guidelines for the PhilHealth Konsultasyong Suiit at Tama (PhilHealth Konsulta Pachage Revision 2).

SECTION 2. Provider Payment Mechanism.

- PhilHealth shall pay using the Auto-Credit Payment Scheme (ASCPS) for services provided under the Konsulta Pachage (ASCPS) for services provided under the Konsulta Pachage per PhilHealth 2023-0013.
- Provider may change fees for services and commodities not included in the benefit package.

SECTION 4. Disposition and Allocation of Capitation Payments. The Capitation reimbursements of the Phill-lealth Konsulta Package per Phill-lealth Circular 2023-0013, Part V, Section E Paragraphs I, state that capitation payments shall be utilized to cover all essential services, medicines, and other operating expenses to support the delivery of quality health care and shall be allocated as follows:





Utilization of Funds: In the event of lack of funding the utilization of funds can be realigned to other operating expenses needed and shall be subject to the discretion of the Accredited Physician.

Staff Sharing: The sharing of the RHU personnel must be under the discretion of the Accredited Physician, ensuring equality among the staff and must ensure an output-based sharing scheme.

SECTION 5. Separability Clauses in the event that any section, paragraph, sentence, clause, or word of this ordinance is declared invalid for any reason, other provisions thereof should not be affected thereby.

SECTION 6. All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

\$ECTION 7. Effectivity. This ordinance shall take effect upon approval.






