Respectfully returned to the Sangguniang Panlalawigan of Leyte, through SP Secretary, the attached Ordinance No. 115-25 of the Sangguniang Bayan of Leyte, Leyte.

Issues/concerns for review/recommendation/legal opinion is/are as follows:

• Ordinance No. 115-25 entitled: "An Ordinance reclassifying Lot 1087 with a total land area of 1,899 square meters located at Barangay Sambulawan, Leyte, Leyte from agricultural to commercial use."

#### **REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit particularly covered under Section 447(a)(2)(viii)<sup>1</sup> of the Local Government Code.

It must be noted however, that the power of the LGUs to reclassify agricultural lands is without prejudice to the authority of the DAR to approve conversion of agricultural lands covered by Republic Act No. 6657 to non-agricultural uses and has been validly recognized by Section 20 of Republic Act No. 7160 by explicitly providing therein that, "nothing in this section shall be construed as repealing or modifying in any manner the provisions of Republic Act No. 6657."

Furthermore, pursuant to DILG opinion No.22, S. 2020 dated January 31, 2020 citing the Supreme Court Decision in the case of "Chamber of Real Estate and Builders Associations, Inc. (CREBA), vs The Secretary of Agrarian Reform<sup>2</sup>, reclassification alone will not suffice to use the agricultural lands for other purposes. Conversion is needed to change the current use of the reclassified lands.

<sup>1 (</sup>viii) Reclassify land within the jurisdiction of the municipality, subject to the pertinent provisions of this Code;

Considering the foregoing, the proposed authority to reclassify is recommended for approval without prejudice to the conversion requirement to conform with the current and actual use of the reclassified land.

This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.

BE IT ORDAINED by the Sangguniang Bayan of Leyte, Leyte in session assembled that:

**SECTION 1.** Authority to Reclassify. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural use and to provide for the manner of their utilization.

**SECTION 2. Reclassification.** The following portion of lot is hereby reclassified from agricultural use to commercial use.



**Section 3. Manner of Utilization.** The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of the Municipality of Leyte and other applicable laws, rules and regulations.

**Section 4. Compliance of Requirements for Reclassification.** Conformably with Section 20 of the Local Government Code, the reclassification of the subject agricultural land is authorized in this ordinance as it ceased to be economically feasible and sound for agricultural purpose for several years now because of its soil classification and topographical location as shown by the certification issued by the Office of the Municipal Agriculture hereto attached and made an integral part thereof. Moreover, the Sangguniang Bayan has determined that the subject land has substantially greater economic value for commercial purposes.

This reclassification is in conformity with the percentage of total land area at the time of the enactment of this ordinance which is ten (10%) for a second class municipality like Leyte, Leyte.

**Section 5. Conversion.** This ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform.

Section 6. Non-Utilization of subject land for commercial purpose. Failure on the part of the applicant for reclassification to utilize the subject land for commercial purpose within ten (10) years from the approval of this ordinance, shall result in the revocation and the subject land will revert back to its agricultural classification.

Section 7. Effectivity. This ordinance shall take effect upon approval.






