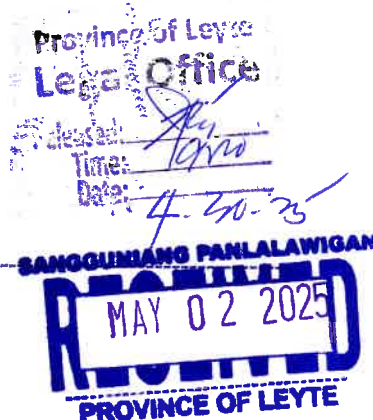

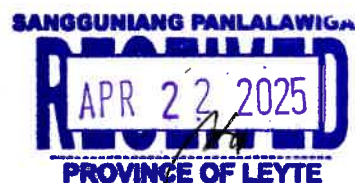

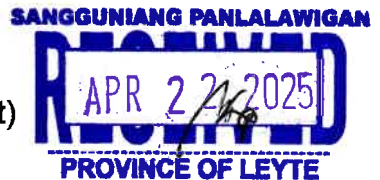

AN ORDINANCE APPROVING THE INCREASE OF THE CONSULTANCY FEE OF THE MANAGERIAL CONSULTANT OF LGU- VILLABA FROM FORTY THOUSAND PESOS (PHP 40,000.00) PER MONTH TO FIFTY THOUSAND PESOS (PHP50,000.00) PER MONTH TO ALIGN IT WITH THE RATE OF FEES FOR CONSULTANCY SERVICES OF THE EDUCATIONAL CONSULTANT

PREFATORY STATEMENT

Municipal Ordinance No. 2, S.-2022-2025 authorizing the Municipal Mayor Carlos G. Veloso to hire a Managerial Consultant in his office, was approved on August 8, 2022.

The aforesaid Ordinance set an amount of four hundred eighty thousand pesos (Php 480,000.00) per annum to cover the monthly fee of forty thousand pesos (Php 40,000.00) of the hired managerial consultant.

In his letter dated February 26, 2025, the Local Chief Executive (LCE) requested the August Body to pass a Municipal Ordinance approving the increase of the Consultancy Fee of the Managerial Consultant, to align it with the rate of fees for consultancy services of the Education Consultant.

In view of the foregoing premises, wherefore, on motion by the Hon. Rogelio J. Baay, Chairman, SB Committee on Human Resources and Management, seconded en masse,

Be it ordained as the Sangguniang Bayan hereby ordained that:

Section 1. SHORT TITLE – This legislation shall be known as the “Consultancy Fee Increase of the Managerial Consultant of LGU-Villaba, from Forty Thousand Pesos (Php 40,000.00) per month to Fifty Thousand Pesos (Php50,000.00) per month.”

Section 2. LEGAL BASIS. – All matters pertinent to human resources and development in local government units shall be governed by the civil service law and such rules and regulation and other issuances promulgated pursuant thereto.






Section 3. SOURCE OF FUND. - There shall be allocated an amount of Six Hundred Thousand Pesos (Php 600,000.00) per annum as fee for the hired Managerial Consultant of LGU Villaba.

Section 4. UTILIZATION OF FUND. - The above amount of Six Hundred Thousand Pesos (Php 600,000.00) per annum shall be utilized to augment the monthly fee of the Managerial Consultant from Forty thousand pesos (Php 40,000.00) per month to Fifty thousand pesos (Php 50,000.00) per month to align it with the rate of fees for consultancy services of the educational consultant.

Section 5. SEPARABILITY CLAUSE. - If for any reason, any section or provision of this ordinance is declared unconstitutional or invalid, the other sections or provisions not affected shall continue to be in full force or effect.

Section 6. EFFICTIVITY CLAUSE. - This Ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with posting requirement of the Local Government Code.

This Ordinance was approved by the Sangguniang Bayan in its Regular Session on March 24, 2025.



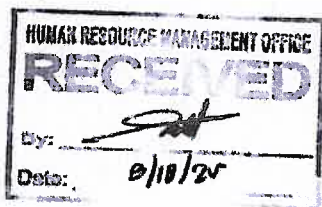


