## **ORDINANCE NO. 2025-06**

AN ORDINANCE ESTABLISHING AND NAMING THE NEWLY CONSTRUCTED PRIMARY CARE FACILITY LOCATED AT BARANGAY SAN PEDRO, ALBUERA, LEYTE AS "ALBUERA SUPER HEALTH CENTER"

#### PREFATORY STATEMENT

R.A. No. 7160, otherwise known as the Local Government Code of 1991, empowered the LGUs in consultation with the National Historical Commission to name and rename of streets, roads, schools, health facilities or any other public place or building within its territorial jurisdiction;

This august body has received an URGENT letter from the Office of the Municipal Mayor of Albuera, Leyte dated March 27, 2025 transmitting the Local Health Board Resolution pertaining to the naming of the newly constructed Primary Care Facility (a facility owned and managed by the LGU located at Barangay San Pedro, Albuera, Leyte) as "Albuera Super Health Center" for information and appropriate legislative action;

NOW, THEREFORE, BE IT ENACTED BY THE SANGGUNIANG BAYAN IN SESSION DULY ASSEMBLED THAT:

NOW THEREFORE, be it ordained by the Sangguniang Bayan in a session duly assembled that:

SECTION 1. NAMING - The newly newly constructed Primary Care Facility located at Barangay San Pedro, Albuera, Leyte is hereby established and named as "ALBUERA SUPER HEALTH CENTER."

**SECTION 2. SEPARABILITY CLAUSE**. If any section or provision of this Ordinance is declared invalid or unconstitutional by competent authority, any section or provision not affected thereby shall remain in full force and effect.

**SECTION 3. REPEALING AND AMENDATORY CLAUSE**. All ordinances, resolutions, rules, and regulations or any part thereof which are in conflict with or inconsistent with the provisions of this ordinance are hereby repealed and/or modified accordingly.

**SECTION 4. EFFECTIVITY**. This Ordinance shall take effect immediately upon approval and compliance with the posting requirement.
