Issues/concerns for review/recommendation/legal opinion is/are as follows:

Ordinance No. (225)#201 entitled: "An Ordinance Institutionalizing Youth Development under the Barangay Governance **Tracking-Community** Assessment and Reward System (BGT-CARES) Constituting a Governance Tracking and Assessment Committee (GTAC) and for Other Purposes."

#### REVIEW/RECOMMENDATION/LEGAL OPINION:

This office opines that the subject Ordinance is general, within the legislative authority of the Sangguniang Bayan under Sections 447(a)(1)1 of the Local Government Code of 1991 (R.A 7160) in relation to RA 94852 and RA 112923. However, further review of Section 7 of the Ordinance is recommended as it is not in consonance with the provision of RA 10742, Section 20(b)4, highlighting financial independence of the Sangguniang Kabataan. Hence, we recommend for the declaration of its validity subject to further review and amendment of Section 7 of the said Ordinance.

Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.



Be it enacted by the Sangguniang Bayan of Matag-ob, Leyte, in session assembled, that:

Section 1. Title This ordinance shall be known as the "Youth Development Institutionalization Ordinance under BGT-CAReS".

Section 2. Declaration of Policy. It is the policy of the Barangay to promote and support youth development as a vital component of community growth and progress. This ordinance aims to institutionalize youth involvement in barangay governance, community activities, and development programs through the Barangay Governance Tracking -Community Assessment and Reward System (BGT-CAReS).

Section 3. Objectives. The objectives of this ordinance are:

3.1. To institutionalize the participation of youth in barangay governance and development initiatives.

3.2. To create opportunities for youth engagement in community service, leadership, and development activities.

3.3. To establish a Governance Tracking and Assessment Committee (GTAC) to monitor and evaluate the participation and impact of youth development programs.

3.4. To create a reward system that incentivizes and recognizes the contributions of the youth to the barangay.

4.1. Youth Development shall be formally recognized as a priority sector under the BGT-CAReS program.

4.2. The barangay shall establish a Youth Development Council (YDC) consisting of youth representatives aged 15 to 30 years old who are residents of the barangay.

4.3. The roles and responsibilities of the YDC shall include, but are not limited to:

4.3.a. Planning and implementing youth-focused programs and activities.

4.3.b. Promoting active participation in barangay governance and community development.

4.3.c. Advocating for the rights and welfare of the youth in the barangay.

4.4. The YDC shall work in coordination with the barangay council, non-governmental organizations (NGOs), and other community-based organizations in implementing youth development initiatives.

# Section 5. Governance Tracking and Assessment Committee (GTAC)

5.1. A Governance Tracking and Assessment Committee (GTAC) is hereby constituted to oversee the implementation of this ordinance.

5.2. The GTAC shall be composed of the following members:

5.2.a. Barangay Captain as Chairperson

5.2.b. Chairperson of the Committee on Youth and Sports

Development as Co-Chairperson

5.2.c. Representative from the Youth Development Council

5.2.d. Barangay Secretary

 Representatives from NGOs or communitybased organizations involved in youth development

5.3. The GTAC shall be responsible for:

5.3.a. Monitoring and evaluation in the implementation and impact of youth development programs and activities.

- 5.3.b. Developing and implementing the Community Assessment and Reward System (CAReS) specific to youth contributions.
- 5.3.c. Recommending policies and programs to enhance youth engagement in barangay governance and development.

# Section 6. Community Assessment and Reward System (CAReS)

- 6.1. The Community Assessment and Reward System (CAReS) shall be established to assess and recognize the contributions of the youth in the barangay development.
- 6.2. The assessment criteria shall include, but are not limited to:
  - 6.2.a. Participation in barangay governance and decision making processes.
  - 6.2.b. Involvement in community service and development projects.
  - 6.2.c. Contribution to the promotion of youth welfare, education, and livelihood programs.
- 6.3. Rewards may include certificates of recognition, financial incentives, scholarships, training opportunities, and other forms of support as determined by the GTAC.

**Section 7. Funding.** The Sangguniang Kabataan of the 21 component barangays of Matag-ob, Leyte shall allocate a portion of its 10% annual budget to support the activities of the Youth Development Council and the implementation of the CAReS program.

**Section 8. Implementing Rules and Regulations** The GTAC, in coordination with the Youth Development Council, shall formulate the necessary rules and regulations for the effective implementation of this ordinance within 60 days from its enactment.

**Section 9. Amendments Clause.** This ordinance may be amended or modified as necessary through the appropriate legislative process.

Section 10. Penalty Clause. Barangays found to have falsified reports or failed to comply with the requirements of

Section 11. **Repealing Clause** All ordinances, resolutions, rules, and regulations inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 12. **Effectivity** This ordinance shall take effect immediately upon its approval and publication in a manner prescribed by law.
