BE IT ENACTED by the Sangguniang Bayan of the Municipality of Matag-ob, Leyte, in session duly assembled:

SECTION 1. TITLE. This Ordinance shall be known as the "Barangay Governance Tracking, Community Assessment, and Reward System (BGT CARES) Ordinance of Matag-ob, Leyte.

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Municipality of Matag-ob to promote good governance, transparency, and accountability in all barangays. The institutionalization of the Barangay Governance Tracking, Community Assessment, and Reward System (BGT CARES) aims to:

- a. Strengthen barangay governance and encourage active community participation;
- b. Provide an objective mechanism to assess the performance of barangays in delivering basic services and ensuring public welfare; and
- c. Recognize and reward exemplary barangays to serve as role models for others.

SECTION 3. OBJECTIVES. The objectives of this Ordinance are as follows:

1. To establish a comprehensive and standardized tracking and assessment system for barangay governance performance.

2. To ensure continuous improvement in governance through periodic evaluations and feedback mechanisms.

 To institutionalize a reward system that motivates barangays to excel in governance and public service delivery.

SECTION 4. SCOPE AND COVERAGE. This Ordinance shall apply to all barangays within the jurisdiction of the Municipality of Matag-ob, Leyte.

SECTION 5. CREATION OF THE BGT CARES PROGRAM The Barangay Governance Tracking, Community Assessment, and Reward System (BGT CARES) is hereby created and institutionalized to operationalize the objectives stated in this Ordinance.

SECTION 6. IMPLEMENTATION GUIDELINES

a. Barangay Governance Tracking

- Key performance indicators (KPIs) shall be established in areas such as public service delivery, disaster preparedness, fiscal management, and environmental protection.
- Each barangay shall submit quarterly and annual reports to the Municipal Evaluation Team (MET).
- Each Barangay Kagawad, Barangay Secretary, Barangay Treasurer, and Barangay SK Chairperson shall submit a monthly and annual report to the Municipal Evaluation Team (MET) on the period agreed upon. Said reports shall be attached to the monthly payroll disbursement voucher of the Barangay.
- In no case shall the Barangay Treasurer and the Punong Barangay prepare their monthly payroll without the attached accomplishment reports of the aforementioned Barangay Officials.
- b. Community Assessment

- An assessment tool shall be developed to gather feedback from barangay residents regarding governance and service delivery.
- Periodic surveys and public consultations shall be conducted.

c. Reward System

- A system of recognition and incentives shall be implemented, including monetary rewards, plaques of recognition, and funding for community development projects.
- Annual awards shall be given to outstanding barangays based on the assessment results.

SECTION 7. MUNICIPAL EVALUATION TEAM (MET) A Municipal Evaluation Team (MET) shall be created to oversee the implementation of the BGT CARES program.

a. Composition:

- Municipal Planning and Development Officer (Chairperson)
- ✓ Representatives from the Sangguniang Bayan
- ✓ Local Government Operations Officer (LGOO)
- ✓ Representatives from accredited Civil Society Organizations (CSOs)
- ✓ Other members as deemed necessary.

b. Functions:

- Formulate criteria, tools, and procedures for the program.
- Conduct barangay assessments and validations.
- Recommend and endorse recipients of rewards and recognitions.

SECTION 8. FUNDING. An initial allocation of PHP 200,000.00 shall be provided from the General Fund of the Municipality of Matag-ob for the implementation of this Ordinance. Annual appropriations shall be included in the municipal budget to sustain the program.

SECTION 9. MONITORING AND EVALUATION. The Municipal Evaluation Team shall submit an annual report to

SECTION 10. PENALTY CLAUSE. Barangays found to have falsified reports or failed to comply with the requirements of this Ordinance without valid justification shall be disqualified from the reward system and may be subject to administrative sanctions.

Non-submission of required reports shall also be the basis for withholding of honorarium of Barangay Officials concerned both elective and appointive.

SECTION 11. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall not be affected and shall remain in full force and effect.

SECTION 12. REPEALING CLAUSE. All ordinances, resolutions, or parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 13. AMENDMENTS CLAUSE. This ordinance may be amended or modified as necessary through the appropriate legislative process.

SECTION 14. EFFECTIVITY. This Ordinance shall take effect immediately upon approval and compliance with publication and posting requirements as prescribed by law.
