



REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is generally in accordance with its power under Sections 447(a)(3)(i)¹ and (1)(iii)² of the Local Government Code of 1991 (R.A 7160) in relation to RA 9288 ³ subject to typographical corrections on page 7, item 7 "Philhealth/walk in mother" and page 8, Section 5, paragraph 1, "P 4,000 instead of P 4,00". Hence, we recommend for the declaration of its validity.

Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. TITLE: This ordinance shall be known and referred as "AN ORDINANCE ON FACILITY-BASED DELIVERY, USER'S AND NEWBORN SCREENING FEES, LABORATORY FEES AND INCENTIVES FOR STAFF, BARANGAY HEALTH VOLUNTEERS AND PREGNANT MOTHERS OF THIS MUNICIPALITY".

Section 2. DECLARATION OF POLICIES. As provided for in Article II, Section 15 of the Philippine constitution, it states that the "State shall protect and promote the right to health of the people and to instill health consciousness among them", an Article XIII, Section 2 further states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the unprivileged, sick, disabled, women and children. Further to carry out the objectives of RA 9710 otherwise known as the "Magna Carta of Women" and to fully support the Millennium Development Goals (MDG's) by;

- 1. Provide high quality delivery care for pregnant women and newborn babies;
- 2. Reducing maternal and neonatal death in Eastern Visayas:
- 3. Giving moral, social and technical support services during and after delivery as well as to the family of the pregnant mother;
- 4. Encouraging community involvement in the development and maintenance of our maternity clinic;
- 5. Encouraging; behavior change in pregnant mothers:
- 6. Increasing facility-based deliveries:
- 7. Increasing MCP (Maternity Care Program) claims in LGU facilities.

It is also a declared policy of the Municipality of Matagob to protect and promote the basic right to health of its inhabitants including the chances of survival of children as healthy and normal individuals. In the pursuit of this policy, the Municipality of Matag-ob institutionalizes and adopts the Newborn Screening Act of 2004, Newborn Screening aims to;

- 1. To ensure that every newborn has access to newborn screening for certain heritable conditions that can result in mental retardation, serious health complications or death if left undetected and untreated,
- 2.To established and integrate a sustainable newborn screening system within the public health delivery system;
- 3.To ensure that all health practitioners are aware of the advantages of newborn screening and of their respective responsibilities in offering newborn the opportunity to undergo newborn screening; and
- 4.To ensure that parents recognize their responsibility in promoting their child's right to health and full development, within the context of responsible parenthood, by protecting their child from preventable causes of disability and death through newborn screening.

Section 3. **DEFINITION OF TERMS:**

- 1. Rural Health Unit Maternity and Child Health Clinic shall refer to an establishment under the control and supervision of the Municipality of Matag-ob that provides health services catering most especially to pregnant women and newborn babies.
- 2. **MSWD** Officer refers to an officer of the Development of Social Welfare of our local government unit, whose tasked mandated by the ordinance is to identify marginalized and indigent maternal clients.
- 3. **Punong Barangay** shall refer to the Chief Executive of the lowest level of a government unit as understood under the Local Government Code of 1991, whose duly under this ordinance is to work in tandem with the MSWD Officer in selecting and identifying marginalized and indigent maternal clients.
- 4. Basic Emergency Obstetrical Newborn Care (BemONC)- the elements of obstetrics and newborn care that relates to the management of pregnancy, child birth (delivery, the postpartum and the newborn period; early detection treatment of problem pregnancies to prevent progression to an emergency; and management of complications such as hemorrhage, obstructed labor, pre-eclampsia/eclampsia, infection, asphyxia, and hypothermia.
- 5. **Municipal Treasurer-** shall refer to the department entity of the local government unit who is mandated by this ordinance to collect the income generated by the service charges of the maternal and child health clinic.
- 6. **Skilled Birth Attendant-** according to the Wor1d Health Organization (WHO), this refers to "an accredited health professional such as a midwife, doctor or nurse who has been formally educated and trained to proficiency in the skills needed to manage normal (uncomplicated) pregnancies, childbirth and the immediate postnatal period, and in the identification, management and referral of complications in women and newborns". Traditional birth attendants (TBA's) either trained or untrained are excluded from the category of skilled birth attendants.

- 7. Barangay Health Volunteers (BHW)- shall refer to a group of community health volunteers such as BHW's (Barangay Health Worker), BNS (Barangay Nutrition Specialist), TBA's (Traditional Birth Attendants or "Hilot") and other recognized Barangay health volunteers.
- 8. **Municipal Health Officer** shall refer to local health authority whose name and signature appears on the Memorandum of Agreement.
- 9. Accredited Professional Health Care Providershall refer to medical professional specialist (Obstetrician or Pediatrician) whose name and signature appears on the Memorandum of Agreement or the Municipal Health officer.
- 10. **Maternal Care Incentive Program (MCIP)-** a performance based program designed to promote safety of the mother and child during pregnancy, delivery and postnatal period. The herein incentives scheme shall encourage pregnant mothers to give birth at the RHU birthing facility.
- 11. **Maternity Care Package-** refer to PhilHealth benefit package provide to mothers as PHILHEALTH members and dependents for the coverage of the first four births in a PHILHEALTH accredited non hospital facility for the following services; prenatal, delivery, postpartum care and family planning.
- 12. **Maternal Death-** defined by the World Health Organization as the "death of a woman while pregnant or within 42 days of termination of pregnancy, irrespective of the duration and the site of the pregnancy, from any cause related to or aggravated by the accidental or incidental causes.
- 13. **Neonatal death** defined by the World Health Organization as number of deaths during the first 28 completed days of life per 1000 live births in given year or period. Neonatal deaths maybe subdivided into early neonatal deaths, occurring during the first 7 days of life, and late neonatal deaths, occurring after the 7th day but before the 28th completed days of life.
- 14. Facility Based Delivery refers to birth deliveries duly attended by skilled birth attendant (SBA) in a duly

15. Normal (Uncomplicated) Deliverybirth characterized by spontaneous onset of labor: low risk at the start of labor, throughout labor, and delivery; infant in vertex position: and 37-42 weeks of completed pregnancy. Delivery shall include services for antenatal care, actual delivery care, postpartum care and newborn care.

Section 4. SCOPE/ COVERAGE. The scope/ coverage of this Ordinance are as follows:

- 1. The Rural Health Unit Maternity and Child Health Care Clinic is committed to provide quality maternal and child care by providing them with the package of needed services and skilled birth attendants through the implementation of the BEMONC facility.
- 2. The mentioned health above facility PHILHEALTH PCB, TB DOTS and Maternal Care Package plus accredited unit providing basic health services to indigent and non-indigent clients.
- 3. All High Risk pregnant women such as those with pre-eclampsia pregnancy or induced hypertension. gestational diabetes mellitus, thyroid problem, cardiac diseases or any other diagnosed medical problems, and those who are gravid5 or more shall be immediately advised to a higher health facility or hospital or sign a waiver if they opt to deliver at the RHU.
- 4. Indigent members and dependents enrolled by the national government (NHTS) are free of charge when giving birth at the RHU. Indigent clients without PhilHealth cards are exempted from payment of service charge of Rural Health Unit, provided said obstetric unit patient is duly certified as indigent by the MSWD officer or his authorized representative or by the Punong Barangay, PhilHealth will reimburse the supplies/drugs used during the delivery and confinement of the mother in the amount of P 15,600.00 to the RHU for any PhilHealth member/dependent who gives birth to the facility.
- 5. Service/charges for non indigent and non PhilHealth or walk in clients shall be P 1,500.00 for primigravida and P 1,000.00 for multigravida. Service charges shall be collected

- a. First Offense- reprimand
- b. Second Offense- fine of P500.00
- c. Third Offense- fine of P1,000.00 and P1,500.00 thereafter.

Section 7. SEPARABILITY CLAUSE, If any part of this ordinance shall be held invalid, other parts or provision which are not affected thereby shall continue to be in full force and effect.

Section 8. AMENDMENT CLAUSE. This ordinance may be amended or modified as necessary through the appropriate legislative process.

Section 9. REPEALING CLAUSE. All ordinances, local issuances or rules inconsistent with the provisions of this ordinance are hereby repealed/ modified accordingly.

Section 10. EFFECTIVITY. This ordinance shall take effect upon its approval
