Now therefore, on motion of the Hon. Joel N. Denoy, duly seconded by all other members present, in its Regular session assembled, that:

SECTION 1. Short Title. - This Ordinance shall be known as "Zero Open Defecation (ZOD) Ordinance of the Municipality of Matag-ob."

SECTION 2. Scope and Coverage. - This shall be applicable to all persons, natural or juridical, resident or non-resident within the territorial jurisdiction in the Municipality of Matag-ob.

SECTION 3. Definition of terms. - For the purpose of this Ordinance, the following terms shall mean:

- a. Zero Open Defecation (ZOD) Absence of open defecation practice by One Hundred Percent (100%) among populace in Municipality of Matag-ob.
- b. Community Service refers to the voluntary public services rendered and intended to help the people in the community.
- c. Defecate to excrete/ discharge fecal waste from the body or to have a bowel movement.
- d. IEC Campaign refers to Information, Education and Communication campaign.
- e. Feces refers to waste matter discharged from human bowels.
- f. Open Defecation refers to the manner of excreting/discharging fecal waste on a place, site or location other than the toilet/comfort room or restroom and making the human feces openly visible and exposed to the environment.
- g. Public Places refers to all places that are accessible or open to the people in a community or places for collective use regardless of ownership which include outdoor spaces for gathering but not limited to playgrounds, public squares or plaza, grounds, church grounds and the likes.
- h. Sanitary Toilets refers to sanitation facilities or a piece of hardware used for the proper collection or disposal of human waste (urine and feces).

- a. It is prohibited to defecate and urinate in open public places.
- b. It is prohibited to throw human wastes, such as but not limited to diapers, napkins, and tissue papers outside the toilets or any open spaces, public or private, and in waterways such as rivers, creeks, drainage and canals.

SECTION 5. General and Administrative Provisions.

- a. Every household and or residential buildings within the territorial jurisdiction of the Municipality of Matag-ob is required to have a functional sanitary toilet to ensure proper disposal of human waste.
- b. All public buildings and private commercial buildings/business establishments must have a clean and sanitary toilets accessible for public use, free of charge.
- c. All sanitary toilets in public buildings and private commercial buildings/business establishments must be compliant to the provisions of Republic Act 7277 also known as Magna Carta for Persons with Disabilities.
- e. The Sanguniang Bayan shall create the Municipal Zero Open Defecation Task Force (MZODTF) and its respective functions;
- f. All 21 Barangay government Units are required to create their respective Barangay Health and Sanitation Task Force (BHSTF) and its respective functions and or may adopt the applicable provisions or functions formulated by the Mun. Zero Open Defecation Task Force.
- g. The Municipal government unit of Matag-ob through the different concerned departments or agencies shall provide any form of assistance (materials & education) to the target residential owners in their usage & construction of sanitary toilets.
- h. Presence of functional sanitary toilets facilities among household/residential and among commercial & business establishments is a pre-requisite in the Issuance of Barangay Clearances, Certificates and Permits_ to the concerned party, hence, master listing of such is necessary (Section 7:b)
- i. Existing houses or residential without toilets shall be given a grace period of one & a half years (1 ½ yrs.) from the effectivity date of this ordinance, to comply.



d. The Barangay Health Sanitation Task Force, in coordination with the barangay officials shall formulate policies and strategies to eradicate Open Defecation in their respective barangays.

SECTION 8. Penal Provisions.

a. In the implementation of this Ordinance, persons caught violating and not complying with the Section IV-Prohibited Acts to this Ordinance shall be penalized and to pay as follows.

1 st Offense	An Administrative fine of One Thousand Pesos (1,000Php)
2 nd Offense	An Administrative fine of Two Thousand Pesos (2,000.00Php)
3 rd Offense	An Administrative fine of Two Thousand Five Hundred (2,500.00) Pesos

b. Violators who failed to pay the corresponding penalties imposed in this Ordinance shall render the community service on the areas determined by the apprehending officers and or by the Barangay Health & Sanitation Task Force, as Follows.

1 st Offense	Two (2) days Community Service in areas determined by the Municipal ZOD Task Force
2 nd Offense	Three (3) days Community Service in areas determined by the Municipal ZOD Task Force
3 rd Offense	Five (5) days Community Service in areas determined by the Municipal ZOD Task Force

One (1) day community service construed or equivalent to (8) hours Community service.

c. The Municipal Treasure's Office is tasked to collect the penalties stipulated in this Ordinance.

SECTION 9. Budget and Appropriation. - The Local Government Unit of Matag-ob, shall appropriate funds for the implementation of Zero Open Defecation (ZOD)
