Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 1 CY 2025** of the **Municipality of Palompon**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 499-130125** with a total appropriation in the amount of **P38,063,043.17**, reveals substantial compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the appropriations for the increase in Salaries and wages to officials & employees from 2nd to 1st class municipality shall be in accordance with the provisions of BLGF Memorandum Circular No. 020-2024 and LBC No. 160 dated August 12, 2024;
- 2. That the grant of RATA adjustment to concerned officials of LGU-Palompon, Leyte shall be in accordance with the rules & regulations under LBC No. 157 dated May 3, 2024;
- 3. That the procurement of Civil Works and related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules & Regulations;
- That the grant of Medical Allowance shall strictly adhere to the conditions and guidelines stipulated under Budget Circular No. 2024-6 dated December 12, 2024;
- 5. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.

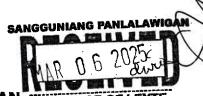
