

**Be it enacted by the Sangguniang Bayan of Tolosa, Leyte, in session
assembled:**

Section 1. Title

This ordinance shall be known as the "Renewable Energy Promotion Ordinance of Tolosa, Leyte."

Section 2. Objectives

This ordinance aims to:

- Promote the use and development of renewable energy sources in the Municipality of Tolosa to reduce dependence on non-renewable energy sources;
- Encourage the adoption of clean, sustainable, and environmentally friendly energy alternatives;



- c. Foster energy independence and reduce the environmental impact of energy consumption;
- d. Enhance public awareness of renewable energy and its benefits for both the environment and local communities.

Section 3. Definition of Terms

For the purposes of this ordinance, the following terms shall be defined as:

- a. **Renewable Energy** - Energy derived from natural sources that are replenished naturally, such as sunlight, wind, geothermal, hydroelectric, and biomass.
- b. **Renewable Energy Systems** - Systems that use renewable energy sources for generating electricity, heating, or other energy-related purposes, such as solar panels, wind turbines, and biomass generators.

Section 4. Promotion of Renewable Energy Systems

The Municipality of Tolosa shall:

- a. Encourage the installation and use of renewable energy systems in households, businesses, and government facilities, including but not limited to solar panels, wind turbines, and biomass energy systems;
- b. Facilitate the approval process for the installation of renewable energy systems by simplifying permit and licensing requirements and providing guidance for applicants;
- c. Promote the integration of renewable energy into public infrastructure, including street lighting, water pumping systems, and public buildings.

Section 5. Incentives for Renewable Energy Adoption

The Municipality shall establish programs to incentivize the adoption of renewable energy technologies, including:

- a) Providing financial incentives, such as subsidies or rebates, for the installation of renewable energy systems in residential, commercial, and government properties;
- b) Collaborating with financial institutions to offer low-interest loans or grants for renewable energy projects;
- c) Offering tax incentives or exemptions for businesses and residents who install renewable energy systems.

Section 6. Public Awareness and Education


To promote the benefits of renewable energy, the Municipality shall:

- a) Launch public information campaigns to educate residents and businesses about renewable energy technologies, their benefits, and how to access available incentives;

- b) Organize seminars, workshops, and training programs to increase local capacity and knowledge about renewable energy systems;
- c) Work with schools and educational institutions to integrate renewable energy education into school curriculums.

Section 7. Integration of Renewable Energy into Municipal Planning

The Municipality shall include renewable energy as a key component in its long-term urban and rural development plans, specifically by:

- a) Including renewable energy options in the municipal energy plans, including sourcing energy for new infrastructure projects from renewable sources;
- b) Prioritizing renewable energy in the development of new public infrastructure projects, such as new schools, health centers, and government buildings;
- c) Ensuring that renewable energy sources are considered in zoning and land-use planning decisions to accommodate renewable energy installations.

Section 8. Collaboration with National and Private Sectors

The Municipality shall collaborate with national government agencies, private companies, and non-government organizations to support renewable energy initiatives by:

- a) Partnering with national agencies such as the Department of Energy (DOE) for technical assistance, policy development, and funding opportunities related to renewable energy;
- b) Encouraging private sector investment in renewable energy through public-private partnerships, especially for large-scale renewable energy projects;
- c) Seeking external funding and technical support for renewable energy projects, particularly for those that target vulnerable or marginalized communities.

Section 9. Monitoring and Reporting

The Municipal Planning and Development Office (MPDO) shall be tasked with monitoring the implementation of this ordinance and ensuring its effectiveness by:

- a) Regularly tracking the progress of renewable energy initiatives, including the installation of renewable energy systems, energy savings, and environmental impact;
- b) Preparing an annual report on renewable energy adoption in the Municipality, which will be shared with the Sangguniang Bayan and made available to the public.

Section 10. Support for Local Renewable Energy Industry

To further promote renewable energy, the Municipality shall:

- a) Support the development of local renewable energy businesses and service providers, including those involved in the installation, maintenance, and manufacturing of renewable energy systems;
- b) Create a platform for local renewable energy businesses to showcase their products and services and provide opportunities for public-private collaborations.

Any provision of existing ordinances, resolutions, and executive orders that are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.





RESOLUTION NO. 02-41-2025

A RESOLUTION CONCURRING IN THE ISSUANCE OF A SPECIAL PERMIT FOR THE "REGULAR COCKFIGHTS" AS REQUESTED BY MR. FRANCIS ANGELO A. ROA, ON MARCH 2, 9, 16, 23, AND 30, 2025 (SUNDAYS) AT THE AIR53 TOLOSA AMUSEMENT CENTER LOCATED AT BARANGAY CANTARIWIS, MUNICIPALITY OF TOLOSA, LEYTE

WHEREAS, Section 447 (a)(3)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants the Sangguniang Bayan the power to authorize and regulate the establishment, operation, and maintenance of cockpits and the holding of cockfighting as provided under existing laws;

WHEREAS, Mr. Francis Angelo A. Roa has formally requested the issuance of a Special Permit for the conduct of "Regular Cockfights" on March 2, 9, 16, 23, and 30, 2025 (Sundays) at the AIR53 Tolosa Amusement Center, Barangay Cantariwis, Municipality of Tolosa, Leyte;

WHEREAS, the request has been reviewed, and the Sangguniang Bayan finds it in accordance with the provisions of existing laws, rules, and regulations governing cockfighting operations;

WHEREAS, the issuance of the Special Permit is subject to compliance with all necessary regulatory requirements, including but not limited to the observance of public order, safety, and health protocols;

NOW, THEREFORE, on motion of Hon. Rolly A. Cinco, duly seconded unanimously, be it:

RESOLVED, as it is hereby **RESOLVED**, that the Sangguniang Bayan of Tolosa, Leyte, concurs in the issuance of a Special Permit for the conduct of "Regular Cockfights" as requested by Mr. Francis Angelo A. Section 1. Title

This ordinance shall be known as the "Climate Resilience Ordinance of Tolosa, Leyte."

- d. **Disaster Risk Reduction (DRR)** - The process of minimizing risks associated with natural hazards, including climate-related disasters, through prevention, preparedness, and mitigation measures.

Section 4. Establishment of the Municipal Climate Resilience Task Force (MCRTF)

The Municipality of Tolosa shall create a **Municipal Climate Resilience Task Force (MCRTF)** to oversee the implementation of climate resilience programs, which shall:

- a. Be composed of representatives from the Municipal Disaster Risk Reduction and Management Office (MDRRMO), the Municipal Planning and Development Office (MPDO), the Municipal Environment and Natural Resources Office (MENRO), the Department of Agriculture, and other relevant stakeholders;
- b. Develop a comprehensive **Climate Resilience Action Plan (CRAP)** that will outline specific measures to reduce climate risks, enhance adaptive capacities, and ensure sustainable development practices.

Section 5. Climate Resilience Action Plan (CRAP)

The MCRTF shall develop and implement a **Climate Resilience Action Plan (CRAP)** to guide the Municipality's long-term efforts to adapt to climate change and build resilience. The plan shall include:

- a. **Vulnerability and Risk Assessments** - Identifying vulnerable sectors, including agriculture, infrastructure, human health, and biodiversity;
- b. **Adaptation Strategies** - Developing specific, targeted actions for each sector to reduce risks from climate hazards such as flooding, drought, and extreme weather events;
- c. **Disaster Risk Reduction** - Incorporating climate change impacts into existing DRR strategies to prepare for and manage climate-related disasters;
- Sustainable Resource Management** - Implementing practices that conserve natural resources, reduce pollution, and protect ecosystems.

Section 6. Integration of Climate Resilience in Local Planning and Development

The Municipality shall:

- a. Ensure that climate resilience is mainstreamed into the Municipal Development Plan (MDP), Comprehensive Land Use Plan (CLUP), and other key policy and planning documents;
- b. Incorporate climate adaptation and mitigation measures in local infrastructure and urban planning projects, prioritizing flood control, resilient housing, and sustainable land use;
- c. Integrate climate risk assessments in all development projects to ensure they are designed to withstand the impacts of climate change.

Section 7. Climate-Resilient Infrastructure

The Municipality shall prioritize the development and maintenance of climate-resilient infrastructure by:

- a. Designing and constructing public buildings, roads, bridges, drainage systems, and other infrastructure with climate resilience in mind, using materials and technologies that can withstand extreme weather events;
- b. Upgrading existing infrastructure to meet climate resilience standards, particularly in areas prone to flooding, landslides, or extreme heat;
- c. Collaborating with experts to incorporate innovative solutions such as green infrastructure, flood management systems, and sustainable energy sources in public projects.

Section 8. Public Awareness and Education

The Municipality shall promote public awareness and education on climate change and resilience by:

- a. Launching public information campaigns to educate residents about climate change, its impacts, and the importance of building resilience;

- b. Preparing an annual report on climate resilience activities to be submitted to the Sangguniang Bayan and made available to the public;
- c. Conducting community consultations to gather feedback on the impacts of climate resilience programs.

Section 11. Repealing Clause

Any provision of existing ordinances, resolutions, or executive orders that are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

AN ORDINANCE ESTABLISHING A MUNICIPAL HOUSING AND URBAN DEVELOPMENT PROGRAM IN THE MUNICIPALITY OF TOLOSA, LEYTE, TO PROMOTE SUSTAINABLE URBANIZATION AND IMPROVE THE LIVING CONDITIONS OF LOCAL RESIDENTS

Section 1. Title

This ordinance shall be known as the "Municipal Housing and Urban Development Ordinance of Tolosa, Leyte."

Section 2. Objectives

This ordinance aims to:

- a. Provide adequate, affordable, and decent housing to the residents of Tolosa;
- b. Promote inclusive urban development that ensures the participation of local communities;
- b. Enhance the provision of basic services and infrastructure to improve the quality of life;
- c. Ensure that urban growth does not compromise the environment, public health, or social equity.

Section 3. Municipal Housing and Urban Development Committee (MHUDC)
A Municipal Housing and Urban Development Committee (MHUDC) is hereby created to guide the development and implementation of housing and urban policies and programs. The Committee shall be composed of the following members:

- a. The Mayor or his/her representative (Chairperson);
- b. The Chairperson of the Committee on Housing (Vice-Chairperson);
- c. Representatives from the Municipal Planning and Development Office, Municipal Engineering Office, and Municipal Social Welfare and Development Office;

- d. Representatives from local homeowners' associations, and relevant community-based organizations.

The MHUDC shall be responsible for:

- a. Developing and implementing a Municipal Housing and Urban Development Plan;
- b. Identifying areas for housing development, ensuring availability of space for residential, commercial, and recreational purposes;
- c. Proposing and managing programs for affordable housing projects in the municipality.

Section 4. Affordable Housing Program

The Municipality shall establish an **Affordable Housing Program** that will:

- a. Focus on providing decent and affordable housing for low-income families and vulnerable sectors, such as senior citizens and persons with disabilities;
- b. Facilitate partnerships with private developers, NGOs, and the national government to support the construction of housing units within the Municipality;
- c. Prioritize the relocation of families living in danger zones or unsafe areas to suitable and safe housing.

Section 5. Land Use and Zoning for Housing Development

The Municipality shall ensure that urbanization is carried out in an organized and sustainable manner by:

- a. Implementing the existing municipal land use and zoning plan that identifies areas for residential, commercial, and public utilities;
- b. Allocating land for socialized housing projects that cater to the needs of low-income families;
- c. Reviewing zoning laws to accommodate the changing needs of the population and promote mixed-use developments.

Section 6. Infrastructure and Basic Services

To ensure the sustainability and livability of housing projects, the Municipality shall:

- a. Prioritize the improvement of roads, access to water, electricity, and sanitation services in new housing areas;
- b. Ensure that all new housing developments are accessible to essential services such as healthcare, education, transportation, and recreation;
- c. Coordinate with utility providers to ensure efficient and reliable provision of basic services to housing communities.

Section 7. Public Participation and Transparency

The Municipality shall encourage public participation in the planning, development, and monitoring of housing projects by:

- a. Conducting consultations with affected communities to gather feedback on housing development plans;
- b. Ensuring transparency in the allocation and use of funds for housing projects by making the information accessible to the public;
- c. Promoting the involvement of local organizations and stakeholders in the planning and implementation phases.

Section 8. Sustainable and Green Housing Practices

The Municipality shall promote environmentally sustainable housing practices by:

- a. Encouraging the use of energy-efficient building materials and technologies in all housing developments;
- b. Implementing waste management systems and rainwater harvesting solutions in new housing areas;
- c. Incorporating green spaces and community parks in residential developments to improve residents' quality of life and promote environmental conservation.

Section 9. Monitoring and Evaluation

The **MHUDC** shall monitor the implementation of the housing and urban development plan, ensuring that programs are effectively executed. This includes:

- a. Reviewing progress and ensuring that housing projects are aligned with municipal goals for urban development;
- b. Collecting data on housing needs and continuously evaluating the effectiveness of housing programs and services;
- c. Preparing an annual report on housing and urban development, which will be made available to the public for review.

Section 10. Budget and Resource Allocation

The Municipality shall allocate funds in the Annual Budget to support the housing and urban development program. The MHUDC will manage these funds to ensure that they are effectively used for the construction, development, and improvement of housing projects and related infrastructure.

Section 11. Repealing Clause

Any provision of existing ordinances, resolutions, and executive orders that are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 12. Effectivity

This ordinance shall take effect immediately upon its approval.

6. An Ordinance in Anticipation of the Various Activities with the Upcoming 158th Tolosa Day Celebration, to wit:
