

AN ORDINANCE ESTABLISHING THE KASALAN NG BAYAN PROGRAM IN THE MUNICIPALITY OF BABATNGON, LEYTE AND PROVIDING FUNDS THEREOF.

Be it enacted by the Sangguniang Bayan of the Municipality of Babatngon, Leyte in session assembled:

SECTION 1 - Short Title. This ordinance shall be known as the "KASALAN NG BAYAN PROGRAM ORDINANCE" in the Municipality of Babatngon, Leyte.

SECTION 2 - Statement of Policy. It is the policy of the Municipality of Babatngon to promote and strengthen family values and relationships by providing a platform for couples to formalize their union through marriage. The **Kasalan ng Bayan Program** aims to encourage couples to legalize their relationships and uphold the sanctity of marriage.

SECTION 3 - <u>Definition of Terms</u>.

- 1. **Couple** refers to man and woman who are living together for at least 5 years and above without legal impediment to marry each other.
- 2. **Application** the formal request of the qualified couple in availing the **Kasalan ng Bayan Program** at the Municipal Civil Registrar Office (MCRO).
- Program the Kasalan ng Bayan under the "USWAG BABATNGON PROGRAM" established by the Local Government Unit of Babatngon, Leyte.
- 4. Kasalan ng Bayan a mass wedding ceremony organized by the LGU for couples who wish to get married.
- 5. MCRO Municipal Civil Registrar Office, the government office responsible for registering vital events such as births, marriages, and deaths.
- LGU Local Government Unit, the governing body of the Municipality of Babatngon.
- **SECTION 4 <u>Administrative Provisions</u>**. The **Kasalan ng Bayan Program** shall be administered by the LGU once a year or in between the month of April or May through the MCR office.
- **SECTION 5 Waiver of Fees.** All fees related to the marriage application process, including marriage license fees, shall be waived for couples participating in the **Kasalan ng Bayan Program.**
- **SECTION 6 Requirements.** Couples who wish to participate in the **Kasalan ng Bayan Program** must meet the following requirements: **Both parties must be of legal age, must be living together as husband and wife for at least 5 years and above without legal impediment to marry each other, must be a resident of Babatngon**, Leyte.
- **SECTION 7** <u>Application Period/Procedure</u>. The application period for the **Kasalan ng Bayan Program** shall be announced by the LGU *at least three months before the scheduled mass wedding ceremony*. Couples must personally submit their application documents to the MCR office during the application period. The MCR office will verify the authenticity of the submitted documents, process, prepare the certificate of marriage and schedule the couple for the mass wedding ceremony.

SECTION 8 - Requirements for Application. Couples must submit the following documents to the MCR office to apply for the **Kasalan ng Bayan Program: -** *Birth certificates (local copies or PSA) of both parties - Valid IDs ,* Certificate of No Marriage record (CENOMAR) from the Philippine Statistics Authority and Tree Planting activities.

SECTION 9 - Source of Fund. The funds to be used for the implementation of the **Kasalan ng Bayan Program** shall be charged under the Gender and Development Program with an initial amount of PhP 500,000.00.

SECTION 10 - <u>Separability Clause</u>. If any provision of this ordinance is declared invalid or unconstitutional, the other provisions shall remain in full force and effect.

SECTION 11 - <u>Repealing Clause</u>. All ordinances, rules, regulations, or parts thereof that are inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 12 - Effectivity. This ordinance shall take effect immediately upon approval.
