

ORDINANCE NO. 494

ORDINANCE ESTABLISHING THE PUBLIC EMPLOYMENT SERVICE (PESO) IN THE MUNICIPALITY OF BABATNGON, PROVIDING 115 AN FUNCTIONS AND PROVIDING FUNDS THEREOF.

Be it enacted by the Sangguniang Bayan of the Municipality of Babatngon, Leyte in session assembled:

SECTION 1 - Short Title. This ordinance shall be known as the "BABATNGON, LEYTE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) Ordinance".

**SECTION 2 – Declaration of Policy.** It is a declared policy that the State shall promote full employment and equality of employment opportunities for all.

SECTION 3 – Creation and Establishment of the Public Employment Service Office (PESO). The Public Employment Service Office (PESO) is hereby created and shall be under the Office of the Mayor with Office Code

SECTION 4 - Objectives of the Public Employment Service Office (PESO). The PESO shall ensure the prompt, timely, and efficient availability of information regarding employment opportunities and provision of information on the other government programs related thereto.

Specifically, the PESO shall:

- Provide a venue where people could explore simultaneously various employment options and seek assistance they prefer to be employed.
- b. Serve as referral and information center for the various related services of other government agencies present in the area.
- Provide clients with adequate information on employment and labor market situation in the area.
- Network with the same office with other local government unit and non-government offices on employment for job exchange purposes.

**SECTION 5 -** Functions of the PESO. That the Public Employment Service Office of Babatngon or herein referred to as PESO shall have the following functions:

- a. Encourage employers to submit to the PESO on a regular basis a list of job vacancies in their respective establishment to facilitate the exchange of labor market information between job seekers and employers by providing employment and recruitment assistance to employers.
- b. Develop and administer testing and evaluation instrument for effective job selection/training and counseling.
- c. Provide persons with entrepreneurship qualities access to the various livelihood and self-employment programs offered by both government and non-government organizations.
- d. Undertake employability enhancement training/seminar for job seekers, as well as those who would like to change career or enhance their employability.
- Provide employment or occupational counseling, career guidance, mass motivation and values development activities.

- Conduct pre-employment counseling and orientation to prospective local and most especially, overseas workers.
- Provide reintegration assistance services to returning Filipino migrant workers; and
- Perform such other functions as will fully carry out the objective of this Ordinance.

SECTION 6 - Other Services of the PESO. In additions to the function enumerated in the preceding section, the PESO shall also undertake the following programs and activities.

- Job fair These shall be conducted periodically within the Municipality to bring together in one venue the job seekers and employers for immediate matching.
- Livelihood and Self-Employment Bazaar These will give clients pieces of information on the wide array of livelihood programs they chose to avail of.
- Special Credit Assistance for Placed Oversees Workers This type of assistance will enable poor but qualified applicants to avail of opportunities for oversees employment.
- Special Program for Employment of Students and Out-of-School Youth This program shall endeavor to provide employment to deserving students and out-of-school coming from poor families during summer and Christmas vacation as provided for under Republic Act No. 7323 and its implementing rules to enable them to pursue their
- Workers Appreciation Program This program aims to develop the values of work appreciation and ethics by exposing the young to actual work situations.
- Workers hiring for Infrastructure Projects (WHIP) This program is in pursuance of Republic Act No. 6685 which requires construction companies including the Department of Public Works and Highways and Contractor for Government - funded infrastructure projects, to hire thirty percent (30%) of skilled and fifty percent (50%) of unskilled labor requirements from the areas where the project is constructed/located; and
- Undertake, implement or assist other programs/activities developed by (DOLE) to enhance provisions of employment assistance to PESO clients particularly for special groups of disadvantaged workers such as persons with disabilities (PWDs) and displaced worker.

SECTION 7 - Repealing Clause. All ordinances, resolutions and executive orders or any part thereof which are not inconsistent herewith are hereby deemed repealed or modified accordingly.

SECTION 8 - Separability Clause. Should any section of this Ordinance or any part thereof or the application of such section or portion be declared null and void, said declaration shall not affect the validity of the other sections of this Ordinance.

SECTION 9 - Effectivity. This Ordinance shall take effect fifteen (15) days after posting in three (3 conspicuous places.


